

## ALCOHOL BEVERAGE LICENSE CONTROL COMMITTEE

- 1. The meeting was called to order at 4:00 p.m. by Committee Chairman Tinder with a quorum present.
- 2. Consideration of a new Class "B" Beer and "Class B" Liquor License for Tilley's Pizza House, Inc., d/b/a Club Ballyhoo, 900 Fourth Street. Agent Teresa Donovan appeared.

Captain Sciame stated he checked municipal and state criminal records and to the best of his knowledge with the available information, the character record and reputation of the Agent are satisfactory and the Police Department has no objection to this license.

Attorney Krueger explained that Tilley's Pizza House, Inc. is a new corporation taking over for the old corporation of Tilley Corporation. Attorney Krueger asked Agent Teresa Donovan if she understands she is responsible for any violations that occur on the premise whether she is present or not and Ms. Donovan responded that she did.

Marsden moved to recommend approval of the new license of Tilley's Pizza House, Inc., second by Metter. Motion carried with Tilley abstaining.

3. Consideration of a transfer of the retail Class "B" Beer and "Class B" Liquor of the license of Tilley's Pizza House, Inc., d/b/a Club Ballyhoo, Teresa Donovan, Agent, from 904 Fourth Street to 900 Fourth Street. Agent Teresa Donovan appeared.

Captain Sciame stated the Police Department had no objection to the transfer of the license for Club Ballyhoo to 900 Fourth Street.

Vickerman moved to recommend approval of the license transfer, second by Metter. Motion carried with Tilley abstaining.

4. Consideration of a new "Class B" Beer and "Class B" Liquor License for Draeving Companies, LLC, d/b/a Thirsty Badger Bar & Grill, 2683 Prairie Avenue. Agent Michael J. Draeving, Sr., appeared.

Captain Sciame stated he checked municipal and state criminal records and to the best of his knowledge with the available information, the character record and reputation of the Agent are satisfactory and the Police Department has no objection to this license application.

Mr. Draeving responded that he understood.

Berkley moved to recommend approval of the license for Draeving Companies, LLC, second by Metter. Motion Carried.

5. Consideration of a Change of Agent for The Bloomin' Apple Beloit, LLC, d/b/a Applebee's Neighborhood Grill & Bar, 2680 Cranston Road. Proposed new Agent Joshua Siebel appeared.

Captain Sciame stated he checked municipal and state criminal records and to the best of his knowledge with the available information, the character record and reputation of the Agent are satisfactory and the Police Department has no objection to this appointment

Attorney Krueger asked Mr. Siebel to confirm that he understands that he will be held accountable for any violations that occur at Applebee's whether he is there or not and Mr. Siebel stated he understood.

Berkley moved to recommend approval of the Change of Agent at Applebee's Neighborhood Bar & Grill to Joshua Siebel, second by Metter. Motion carried
