**WHEREAS**, due to the vision and dedication of the teaching staff and principal at Gaston School, student achievement on state assessments have improved over the past five years and are now above the 60<sup>th</sup> percentile in reading and mathematics; and

**WHEREAS**, at a conference and awards ceremony in Washington, DC, Gaston School received a plaque and flag to signify their status as a National Blue Ribbon School;

**NOW, THEREFORE, BE IT PROCLAIMED THAT** the City of Beloit is proud to honor the students of Gaston Elementary School for their outstanding educational achievements, and salutes the teaching and administrative staff for their guidance and support.

1. The meeting was called to order at 7:08 p.m. in the Forum at Beloit City Hall

2. PLEDGE OF ALLEGIANCE

## 3. SPECIAL ORDERS OF THE DAY/ANNOUNCEMENTS

- a. Vice President Van De Bogart presented a Proclamation recognizing Officer Ryan Flanagan, Captain Dan Risse, and the Beloit Police Department for receiving the Cities and Villages Mutual Insurance Company (CVMIC) Significant Program Award for the Force Multiplier Program. Officer Flanagan accepted the Proclamation, thanked the Council, and said that he was proud to represent the Department. File 7148
- b. Vice President Van De Bogart presented a Proclamation in Commemoration of the **70**<sup>th</sup> **Anniversary of the Civil Air Patrol** and declared December 1, 2011 as Civil Air Patrol Day.

#### 4. PUBLIC HEARINGS

- a. Community Development Director Julie Christensen presented a proposed Ordinance to amend the **Zoning District Map** to change the Zoning District Classification from PUD, Planned Unit Development District, to R-1A, Single-family Residential District, for the properties located at 1907 and 2000 Aspen Drive and 1907, 2000, and 2001 Dell Drive. It was noted that the Plan Commission recommended approval 5-0. President Leavy opened and closed the public hearing without participation. Councilor Haynes moved to suspend the rules for a second reading of this Ordinance, and Councilor Luebke seconded. The motion carried 6-0. On the merits, Councilor Spreitzer moved to enact the Ordinance, and Councilor Haynes seconded. The motion carried 6-0. File 8517 Ordinance 3454
- b. Ms. Christensen presented a Resolution authorizing a Conditional Use Permit to allow an Outdoor Seating area and Outdoor Sales, Possession, and Consumption of Alcohol in a C-3, Community Commercial District, for the property located at 65 Portland Avenue. It was noted that the Plan Commission recommended approval 5-0. Ms. Christensen explained that Kline's Club 88 had applied for this conditional use permit and that a variance is needed in order for the applicant to obtain a permit for the 8-foot tall privacy fence proposed. Ms. Christensen reviewed the conditions of approval recommended by Planning staff and the Plan Commission. President Leavy opened and closed the public hearing without participation. Councilor De Forest moved to adopt the resolution, and Councilor Luebke seconded. After discussion regarding the proximity of the outdoor seating area to the bike path and sidewalk and the variance required for the privacy fence, Councilor Spreitzer moved to lay the item over until the Board of Appeals decides the merits of the necessary variance. Councilor De Forest seconded. The motion passed and the item was laid over until the Board of Appeals acts. Ms. Christensen noted that the Board of Appeals application has not been filed yet and that it is likely that the Council will not see this application again until the second meeting in January 2012. ## 5. CITIZENS' PARTICIPATION

• Debbie Fischer, 1477 Fisher Road, property owner of 1338 McKinley Avenue, spoke in support of banning concealed weapons City facilities.

- Robert Bellard, 842 Bluff Street, spoke in opposition of the proposed Ordinance to ban the concealed weapons in City facilities.
- Mike Zoril, 1756 Carlyle Road, spoke in opposition to the Ordinance prohibiting dangerous weapons in City facilities. He provided a hand-out outlining his opinions and suggestions to improve the Ordinance.
- Paul Limbrich, 102 N River Street, Apt. 301, Janesville, spoke in opposition to the proposed Ordinance banning dangerous weapons in City facilities. He said that more guns equate to less danger to the public.
- Jack Leader, 1705 Randolph Road, Janesville, spoke regarding his opposition to the proposed Ordinance to ban dangerous weapons in City facilities.
- Randall Fiore, 2544 Edgewood Drive, Vice Chair of the Board of Appeals, expressed concern
  with the possibility of concealed weapons being carried at contentious Board of Appeals
  meetings. He stated that allowing concealed weapons to be carried in City facilities presents a
  danger that does not need to be there.
- Chuck Kuecker, 2511 W. Creedy Road, Town of Beloit, said that it is not a good idea to ban guns
  unless there are metal detectors and people to enforce the law. He stated that the proposed
  Ordinance would not do anything to make people safer.
- Georgia Janisch, 1514 Dayton Drive, Janesville, spoke against the proposed Ordinance banning concealed weapons in City facilities.
- Kim Mork, 1822 Sun Valley Drive, spoke against the proposed Ordinance banning weapons in City facilities.
- Bill Mitchell, 4105 Skyview Drive, Janesville, spoke against the proposed Ordinance banning dangerous weapons in City facilities.
- Brian Jones, 612 Meadow Crest Drive, Rockton, IL, expressed concern about the trend toward the abolition of gun use for personal protection.
- James Pardee, Janesville, spoke against the proposed Ordinance and said that it would wise for teachers and public employees in charge of critical infrastructure to carry concealed weapons.

## 6. CONSENT AGENDA

Councilor Luebke moved to adopt the Consent Agenda, which consists of items 6.a. through 6.c., and Councilor Van De Bogart seconded. The motion carried that all items on the Consent Agenda be accepted, approved, adopted, or referred and acted upon as required by state and local codes by a vote of 6-0.

- a. **Minutes** of the Regular Meeting of November 7, 2011 were approved.
- b. The Resolution approving an Amendment to the Class "B" Beer and "Class B" Liquor License for PRD Saloon of Beloit, Inc., d/b/a Patti's Road Dawg Pub, to include the Rodeway Inn Hotel premises was adopted. File 8497
- c. The application for a **Class "B" Beer License** for Summer's Banquet Hall LLC, d/b/a Summer's Banquet Hall, 1304 Cranston Road, Virginia L. Cabrera, Agent was referred to the Alcohol Beverage License Control Committee. File 8497

#### 7. ORDINANCES

a. City Attorney Tom Casper presented a proposed Ordinance to repeal and recreate Section 15.07(1), to create Section 15.07 (1g), and to amend Sections 15.01 and 15.30 of the Code of General Ordinance of the City of Beloit pertaining to **Dangerous Weapons in City Buildings.** A second reading of the Ordinance was given. Councilor De Forest moved to enact the Ordinance, and Councilor Luebke seconded. After discussion, Councilor De Forest moved to amend Section 1 of the Ordinance by removing the word "locations" from two places in the "Dangerous Weapons Restricted" paragraph and including "park bathroom facilities" as exempt from the concealed carry prohibition. Councilor Haynes seconded this amendment, and it carried 6-0. Councilor Spreitzer moved to amend Section 2 of the Ordinance by removing the last clause in the definition of "Dangerous weapon." Councilor De Forest seconded this amendment, and it carried 6-0. Councilor Spreitzer moved to amend Section 4 of the Ordinance to reduce the fine for a first offense for carrying a concealed weapon in a City facility from \$300 to \$200. Councilor De Forest seconded this amendment, and it carried 4-2 with Councilors Van De Bogart and Leavy voting in

opposition. On the merits, the Council voted 4-2 to enact the Ordinance with Councilors Van De Bogart and Haynes voting in opposition. File 6255 Ordinance 3455

## Overview/Background Information:

Miguel Servin, the operator of Miguel's Tires and Rims, has filed an application for a Conditional Use Permit to allow a limited vehicle service use in a C-2, Neighborhood Commercial District, for the property located at 2056 Liberty Avenue. The applicant has proposed to sell new and used tires and rims, and provide limited services to vehicles at 2056 Liberty Avenue. Limited vehicle service uses provide direct services to motor vehicles where the driver or passengers generally wait in the car or nearby while the service is performed.

## Key Issues (maximum of 5):

- Limited Vehicle Service uses are a conditional use within the C-2, Neighborhood Commercial District, and require
  a recommendation by the Planning Commission, and approval, approval with conditions, or denial by City
  Council.
- The property at 2056 Liberty Avenue was built in 1958 and includes retail space, a single-family residence, and an attached residential garage.
- The applicant has proposed to use the attached residential garage to provide limited services to vehicles, and the retail space to display tires and rims, as well as, store waste tires.
- The property at 2056 Liberty Avenue fronts State Highway 81 and abuts single-family residential districts to the North and West, a two-family district to the South, and Neighborhood Commercial District to the East.



## Overview/Background Information:

R.H. Batterman & Co., Inc. has submitted an Application for the Review of a Minor Subdivision and a 2-Lot Certified Survey Map (CSM) for the properties located at 2357 & 2426 Field Crest Road.

## Key Issues (maximum of 5):

- The intent of the proposed CSM is to separate a 1.474-acre parcel for the existing single-family home in the northeast corner of the property located at 2357 Field Crest Road from the remainder of this primarily agricultural parcel. However, since the property located at 2357 Field Crest Road does not have any right-of-way frontage, the proposed CSM also involves the dedication of land to the public to create some frontage.
- As shown on the attachments, the proposed CSM extends the Field Crest Road right-of-way by 70 feet. This dedication creates 70 feet of right-of-way frontage for proposed Lot 2 and 92.46 feet of frontage for proposed Lot 1, which is 28.02 acres (the remainder of the parcel). A small triangular portion of the proposed dedication involves the property to the north (2426 Field Crest Road), which will retain 31.57 feet of frontage following this dedication.
- The land to be dedicated to the public will not be improved as a public street until additional development occurs.
- Since there is an existing driveway leading from the existing end of Field Crest Road to the house, the proposed CSM includes an ingress/egress easement over a portion of proposed Lot 1 to benefit proposed Lot 2.
- The proposed CSM must be reviewed by the City Council because of the dedication of public right-of-way.





## Overview/Background Information:

The Rock County 911 Center was established in 1992. After nearly a decade of operation, Rock County assumed the responsibility for maintaining and upgrading the radio system infrastructure for most Rock County Law Enforcement agencies and all Rock County Fire Agencies, including the City of Beloit Fire Department. The only two departments that were not included in the countywide system of maintenance and infrastructure management were the Janesville PD and the Beloit PD.

Since the Federal requirements were established to update our communication systems by 12/31/2012, the city has been working with the Rock County Communications Center staff to implement these changes for the past several years. A communication plan was developed for the changeover and upgrade of our respective systems. One component of this process was to have Rock County be responsible for the management of all public safety radio system infrastructure related to Police and Fire services in Rock County.

Consistent with the required upgrades in 2012, these two agencies requested that the county take over the responsibility for maintaining their systems as they have been fully integrated into the county communications system for many years. After several months of negotiations and evaluations of the current systems, Rock County has agreed to take over the maintenance for the Beloit Police Communication system, upon the completion of scheduled upgrades in 2012. This will positively impact the department and will decrease operating expenses starting in 2013 for maintenance of identified infrastructure of approximately \$20,000.00 per year. Rock County also committed over \$200,000.00 for actual upgrades to existing equipment in 2011 and 2012. This allowed us to reduce our 2012 CIP for this project from \$950,000.00 to \$750,000.00. We are still responsible for upgrades related to some system enhancements prior to the turnover and for all of our mobile and portable operations necessary for implementation.

## Key Issues (maximum of 5):

- This agreement outlines the parameters of the service agreement that will supplied by Rock County.
- This agreement helps the city maintain their radio interoperability requirements.
- This action resulted in a reduction in anticipated CIP expenditures in 2012 by over \$200,000.00.
- This action will result in a reduction of maintenance and infrastructure costs, related to PD communications, of approximately \$20,000.00, effective in 2013.
- This is a net benefit to the department, the city, and the community.

Conformance to Strategic Plan (List key goals this action would support and briefly discuss its impact on the City's mission.): This resolution is part of a strategic plan to remove maintenance costs from the operating budget whenever possible. This is a negotiated strategy that will allow us to maintain a high level of communications in the public safety environment, while diminishing some of the operating expenses.

# COOPERATIVE AGREEMENT BETWEEN CITY OF JANESVILLE, CITY OF BELOIT AND COUNTY OF ROCK

# REGARDING THE ANALOG TO DIGITAL CONVERSION OF PUBLIC SAFETY RADIO EQUIPMENT

This agreement entered into this, day of, 2011, by and between the
COUNTY OF ROCK, hereinafter referred to as the "County," and the CITY OF JANESVILLE
and the CITY OF BELOIT, hereinafter referred to as "Cities," pursuant to section 66.0301, Wis
Stats.

## WITNESSETH

WHEREAS, the parties to this Agreement are committed to delivery of the highest possible level of fire, law enforcement, medical emergency and related services; and

WHEREAS, the parties to this Agreement believe that interoperability, the ability for public safety agencies and communications centers to seamlessly communicate with each other, is a critical component of state-of-the-art public safety radio communications; and

WHEREAS, the parties to this Agreement are committed to participating in the use and support of such state-of-the-art public safety radio communications, that:

- Provide for efficient and effective support of the delivery of public safety services to people who need help;
- Provide the greatest support possible for firefighters, EMS, law enforcement officers and others for whom reliable, interoperable communications can mean the difference between life and death;

WHEREAS, attached as Exhibits A and B, are the technical radio components which the County shall acquire from the Cities to develop a state-of-the-art interoperable public safety radio communication system based on an analog/digital radio system that is capable of being

expanded in a manner consistent with current and future public safety communications technical standards.

## ARTICLE I – PURPOSE

1.01 The purpose of this Agreement is to define the rights and obligations of the County and the Cities with respect to the coordinated operation, maintenance, and upgrades of the county-wide analog/digital radio system.

## ARTICLE II – COOPERATION

2.01 The County and Cities will cooperate and use their best efforts to ensure that the various provisions of this Agreement are fulfilled. The parties agree in good faith to undertake resolutions of all disputes, if any, in an equitable and timely manner in accordance with the provisions of this Agreement.

## ARTICLE III – TERM

- 3.01 This Agreement shall take effect upon execution by all parties hereto, and shall remain in effect for a period of ten (10) years, starting upon the day upon which the governing bodies of the County and Cities have executed this Agreement.
- 3.02 If no action is taken to dissolve this Agreement and the County and the Cities fail to extend the Agreement after ten (10) years, the Agreement shall automatically be renewed for additional twelve (12) month period(s) under the same terms.

## ARTICLE IV – DEFAULT

4.01 Any material violation of the Agreement during the term of this Agreement shall constitute a default. In the event of an alleged default, the appropriate parties shall give the alleged defaulting party notice of such alleged default. Upon notice, the party alleged

- to have defaulted shall have a period of 30 calendar days to cure the alleged default. Failure to cure the default may result in the termination of the agreement.
- 4.02 Either the County or the Cities may terminate this agreement upon 180 days written notice to the other parties.

## ARTICLE V – CONFORMANCE TO PLANS, ETC.

- 5.02 The County equipment operating on the analog/digital radio system shall comply with technical and performance best practices.
- 5.03 The County and Cities agree maintenance proposals for the analog/digital radio system will be updated on 5 year intervals and that a vendor recommendation to the County will be made by the 911 Commission. The County will attempt to have one vendor maintain all infrastructure.
- 5.04 All improvements of existing facilities, additional infrastructure or new tower sites must be approved by the County and the 911 Commission.

## ARTICLE VI – OWNERSHIP OF INFRASTRUCTURE

- 6.01 The County shall own all infrastructure associated with the analog/digital radio system unless otherwise stated within this Agreement. Infrastructure may include all Janesville and Beloit radio equipment as well as all related receivers, voters, antennas and microwave units. See Exhibits A and B for current list of equipment.
- 6.02 Radio equipment buildings owned by the respective municipalities will remain that municipalities' responsibility for maintenance and upkeep.
- 6.03 Exhibits C and D are a list of all of the Cities' tower sites as of November 1, 2011, the radio equipment at these sites are hereby transferred to the County.

- 6.04 County shall be responsible for all analog/digital upgrades and maintenance of existing public safety and voice communication systems.
- 6.05 Cities agree that their existing public safety radio sites will be up to acceptable standards before turn over to the County occurs. The County will be the final judge of acceptable standards.
- 6.06 The parties agree that any County approved public radio system maintenance vendor will be allowed access to the respective municipalities radio equipment buildings at any time.

## ARTICLE VII - SYSTEM FUNDING

7.01 The County shall be responsible for the initial analog/digital mode radio infrastructure purchase and installation and for subsequent infrastructure public safety radio maintenance and improvements purchases. See Exhibits E through H.

## ARTICLE VIII - FCC LICENSE AND USE OF FREQUENCIES

- 8.01 The Cities will transfer their public safety radio licenses to the County.
- 8.02 The County shall be responsible for the maintenance of all FCC licenses required to operate the analog/digital radio system.
- 8.03 All County and Cities radios used for law enforcement shall be capable of full operation on the County provided public safety radio system.
- 8.04 All County and Cities shall operate two-way radio equipment in accordance with the rules of the FCC.

## ARTICLE IX – RADIO SYSTEM USES AND LIMITATIONS

9.01 Permitted users of the radio system will include the County and Cities public safety and may also include non-public safety users.

- 9.02 To ensure that the channel capacity of the radio system will not be unnecessarily reduced, neither the County nor the Cities shall utilize any radio with a telephone interconnect capability except as approved by the County.
- 9.03 Parties agree to work out acceptable co-location agreements with third parties. County has final say on co-location agreements.
- 9.04 The County agrees to provide and maintain site generators or uninterruptible power supplies (UPS) and other utilities for all tower sites that contain more than 50% emergency radio infrastructure equipment. For facilities 50% or less-devoted to emergency radio, the cost for generators or UPS or other utilities will be paid for by the respective cities.
- 9.05 Cities agree that the County will have the right of inspection and acceptance before turning over cities' radio equipment to the County.
- 9.06 This agreement does not include the cities mobile and portable radios. All public safety mobile and portable radios remain the individual municipalities responsibility.

## ARTICLE X - NOTICE

10.01 Any notice, report of demand which must be given or made by a party hereto under the terms of this Agreement shall be sent by registered or certified mail, return receipt requested. Notice to the County shall be sent to 911 Communication Director, 911 Communications Center, 3636 N. Cty. Hwy. F, Janesville, Wisconsin 53545. Notice to the City of Janesville shall be sent to: Chief of Police, City of Janesville, 100 North Jackson Street, Janesville, WI 53547-5005. Notice to the City of Beloit shall be sent to: Chief of Police, City of Beloit, 100 State St., Beloit, WI 53511.

## ARTICLE XI – MERGER AND MODIFICATION

- 11.01 It is understood and agreed that the entire Agreement between the parties is contained herein and that this Agreement supercedes all oral agreements, previous written agreements and negotiations between the County and the Cities.
- 11.02 Any alterations, variations, modifications, or waivers of the provisions of this Agreement shall only be valid when they have been reduced to writing and signed by parties hereto as an amendment to this Agreement.

## ARTICLE XII – RECORDS

- 12.01 County and the Cities agree to maintain all records relative to this agreement and the use of the system during the period in which that system is used by the County and the Cities and further for any additional period of time as prescribed by law.
  - ARTICLE XIII INDEPENDENT CONTRACTOR AND INDEMNIFICATION
- 13.01 The County and Cities are, and shall remain, independent contractors with respect to all services performed under this Agreement. Except as provided within this Agreement, the County and Cities shall select the means, method, and manner of performing their respective services herein. Nothing is intended or should be construed in any manner as creating or establishing the relationship of co-partners between the County and Cities hereto or as constituting either party as the agent, representative, or employee of the other for any purpose or in any manner whatsoever. The Cities represent that they have or they will secure at their own expense all personnel required in performing services under this Agreement. Any and all personnel of the Cities or other persons engaged in the performance of any work or services under this Agreement shall have no contractual relationship with the other party, and shall not be considered an employee of any other

party. Each party hereto agrees to defend, indemnify and hold the other parties, its officers, agents and employees harmless from any and all claims, including reasonable attorney's fees, arising out of any acts or omissions of that idemnifying party related to the performance of this agreement.

13.02 Each of the parties shall maintain their own insurance to cover all their equipment, buildings or other items deemed necessary.

## ARCTICLE XIV - GOVERNING LAW

14.01 The laws of the State of Wisconsin shall govern all questions and interpretations concerning the validity and construction of this Agreement and the legal relations and performance and obligations between the County and Cities.





## Overview/Background Information:

The City of Beloit Fire Department provides paramedic level emergency medical services to the citizens and visitors of the Greater Beloit Area. The City of Beloit Fire Department contracts with a third party company to bill for Emergency Medical Services. The current contract with Specialty Billing Services will terminate at the request of the vendor on December 31, 2011. Specialty Billing Services is changing their business model and expanding in a different area; they are providing services to Janesville St. Mary's Hospital. A Request for Proposal (RFP) was done for this service and a committee selected Andres Medical Billing, Ltd. from two other RFP's received. Andres Medical Billing was the lowest bidder.

## Key Issues (maximum of 5):

- 1. Specialty Billing Services terminated our current contract for EMS billing effective December 31, 2011. The City does not have the training, capacity, or software to conduct this service internally.
- 2. A third party company for this service is necessary in order to maximize ambulance billing revenue, and to ensure compliance with medical records management, patient privacy, bill coding and Medicare/Medicaid Compliance.
- 3. Andres Medical Billing, Ltd. Is qualified to perform this service for the City of Beloit Fire Department.
- 4. Specialty Billing Service will continue to manage and collect for all accounts to be billed out through the December 31, 2011 service period. This will cause a service overlap for a period of several months.

Andres Medical Billing's fee is 5% of revenue collected. The amount collected in 2010 was \$958,549.99; 5% of this would have been \$47,927.00, an increase of only \$3,452.00.

## Overview/Background Information:

The City of Beloit Fire Department provides paramedic level emergency medical services to the citizens of Beloit and to those who pass through the City of Beloit and surrounding areas. The City of Beloit Fire Department contracts with a third party company to perform all billings for EMS. After the standard collection process is done by the billing company the accounts are transferred to a collection agency. State Collection Service, Inc., has a State of Wisconsin contract.

- 1. In order to maximize ambulance billing revenue delinquent accounts need to be transferred to a collection agency.
- 2. A third party company for this service is necessary in order to maximize ambulance billing revenue.

## Overview/Background Information:

The City's Administrative Policy for Doubtful Accounts and Accounts Written-off requires the City Comptroller (Finance, and Administrative Services Director) to annually present to the City Council any accounts \$5,000 or more that are considered doubtful accounts and should be written off as uncollectible. The Director of Housing Services and City Treasurer have recommended that several loans made as part of the Housing Rehab Loan Program and various billings for city services and taxes be considered for write-off since the properties have been foreclosed and sold at a Sheriff's sale or are considered no longer collectable. All reasonable efforts to collect these delinquent accounts have been exhausted and in accordance with the City's policy the accounts are considered to be doubtful accounts and should be written-off as uncollectible. All of these accounts are currently listed with the city's collection agency for additional follow-up.
