#### **COUNCIL CANDIDATE ORIENTATION**

The Council candidate orientation originally scheduled for Wednesday, January 25, had to be rescheduled for Tuesday, February 7, 2012 at 5:30 p.m. in the City Manager's Conference Room on the fourth floor of City Hall. Unfortunately, several candidates could not attend the original session and we would like as many candidates as possible to have access to the same information.

#### **REMINDER: SPRING PRIMARY ELECTION ON FEBRUARY 21, 2012**

On February 21, 2012 there will be a Spring Primary Election in the City of Beloit. The only contest on the ballot is a primary for the Rock County Circuit Court Judge Branch 7. Voters are reminded that Wisconsin's new Voter ID requires that voters show an acceptable form of identification at the polling place as well as sign the poll book starting with the February Election. Further, Beloit's ward numbers and boundaries and polling locations have changed due to redistricting. # CITY COUNCIL MEETING - MONDAY, FEBRUARY 6, 2012

At 5:30 p.m. on Monday, February 6, 2012, the City Council will hold a <u>Special Meeting</u> in the 4th Floor City Manager's Conference Room and adjourn into closed session to update and discuss strategies related to **Collective Bargaining**.

At 6:30 p.m. the City Council will have an Agenda Review session in the 4th Floor City Manager's Conference Room.

The attached agenda is for the Monday, February 6, 2012 regular City Council meeting beginning at 7:00 p.m. in the Forum.

#### 3. SPECIAL ORDER OF THE DAY/ANNOUNCEMENTS

- a. Proclamation recognizing the **Beloit International Film Festival**, February 16-19, 2012. The Beloit International Film Festival (BIFF) will be celebrating its seventh season this year. A representative of BIFF will be present to accept the proclamation.
- b. The Council President provides a **State of the City Address** annually. A draft of President Leavy's report will be posted on the City's website on Tuesday, February 7, 2012.

#### 6. CONSENT AGENDA

- a. Approval of the minutes of the Regular meeting of January 17 and the Special meeting of January 24, 2012.
- b. Application for a **Zoning Map Amendment** to change the zoning district classification from DH, Development Holding District, to R-1A, Single-family Residential District, for the property located at 2357 Field Crest Road. The "DH" district is a special purpose district that is intended for areas that are not yet suitable for urban or suburban intensity development. Because the subject property has been divided from the agricultural parcel and includes an existing single-family home, the DH zoning district classification is no longer appropriate. This matter will be referred to Plan Commission for their review and comment.
- c. Application for a **Zoning Map Amendment** to change the zoning district classification from PUD, Planned Unit Development District, to R-1A, Single-family Residential District, for the properties located at 731 and 737 Crist Road and 732 and 738 Newark Road. Reverting this parcel to R-1A makes it consistent with our Master Plan. This matter will be referred to Plan Commission for their review and comment.
- d. Resolution approving a one-lot Certified Survey Map for the properties located at 1800 Gateway Boulevard and 1751 Apex Drive. This is the Certified Survey Map that is needed to create the zoning lot for the NorthStar Radioisotopes production facility, which is scheduled to begin construction early this coming summer. Plan Commission unanimously recommended for approval.
- e. Resolution authorizing **Final Payment of the Public Works contract** for Renewable Energy Systems. This project utilized funds from the City's Capital Budgets to pay for the installation of solar photovoltaic cells on City Hall. The project has been completed and it is recommended that Council authorize the final payment.
- f. Resolution approving 2012 Para transit Aids Contract between the State of Wisconsin and City of Beloit. The revenue received by the Transit Division of the Public Works Department from this program was already submitted in the annual State operating assistance grant application. The City will obtain \$16,448 from the State of Wisconsin Department of Transportation to offset some of the costs associated with operating Para transit services as required in the Americans with Disabilities Act.

#### 7. ORDINANCES

- a. Proposed Ordinance to amend the Zoning District Map to change the Zoning District Classification from PLI, Public Lands and Institutions District, to C-2, Neighborhood Commercial District, for the property located at 1872 Porter Avenue. This property was previously a part of the Beloit Catholic High School campus and zoned Public Lands and Institutions (PLI). A new user has occupied the building, which requires a zoning change to the C-2 Neighborhood Commercial District classification. This is a second reading and Plan Commission unanimously recommended for approval.
- b. Proposed Ordinance to establish No-Parking Regulations on Cleora Drive. Currently, parking is allowed on both sides of Cleora Drive. The Engineering Division recommends parking be limited to the residential (east) side of the street between Sun Valley Drive and Poff Street. This is a first reading, and Traffic Review Committee unanimously recommended for approval.

a. **Community Development Reorganization**. Julie Christensen, Community Development Director, will give a PowerPoint presentation on the proposed reorganization of the Community Development Department.

#### 11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution authorizing the City Manager to apply for Homeland Security WISCOM Upgrades to local agencies Grant Program (Fire Department). The Wisconsin Office of Justice Assistance notified local public safety agencies that they were eligible for supplemental funding in order to allow them access to the State of Wisconsin WISCOM radio system. The Fire Department is eligible for an additional \$55,000 in funding to upgrade the mobile and portable communications in department vehicles and the Emergency Operations Center.
- b. Resolution authorizing the City Manager to apply for Homeland Security WISCOM Upgrades to local agencies Grant Program (Police Department). The Wisconsin Office of Justice Assistance notified local public safety agencies that they were eligible for supplemental funding in order to allow them access to the State of Wisconsin WISCOM radio system. The Police Department is eligible for an additional \$65,000 in funding to upgrade the mobile and portable communications in department vehicles, command post, and the Emergency Operations Center.
- c. Resolution amending the 2012 Capital Improvement Budget and appropriating funds for Homeland Security WISCOM Upgrades to local agencies grant program (Police and Fire Departments). The upgrades to the public safety radio systems were not included in the 2012 CIP budget; therefore, a budget amendment and appropriation authorization is also being proposed for Council consideration.
