## BELOIT POLICE DEPARTMENT RECEIVES REACCREDITATION FROM THE WISCONSIN LAW ENFORCEMENT ACCREDITATION GROUP

Please note attached to the Beloit Report a copy of correspondence received by Chief Norm Jacobs of the Beloit Police Department this past week. The letter is a notification and congratulations from the Wisconsin Law Enforcement Accreditation Group indicating that the department meets all of the professional standards established by this group for law enforcement accreditation. The department will soon be undergoing a CALEA accreditation re-evaluation for approval by the National Law Enforcement Accreditation Group.

#### CITY TO PARTICIPATE IN CLEAN SWEEP 2012 HAZARDOUS WASTE COLLECTION

Please find attached a copy of the flyer with detailed information regarding this year's Clean Sweep for hazardous waste. The pickup in Beloit will be on **Saturday, April 28 from 8:00** a.m. to noon (RSVP required prior to event). On the preceding Friday, April 27, there will also be a drop off at the City of Evansville Public Works garage, should that prove to be a more convenient time or location. This is a great opportunity to get rid of household products that may contain mercury, solvents, or chemicals of any sort, along with pesticides, old fuel, and similar products.

#### REGIONAL DIRECTOR FOR U.S. SENATOR RON JOHNSON VISITS BELOIT

Manny Vasquez, the Regional Director for Southern Wisconsin for U.S. Senator Ron Johnson, visited with City officials this past week. We had an opportunity to meet Mr. Vasquez and obtain contact information. This individual will be a contact point when the City needs to contact Senator Johnson's office.

#### **UPDATE ON WAGNERS/DOWNTOWN REDEVELOPMENT**

Several months ago, Hendricks Development purchased the building on East Grand Avenue that formerly held the Wagners Office Supply business. Since that time, representatives from Hendricks Development have been actively working on a redevelopment project for that block of East Grand Avenue, and have been in contact with the City about developing a public/private partnership to facilitate that significant redevelopment effort. Representatives from the City and Hendricks Development have had preliminary discussions about a Development Agreement to implement that partnership. Hendricks Development has also been working on perfecting plans and obtaining a major tenant for most of the building space. At this time, we hope to have enough preliminary work completed on both the Development Agreement and the project plans, to present the project to City Council and the community at a workshop tentatively scheduled on **Monday, April 9, 2012**. Following the workshop and Council input, work would continue on preparing a final draft of a Development Agreement for Council consideration at a subsequent City Council meeting. Hendricks Development advises the City that if a Development Agreement can be finalized, they plan to move forward yet this year with construction on this project.

#### **NEIGHBORHOOD REVITALIZATION UPDATE**

The Neighborhood Revitalization Committee met this past Tuesday and discussed a number of initiatives currently underway. Staff is in negotiations to purchase several residential properties for the Neighborhood Stabilization Program (NSP). There are not a lot of foreclosed properties available in our designated census tract, and we've had some problems in negotiating pricing with the financial institutions that currently hold title to these properties. Staff will continue to try to acquire the properties needed for the NSP Phase 3. Properties acquired earlier under NSP, as well as the property tax foreclosure program, that were slated for demolition have all been contracted for at this time. Several of the properties have been removed and others are slated for demolition in the immediate future. Over the next several months, Community Development and Engineering staff will focus on remodeling the better quality units which have been acquired for this purpose.

Community Development staff is also working with the listing broker to put together a 50-50 program for the four remodeled Neighborhood Stabilization program homes currently for sale. Most of these properties are listed from the mid-to-high \$60,000 amount. Staff is working on a plan to offer them at \$50,000 each for a period of 50 days. All of the units have undergone a complete interior and exterior remodel, and are in move-in condition. This would be a great value and an opportunity for qualified residents to purchase these properties at a very attractive price.

#### **EMPLOYEE UPDATE MEETINGS**

I have scheduled a total of 13 meetings with various groups and City employees throughout the month of April to provide an update report on community activities completed in 2011 and plans for 2012. The presentation is similar to the community update that we presented to Council in February and provides me with an opportunity to meet with all City employees to give them an overview update on community activities and to answer questions about city operations.

#### **CASINO UPDATE**

The City did receive resolutions of support for the Beloit Casino Project from the City Councils of both Rockton and South Beloit this past week. Those resolutions were passed on to the Ho-Chunk Nation to include in their application packet, along with the resolution of support from the Beloit City Council. The Nation's representatives indicated they are actively working on completing the application and it should be filed with the Bureau of Indian Affairs (BIA) in the next few weeks.

The Beloit Public Library will be **closed** on Friday, April 6 in observance of the Spring Holiday. The outside book drop, located on the south side of the building, is open 24 hours a day. The library will reopen on Saturday, April 7 at 9:30 a.m.

- a. Proclamation supporting "The Big Read" program at the Beloit Public Library.
- b. Proclamation recognizing April as **National Fair Housing Month**. A presentation from the City's Fair Housing Coordinator is included later in the agenda.

#### 6. CONSENT AGENDA

- b. Resolution awarding **Public Works Contract** for mud jacking. This contract is for maintenance on various concrete streets where slabs have settled or become misaligned. Mud jacking is the inexpensive alternative to reconstruction and often restores street sections to like-new condition.
- c. Resolution awarding **Public Works Contract** for the Mill Street Parking Lot Rehabilitation. This contract will result in the milling resurfacing and restriping of the Mill Street parking lot downtown. This is one of the smaller remaining infrastructure projects that we have scheduled for completion prior to the closure of the expenditure period for the downtown TIF District. The project will be a short duration improvement, likely scheduled for a single week sometime in late April or early May. Close coordination with local businesses will precede the beginning of construction.
- d. Resolution authorizing final payment of **Public Works Contract** for the Hawthorne Drive sewer and water extension. There are a few punch list items remaining on the project that will be completed this spring prior to distribution of the final payout. Engineering has indicated, however, that the project is complete and ready for final payment.
- e. Resolution authorizing final payment of **Public Works Contract** for the Park Avenue and Shirland Avenue Reconstruction projects. This work was completed in 2011; all of the punch list items have been resolved and the contract is ready for closure and final payment.
- f. Application for a **Conditional Use Permit** to allow outdoor seating area and outdoor sales, possession, and consumption of alcohol in a C-3, Community Commercial District. This application is for the new Tilley's pizza House located at 900 Fourth Street. This application is being referred to the Plan Commission for review and recommendation.
- g. Application for a **Zoning Map Amendment** to change the Zoning District Classification from Public Lands and Institutions to C-1, Office District, for the property located at 250 Garden Lane. This is the former County Court House property, which has actually been sold twice since Rock County disposed of the property. The current owner would like to use the building for various office uses and that zoning classification is included in the City's Comprehensive Plan for this site. The PLI Zoning District is clearly inappropriate now that the building is no longer utilized for a governmental purpose; however, to date the owners have not had a planned reuse and have not taken the steps necessary to upgrade the zoning classification. This item is being referred to the Plan Commission for their review and recommendation.
- h. Application for a **Zoning Map Amendment** to change the Zoning District Classification from Planned Unit Development to C-3, Community Commercial District, for property located at 1610 Willowbrook Road. This is another

situation where the Planned Unit Development was not constructed and the project has expired. That is recommending that we rezoned to the underlying classification. If the owner should proceed with the project in the future, a new Planned Unit Development application will be required. This matter is being referred to the Plan Commission for review and recommendation.

- i. Application for a Class "B" Beer and "Class B" Liquor License for Tilley's Pizza House, Inc. located at 900 Fourth Street. This is the liquor license for the new Tilley's location and it is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.
- j. Application for a Retail License Transfer for Class "B" Beer and "Class B" Liquor License for Tilley's Pizza House from 904 Fourth Street to 900 Fourth Street. This is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.
- k. Application for Class "B" Beer and "Class B" Liquor License for the Draeving Companies, who are opening a new facility called Thirsty Badger Bar and Grill, which will be located at 2683 Prairie Avenue. This is a new restaurant and bar operation in an existing building, which is undergoing some remodeling and outfitting for this use. The application is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.

#### 10. CITY MANAGER'S PRESENTATION

a. Presentation of Analysis of **Impediments to Fair Housing**. This presentation was alluded to earlier in the agenda and will be presented jointly by Julie Christensen and Teri Downing from the Community Development Department. The analysis has been completed and is posted to the City's website and can be accessed via a link on the home page.

#### 11. REPORTS FROM BOARDS AND CITY OFFICERS

a. Resolution approving **Farm Leases** for the former Woodman's property located on Burton Street. The City received the donation of this property several years ago and has tried on at least three separate occasions to put together some type of housing development for the utilization of this site. None of those projects were successful. The site is a large, vacant field, which must be mowed on a regular basis throughout the season. As part of the City's cost-cutting initiatives for this year, we have been attempting to find alternative uses, including returning many of these vacant parcels to agricultural use, both to save money and, when feasible, produce income for the City. The City currently has many acres of farm land located throughout the community, including some in close proximity to residential neighborhoods. As noted in the staff report, this large parcel costs the City approximately \$5,400 per year to keep mowed and the best bid for returning this to agricultural use would generate between \$3,100 and \$3,400 per year in revenue. The total benefit to the City would be in the magnitude of \$47,000 over the five-year lease period.

The City also received an alternative proposal to leave the land in grass. The site would be mowed periodically throughout the season and the grass would be baled or harvested in some fashion for agricultural use. That would be a somewhat cleaner operation, but would generate less revenue. The City would not receive any income but would save the \$5,400 per year mowing costs for a savings of approximately \$27,000 over the five years.

Either proposal would be acceptable to the City. I see no reason why this area could not be returned to agricultural use; however, if Councilors would feel more comfortable in leaving the grass in place, then this bid could simply be rejected. As noted in the staff report, there is no revenue or cost associated with the alternative bid to simply harvest the grass off the site and the City could administratively enter into an agreement with that individual for that purpose.
