CURRENT EVENTS AND ACTIVITIES

RIVERFEST SCHEDULED FOR NEXT WEEK

Riverfest begins next Wednesday, June 27 and runs through Sunday, July 1, 2012. A large carnival, food and refreshments, plus music from notable local and regional groups will again be featured at this year's Riverfest. URBAN CHICKEN ORDINANCE

This past week, the Stateline journal included a fairly detailed ordinance related to the discussions currently underway to prepare a draft ordinance which, if approved by the City Council, would allow for the keeping of chickens in the City's urban residential neighborhoods under certain conditions. This past week, the staff completed preparation of a second proposed draft ordinance, and we have tentatively set aside Monday, July 2, 2012 at 5:30 p.m. as a workshop date and time to continue discussions related to preparing a draft ordinance for this purpose.

Once again, the workshop will be held in the Council Chambers (Forum) here at City Hall and the public is invited to attend.

BUDGET PREPARATION

Beyond the pre-budget submittal workshop held with Council this past Monday, June 18, little additional work has been done on the budget this week. Division and Department Directors are still inputting their initial budget requests. The City Manager's staff has scheduled a meeting this coming Monday to go over our individual operating budget submittal.

ECONOMIC DEVELOPMENT UPDATE

While no major employers have announced plans to relocate or substantially expand facilities in recent months, we continue to see improved economic development activity. This past Monday evening, the City Council approved a residential care apartment complex project located at 2157 Schuster Drive, south of Cranston Road. A regional supermarket chain is still looking at available sites within the community.

We also met with MLG, our development partners in the Gateway Business Park this week, to discuss our ongoing business relationship and the status of real estate, including the probable date for closing on the acquisition of property for the NorthStar development.

NorthStar has also been in and is working with the design team now to complete their plans for both their site and building to make a formal building permit application. The project is running slightly behind schedule but still anticipates a full building permit submittal yet this summer.

CONSTRUCTION UPDATES

Flood Protection Downtown

The new sea wall and rip-rap area downtown running from the Broad Street bridge south behind the Post Office to the Fifth Street bike path and beyond, is actually nearing completion. Most of the heavy construction work is now complete and the contractor is heavily involved in restoration on and around the site. This area is close by but outside the festival grounds and will not interfere with Riverfest scheduled for next week.

Henry Avenue Bridge

This week, the contractor made the first large pour on the bridge deck, which included about 2/3 of the length of this improvement project. The second pour will be made later. The bridge is still on schedule for completion by September 1, 2012. The dedication and ribbon cutting ceremony is scheduled for Saturday, September 8, 2012 at 10:00 a.m. in conjunction with Heritage Days weekend.

North Riverside Park

The pre-construction meeting for the North Riverside Park improvements is scheduled and hopefully construction will begin within a matter of days on the north end improvements to Riverside Park. We anticipate dedicating those park improvements in conjunction with the Henry Avenue Bridge dedication on Saturday, September 8, 2012. These improvements will actually mark the final completion of Riverside Park upgrades all the way from Portland to Henry Avenue. Maintenance and care for the facility will, of course, continue; however, this project will mark the completion of all construction improvements planned for Riverside Park.

Downtown Improvements

Bids for the resurfacing of Colby Street and the reconstruction of the West Grand Avenue parking lot will be on Council's agenda for the July 2, 2012 meeting. The Mill Street lot was already resurfaced and the Broad Street lot is being held pending completion of the East Grand Avenue redevelopment project. The City has also noted that the Chester Square lot needs resurfacing. Fortunately, the lot is relatively small and there are adequate appropriations remaining in the downtown account to accommodate that paving. The project will be included with the second street resurfacing project, which will be let in July. Work is also proceeding on the upgrades to various street furnishings, to be completed this summer ahead of the expenditure period termination, which occurs in September.

Intermittent Street Resurfacing

The first round of streets to be repaired and resurfaced under this program are essentially complete at this time. As noted above, the second round of street resurfacing projects is included in the bid that will be let in July.

Park Improvements

Other than the north end of Riverside Park, no major park reconstruction projects are scheduled for this year. There is some funding available in the current capital budget, as well as carryover from prior years, and a number of smaller projects are underway throughout the system, including replacing and/or installing playground apparatus, upgrading benches and furnishings in some sites, repairing and/or replacing fencing and related smaller scale improvements of this type.

CITY COUNCIL TO REVIEW "CONNECTION PLAN"

A <u>special informational meeting</u> with both the Beloit and South Beloit City Councils has been scheduled for next Tuesday, June 26, 2012 at 5:30 p.m. at the Sand Castle Community Center, located at 201 South 8th Street, South Beloit. The two Councils will hear a briefing on the status of planned improvements to create bike/pedestrian path connections between the two cities.




