BELOIT AND JANESVILLE CITY COUNCILS TO CONDUCT JOINT WORKSHOP

The City Councils of both Beloit and Janesville will meet in joint session next **Monday, July 9, 2012 beginning at 5:30 p.m.** The joint <u>meeting</u> of the Councils will be held in The Armory, 10 South High Street, Janesville, Wisconsin.

The joint Councils will begin by hearing a briefing and update on various economic development marketing activities underway in Rock County. Following that presentation, Council members will hear an update on joint service delivery and collaboration activities that are on-going between the two municipalities. The meeting will be open and the public is invited to attend.

SUPERWEEK BIKE RACES COME TO DOWNTOWN BELOIT

Just a reminder that SuperWeek Bike Races will be held in various locations throughout the next several days. These are generally referred to as the ICC SuperWeek Races. This year, the City of Beloit's downtown was honored to be selected as a location and races will be conducted in a downtown circuit this coming **Thursday**, **July 12** beginning at 8:00 a.m. until approximately 8:00 p.m. A circuit will be laid out and access limited to some of the downtown parking lots, and certainly in and out of the area during race times. Access will be available between the various heats and a very large crowd is anticipated to spend the day in downtown Beloit attending this event. This is another great opportunity to showcase the tremendous improvements that have occurred in our historic downtown in recent years, and if the experience of other communities is a guide, there will be substantially increased activity for local merchants, as well.

TERRACE TREE WATERING REQUEST

We want to again remind the public that the Public Works Department has issued a request to all residents to assist the City with tree watering, particularly if you have terrace trees that were planted in front of your home in the last couple of years. Young trees without deep root structures are susceptible to damage, even dying in the extremely dry conditions such as we have experienced this year. The City has redeployed much of its seasonal staff and has multiple crews watering trees, landscaping, and other plantings to minimize loss during this unusually dry summer season. trees, be sure you also give thought to other plantings on your property, particularly anything that has been planted in the last two to three years and may not have a deep, fully established root structure.

CLEAR WATER METERS AVAILABLE THROUGH WATER RESOURCES

The <u>attached</u> press release from the Water Resources Division of the Public Works Department reminds residential customers only, that clear water meters can be rented from the City's Water Utility to use for large pool filling and watering of lawns and gardens. Customers that rent a clear water meter for this purpose avoid any wastewater fees, which are also calculated based upon the amount of water that runs through your regular household meter. If you plan on expensive lawn watering due to dry conditions this summer, you may want to consider renting a clear water meter from Beloit Utilities as a lower cost option to meet your watering needs.

Permanent clear water meters can also be installed in your home if you have a lawn irrigation system, a pool that is regularly filled, or other heavy outside watering needs. For more information about both temporary and permanent clear water meters, please contact Water Resources at 608-364-5735.

RESIDENTS INVITED TO AN INFORMATION MEETING REGARDING MCKINLEY AVENUE RECONSTRUCTION

A portion of McKinley Avenue located between Portland Avenue and Liberty Avenue has become badly deteriorated in recent years and is scheduled for reconstruction later this summer. Contracts will be let soon to replace the curb, gutter and driveway aprons along this portion of McKinley, and then to mill and resurface the asphalt driving surface. Adjacent property owners and interested residents are invited to attend an informational meeting that has been scheduled at the **Beloit City Hall, 4th Floor Health Conference Room, 100 State Street from 4:30—6:00 p.m. on Wednesday, July 11, 2012.** City Engineering staff will be available to discuss the planned improvement with adjacent property owners and interested residents.

URBAN CHICKEN ORDINANCE

The second workshop to work on a draft ordinance which would allow for the keeping of chickens in the City's urban residential neighborhoods was held this past Monday evening. Once again, there were a number of different opinions and attitudes articulated at the session. A number of language issues related to completing a final draft of the ordinance were also discussed. City staff is currently preparing an updated draft of the ordinance to incorporate those suggested modifications and also continuing its research on the experience other communities have had with the keeping of chickens in urban neighborhoods. No specific timeline exists for when a draft ordinance may be placed on Council agenda for formal consideration.

BUDGET PREPARATION

July 6 marked the deadline for departments and divisions to complete and enter their initial operating budget requests into the City's budget software. Initial meetings with department and division directors have been scheduled the week of July 16, 2012 to begin the initial round of reviews for the City's proposed 2013 Operating Budget. This process normally takes about two months to complete for all of the various operating departments and divisions, with final budget preparations being finalized in September for the initial presentation of the budget to Council and the community, which is scheduled for Monday, October 1, 2012.

Clear Water Meter Program

July 5, 2012 – Portable clear water meters may be rented from the City of Beloit Water Utility to be used for large pool filling and watering of lawns and gardens. The benefit to the customer is the avoidance of the wastewater fee of \$2.95/unit for water not entering the sanitary sewer system.

Rental period options are ten (10) days at a cost of \$15 or forty-five (45) days at a cost of \$40. There is also a deposit of \$40 for each rental unit. Kits are available from the City's Water Resources Division between the hours of 7:30 a.m. and 4:00 p.m. We are located in the Beloit Utilities and Engineering Facility at 2400 Springbrook Court.

Clear water meters are available to City of Beloit *residential customers* only. Customers must also be current on their account.

During this period of hot and dry weather it's best to water your lawns and gardens in the morning. Also, water in several short sessions to allow the soil to better absorb the moisture.

29th ANNUAL NATIONAL NIGHT OUT

The Beloit Fire Department, the Beloit Police Department, and the Beloit Crime Stoppers will once again partner in celebration of the 29TH National Night Out on August 7TH 2012.

On August 7TH from 5:30-8:30pm residents in neighborhoods throughout Beloit are asked to lock their doors, turn on and display outside lights and spend the evening outside with their neighbors. Last year over 35 neighborhood blocks registered to participate in Beloit's National Night Out celebration.

Last years' National Night out campaign involved citizens, law enforcement agencies, civic groups, businesses, neighborhood organizations and local officials from over 15,000 communities from all 50 states, U.S. territories, Canadian Cites, and military bases worldwide. In all, 37 million people participated in National Night out 2011.

As in the past, Beloit Police, Firefighters, City Officials, Crime Stoppers, and elected representatives will visit many of block parties and cookouts. Each neighborhood block will be responsible for planning special activities. Barricades will be available.

National Night Out is designed to:

- Heighten drug and crime awareness
- General support for, and participation in, local anticrime programs
- Strengthen neighborhood spirit, and police-community partnerships
- Send a message to criminals letting them know that neighborhoods are organized and are fighting back

All neighborhood blocks participating in this year's National Night Out activities should register with the Beloit Police Department.
