CURRENT EVENTS AND ACTIVITIES

BIKE RACERS NAVIGATE THROUGH DOWNTOWN BELOIT

On Thursday, July 12, the City of Beloit hosted the Downtown Beloit Criterium presented by "Be Active Outdoors." The event, which was part of the ICC SuperWeek Bik Races, included eight semi-professional races and one fun ride for amateurs who wanted to sample the race course. The criterium loop consisted of a 0.8 mile loop, which traveled clockwise from West Grand to East Grand, south on Pleasant Street, and west on Broad Street. The athletes enjoyed the course that was part of their 17-day bike tour circuit, and gave positive feedback to the organizers. Again, this was a wonderful opportunity to showcase our beautiful downtown area, as well as demonstrate our hometown hospitality to the athletes and their supporters, some who came from around the world.

TERRACE TREE WATERING REQUEST

The Public Works Department has issued a request to all residents to assist the City with tree watering, particularly if you have terrace trees that were planted in front of your home in the last couple of years. Young trees without deep root structures are susceptible to damage, even dying in the extremely dry conditions that we have experienced this year. The City has redeployed much of its seasonal staff and has multiple crews watering trees, landscaping, and other plantings to minimize loss during this unusually dry summer season. We would also urge residents while you're out watering terrace trees, be sure you also give thought to other plantings on your property, particularly anything that has been planted in the last two to three years and may not have a deep, fully established root structure.

CITY COUNCIL MEETING - MONDAY, JULY 16, 2012

The City Council will meet at 5:30 p.m. on Monday, July 16, 2012 in the City Manager's Conference Room located on the 4th Floor of City Hall. The Council will immediately adjourn into <u>Closed Session</u> to discuss two possible property acquisitions. One involves a property in downtown Beloit that is under negotiation, and a second one involving some properties in the Gateway Business Park area. The Council will reconvene into open session.

Mid-week, a new issue arose, which constitutes an unanticipated opportunity for the City's Central Business District. At approximately 6:15 p.m., City Council will consider a supplemental appropriation to the 2011 Capital Improvement Budget in the amount of \$90,000 to provide additional funding for the Upper Floor Housing Initiative in the City's Central Business District. This initiative, along with the façade renovation grant program, was started about three years ago, and there have been some participants. This summer, as we near the conclusion of the TIF expenditure period, we have suddenly received a number of applications from property owners to do both façade renovations and upper floor housing projects before the TIF expenditure period closes. This would literally be a last minute opportunity to make significant improvements in a number of downtown buildings.

The funds are, of course, available and TIF #5 and the relatively small supplemental appropriation would facilitate completion of a significant number of second floor housing projects prior to the closure of the TIF expenditure period. As previously noted, there are also a significant number of façade renovation projects included in this last round of grant approvals, although no supplemental appropriation is required to support that program. This supplemental appropriation will allow the Downtown Beloit Association Loan Committee to approve all applications currently pending, which would make them eligible for reimbursement, even if the work is not concluded until later this fall.

At approximately 6:30 p.m., the City Council will hold the normal Agenda Review Workshop in the Manager's Conference Room.

4. PUBLIC HEARINGS

a. Public Hearing to Solicit Input on the Community Development, Housing, and Homeless Needs in the City for inclusion in the 2013 Annual Action Plan for Community Development Block Grant (CDBG) local funding priorities. Also included in the Council packet is a resolution establishing priorities that have been determined by the Community Development Authority Board for the 2013 program year.

6. CONSENT AGENDA

- a. Approval of the **Minutes** of the regular meeting of July 2, 2012.
- b. Resolution approving a Class "B" Beer and Reserve "Class B" Liquor License for The Cheese People of Beloit, located at 431 E. Grand Avenue. The Alcohol Beverage License Control Committee unanimously recommended for approval with a contingency.
- c. Resolution awarding Public Works contract for the 2012 Street Resurfacing Phase II projects. The paving projects include resurfacing of Colley Road from Willowbrook Road east, approximately 1,900 feet, along with improvements needed to various roads in the East Lawn Cemetery and Big Hill Park. The Chester Square parking lot, downtown, will also be resurfaced under this particular bid, although funding for this project will come from downtown TID #5 funding sources.

- d. Resolution awarding a Public Works contract for **Pavement Markings** for the 2012 construction season. The bid will refresh pavement markings along Milwaukee Road, between Lee Lane and Freeman Parkway; Cranston Road between Milwaukee Road and Settler Avenue; and place new pavement markings on Frederick Street between Liberty Avenue and Madison Road.
- e. Application for an **Obstruction Easement** to allow a sign in the public right of way abutting the property located at 2460 Milwaukee Road. This request was made on behalf of Central Christian Church to construct a 16-ft. pylon type pole sign in the public right of way adjacent to the church property located at 2460 Milwaukee Road. This is a somewhat unusual request, since we normally do not allow the installation of private signs within the public rights-of-way, which are generally reserved not only for street use but also for the installation of both above and underground utilities on an as-needed basis. This application is being forwarded to the Plan Commission for their review and recommendation.

7. ORDINANCES

a. An ordinance amending the Section 13.05(3) of the Municipal Code related to **Overnight Parking Permits** for the downtown Business Improvement District. This ordinance was presented at the last meeting and received a first reading. It is back on the agenda for Council consideration of second reading and approval.

10. CITY MANAGER'S PRESENTATION

a. Paul York, Director of Finance and Administrative Services along with representatives from Baker Tilly will be in attendance to present the 2011 Audit Report to the City Council. The audit report has been posted to the City's website and can be viewed [here].

11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution authorizing the Application and Borrowing of up to \$377,000 from the State of Wisconsin Board of Commissioners of Public Lands, State Trust Fund Loan Program. This loan covers some of the smaller, shorter life span capital spending included in the 2012 capital projects budget. The loan was anticipated and included in the consultant's analysis of debt for 2012, which was submitted to Council for review prior to the bond issues authorized earlier this year. We have reached the point in the application process where a Council resolution is required to continue processing the State Trust Fund loan.
- b. Resolution releasing a right of first refusal for a residential property located at **348 Locust Street**. This property was purchased by the City over ten years ago and underwent some remodeling. Prior to its sale, the City was approached by Family Services of Southern Wisconsin and Northern Illinois about acquiring the property for \$5,000 to be used as a domestic violence shelter. While the property sale was being negotiated, the City requested a "right of first refusal" be inserted into the contract so that if for any reason the agency ever ceased operating the program or no longer wished to utilize this facility, the City would have the right of first refusal to repurchase the property in the amount of \$5,000.

The agency has now terminated its use of the facility and wishes to place the property for sale in the open market. Family Services believes the property could be sold for substantially more and would like the opportunity to recover that money from the potential sale, which would then be used to subsidize the agency's operating budget.

At the present time, the City has a number of residential properties in inventory that are listed for sale. Four more will be coming on-line over the next several months, which are being remodeled under the Neighborhood Stabilization Program. Councilors are aware that residential properties have been selling at a slow pace and we have had some in

inventory for over two years, awaiting a buyer. Consequently, the City has no particular interest in acquiring this property and placing it in inventory, where it may require some remodeling or maintenance expense, and then sit on the market for an extended period of time. We are recommending that the Council authorize the waiver of the right of first refusal, allow the agency to proceed with a conventional sale of the property. If the agency is successful, they will recover more than the \$5,000, which would be used for providing services to the Greater Beloit community.

29th ANNUAL NATIONAL NIGHT OUT

The Beloit Fire Department, the Beloit Police Department, and the Beloit Crime Stoppers will once again partner in celebration of the 29TH National Night Out on August 7TH 2012.

On August 7TH from 5:30-8:30pm residents in neighborhoods throughout Beloit are asked to lock their doors, turn on and display outside lights and spend the evening outside with their neighbors. Last year over 35 neighborhood blocks registered to participate in Beloit's National Night Out celebration.

Last years' National Night out campaign involved citizens, law enforcement agencies, civic groups, businesses, neighborhood organizations and local officials from over 15,000 communities from all 50 states, U.S. territories, Canadian Cites, and military bases worldwide. In all, 37 million people participated in National Night out 2011.

As in the past, Beloit Police, Firefighters, City Officials, Crime Stoppers, and elected representatives will visit many of block parties and cookouts. Each neighborhood block will be responsible for planning special activities. Barricades will be available.


