#### **CURRENT EVENTS AND ACTIVITIES**

#### STORM CLEAN UP PRODUCES WOOD CHIPS

This week, the City leased a tub grinder and converted all of the downed trees and tree limbs into finely shredded mulch, which is suitable for many landscape operations or similar uses. The City has stored some of the material for possible future use; however, a great deal remains and has been deposited at the small parking lot south of the Krueger Haskell Golf Course. Residents are free to take as much of the mulch as you can use. If residents have a truck or trailer, Public Works will be loading free of charge on Monday, August 13 from 7:00 a.m. to 1:00 p.m.

Also, if you have need of a large volume of the material, arrangements can be made for delivery by contacting the Public Works Operations office at 364-2929 by Monday, August 13<sup>th</sup>.

#### **TEMPORARY ROAD CLOSURES**

On Monday, August 13 at 7:00 a.m., the Public Works Engineering Division will close Milwaukee Road from Arlington Avenue to Bushnell Street, and Bushnell Street from Milwaukee Road to Central Avenue for sewer lining operations. The closures will last for short periods of four to six hours at a time for approximately one week. The City advises the public to detour to the adjacent streets during the construction period, as the road will be open to local traffic only.

#### **NATIONAL NIGHT OUT**

Once again, National Night Out sponsored by Crimestoppers and the Beloit Police Department included enthusiastic participation by numerous residents at neighborhood picnics. Both the Police and Fire Departments had a huge turnout of personnel and apparatus that made the rounds and provided information to participants. Several City Councilors participated, including Sheila De Forest, Charles Haynes, Kevin Leavy, Jim Van De Bogart, and Dave Luebke.

#### **BUDGET PREPARATION**

Again this week, we continued with work on preparation of the 2013 budget. City Finance staff reviewed preliminary equalized assessment projections from the Department of Revenue (yes, they're going to be down again this year) and staff continued work on some of the special revenue fund budgets that are completed as part of the process each year. Following midmonth receipt of final equalized assessment numbers, city staff will begin to compile the final draft of the proposed budget document.

## DEDICATION AND RIBBON CUTTING FOR NORTH RIVERSIDE PARK AND THE RENAMED KEN HENDRICKS MEMORIAL BRIDGE

Planning has begun in earnest for the ribbon cutting and dedication ceremonies scheduled for **Saturday, September 8, 2012 beginning at 10:00 a.m.**, on the east side of the bridge. The ceremonies will mark the completion of the north Riverside Park improvements. The new monument sign, upgraded walks, lighting and landscaping are currently under construction and the improvements will be completed by that date.

Family members and dignitaries will be unveiling a special plaque installed on the bridge commemorating Ken Hendricks' extraordinary accomplishments and contributions to the City of Beloit. Following dedication of the plaque, the final ribbon cutting will be held to open the newly renamed Ken Hendricks Memorial Bridge. This will be an extraordinary event in the City's history, marking the final completion of the 20-year Riverside park improvement program and, of course, reopening of the newly constructed bridge renamed to honor Ken Hendricks. Following the dedication ceremonies, the contractor will actually open the bridge for resumption of normal use. Parking for the ceremonies will be in Riverside Park, the Eclipse Center, and Wooten Park (pedestrians will be able to walk across the bridge for the ceremony). Limited parking for family members and dignitaries will be available on Henry Avenue, just east of the bridge near the north end of the park.


