HERITAGE DAYS WEEKEND/9-11 COMMEMORATION

I hope all Beloit residents will partake in at least some of the many activities scheduled by organizations throughout the community as part of the Heritage Days weekend, which will be celebrated this Friday evening, September 9 through Sunday, September 11. Please click [here] for a detailed listing of events with times and locations that will be part of this weekend's activities.

Also, don't forget the 12:00 noon commemoration of the 9-11 attacks on the United States. <u>Attached</u> is a proclamation that was issued by Council President Leavy this past Monday evening, calling upon all residents to observe a moment of silence or participate in some other appropriate activity at 12:00 noon in remembrance of the tenth anniversary of this important date in our nation's history. A copy of the proclamation is attached and could serve as a basis for comments or to be read as part of your commemorative activity.

BUDGET PREPARATION

This week, we completed work on the General Fund budget. Although it has been a difficult and trying process, we do have a proposed balanced General Fund budget. A <u>Special Council Meeting</u> with Closed Session is being scheduled for this coming **Tuesday, September 13, 2011 at 5:30 p.m.** to discuss with Council the specific personnel reductions included in the proposed budget document. We would like to make Council aware of the positions we have identified for elimination, both to get some informal feedback on the proposals, and also as a prelude to early notification for employees that will be impacted by the budget. It should be noted that we have some current openings and other retirements scheduled for later in the year, so that many of the positions scheduled for elimination will be done through attrition. Also, in some cases we have openings in other funds not impacted by the State Revenue reductions, and there will be employment opportunities extended to some of the individuals impacted by the General Fund budget. Our goal at the end of the day, of course, is to minimize layoffs, both because of the impact on the individual and their families, as well as the cost to the City inherent in a layoff process.

HENRY AVENUE BRIDGE IS CLOSED

The Henry Avenue Bridge was closed this past Tuesday, September 6 as scheduled. The detour signs are in place and traffic does seem to have shifted to other arterial routes, with much of the river crossings occurring at the Portland

Avenue Bridge. Construction has begun and work will be continuing, hopefully at a good pace. The bridge is scheduled for reopening on or about September 1, 2012.

CONSTRUCTION UPDATES

The concrete contractor has mobilized downtown and work is continuing at a good pace on Shirland and Park Avenues. The same contractor also had the concrete work for Short Street and curbing was placed for that project this week, as well. Work should continue at a good pace and we anticipate having all of the downtown street construction completed, including restoration, by the end of September.

Work is also progressing on Cranston Road. Utility installations are currently underway, with the underground work scheduled to be completed in the near future. The contractor will then begin paving operations.



Recognizing the National Moment of Remembrance for the 10th Anniversary of September 11th

WHEREAS, the City Council of the City of Beloit expresses its support of the United States Senate by joining the Nation and ceasing all work or other activity for a moment of remembrance beginning at 12:00 p.m. Central Daylight Time on September 11, 2011, in honor of the 10th anniversary of the terrorist attacks committed against the Unites States on September 11, 2001; and

WHEREAS, on September 11, 2001, three hijacked airliners crashed into the North and South Towers of the World Trade Center and the Pentagon, and the passengers and crew of a fourth hijacked airliner acted heroically to thwart the taking of additional American lives by crashing the airliner in Shanksville, Pennsylvania; and

WHEREAS, nearly 3,000 innocent civilians were killed in the heinous attacks of September 11, 2001, and countless fire and police departments, emergency medical personnel, government officials, workers, and volunteers responded immediately and heroically to these horrific events; and

WHEREAS, 10 years later, the people of the U.S. and around the world continue to mourn the tremendous loss of innocent lives, and thousands of men and women in the U.S. Armed Forces remain in harm's way defending the U.S. against those who seek to threaten this country; and

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Beloit recognizes September 11, 2011, as a day of solemn commemoration of the events of September 11, 2001; offers its deepest condolences to the families and friends of the innocent victims of these attacks; honors the heroic service, actions, and sacrifices of first responders, law enforcement personnel, State and local officials, volunteers, and countless others who aided the innocent victims at the expense of their own lives; and recognizes the valiant service, actions, and sacrifices of U.S. personnel, including members of the Armed Forces, the intelligence agencies, the diplomatic services, homeland security, and law enforcement, and their families, who have given so much to support the cause of freedom and defend the security of the U.S.

BE IT FURTHER RESOLVED that the City Council of the City of Beloit encourages the observance of the moment of remembrance to last for 1 minute beginning at 12:00 p.m. Central Daylight Time by ceasing all work or other activity and marking the moment in an appropriate manner, including ringing bells, blowing whistles, or sounding sirens.


