BUDGET/POLICY UPDATES

With the budget now completed and posted on the website for use, we are devoting considerable time completing a number of personnel policy changes necessitated by the new Collective Bargaining Law. We anticipate having those policy reviews complete and ready for implementation by January 1, 2012 when many of the existing Collective Bargaining Agreements will be substantially reduced in compliance with the new Wisconsin Statute.

The Manager has also been busy completing annual performance evaluations for all of those individuals who report directly to the City Manager. With changes in the Public Works management structure, there are now five Public Works Division Directors who report to the Manager, in addition to Department Directors and office staff, which are supervised and reviewed on an annual basis.

BIFF PREPARATIONS WELL UNDERWAY

The Beloit International Film Festival is scheduled this year from February 16-19, 2012. CAPITAL PROJECTS PLANNING

The City, primarily through its Engineering Division, is also planning for various construction projects included in the City's annual capital budget for 2012. We had a meeting this week with representatives from the design firm doing construction plans for the North Riverside Park improvements. The construction plans will be based on design concepts earlier provided by Schreiber Anderson and Associates. We anticipate having at least the basic site plan completed in early January for review and approval by all the boards, commissions and City Council prior to bidding the improvements for construction next summer. Obviously, this work will need to be completed prior to the conclusion of construction on the Henry Avenue bridge project.

Beloit Police Department to join Booze and Belts traffic safety mobilization

To prevent traffic crashes and keep the upcoming holiday season from becoming a time of tragedy, Beloit Police Department will mobilize for the statewide "Booze and Belts" campaign from Dec. 9 to 17.

"Our officers will be out in force during the Booze and Belts mobilization to prevent needless traffic deaths and injuries by arresting impaired drivers and enforcing the mandatory safety belt law," said Sgt. Daniel Molland.

Law enforcement agencies are cracking down on impaired and unbuckled motorists.

Last year in Wisconsin, there were more than 40,000 convictions for operating a motor vehicle while under the influence of alcohol and / or a controlled substance. "If you drive impaired you are risking humiliation, huge fines, possible jail time and having to install an ignition interlock device on every vehicle you own, have registered in your name, or drive," said Sgt. Daniel Molland. "You also are risking your life and the lives of others on the road."

Furthermore, there were nearly 120,000 convictions for failure to fasten safety belts, which was the second most frequent traffic conviction in 2010.

"Our goal is not to make more impaired driving arrests or write more safety belt tickets. We are striving to save lives and prevent injuries, so we hope that people will voluntarily decide to buckle up and drive sober. But if they don't, our intensified enforcement will increase the risks of getting caught," said Sgt. Daniel Molland. "We will pursue our enforcement and education efforts until we attain our ultimate goal of zero preventable traffic deaths in Wisconsin."
