<u>Community Action - Supportive Services</u>

This program will address the service needs of participants in Helping Urban Beloit (HUB) Teen Parent Program, Skills Enhancement, and Beloit Fresh Start.

Timeliness

Because there is a great need at this time for these supportive services, Community Action will be able to expend all of the awarded dollars within the required 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. Community Action's program helps clients move towards economic self-sufficiency. Therefore, this program is an essential step towards economic self-sufficiency for their clients.

<u>Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity</u>

Although this activity will not create jobs, it is estimated to allow for the retention of 0.5 jobs currently in existence.

My Sister's Place

My Sister's Place provides transitional housing and case management services to women who are homeless due to victimization from domestic violence. The program functions as a "stepping stone" between crisis shelter housing and independent living.

Timeliness

Because there is a great need at this time for the services and housing that My Sister's Place provides, this agency will be able to expend all of the awarded dollars within the required 120 days. The demand for transitional living services continues to increase.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. My Sister's Place helps battered women move towards independence and economic self-sufficiency. This program is an essential step towards economic self-sufficiency for battered women and their children.

<u>Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity</u>

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Beloit Domestic Violence Center

The Beloit Domestic Violence Center provides emergency short-term shelter to women and children who are homeless as a result of domestic violence. Additionally, the center provides a wide array of services that help clients secure permanent housing.

Timeliness

Because there is a great need at this time for the services and housing that the Beloit Domestic Violence Center provides, this agency will be able to expend all of the awarded dollars within the required 120 days. This program is currently operating at a deficit, and clients are tending to stay in the shelter for longer periods of time. We believe that the clients the Shelter serves are having an even more difficult time transitioning to independent living at this time, which results in a greater need for the services provided by the Beloit Domestic Violence Shelter.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. The Beloit Domestic Violence Center helps battered women move towards independence and economic self-sufficiency. This program is an essential step towards economic self-sufficiency for battered women and their children.

Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Home Companion Registry

The Beloit Home Companion Registry offers unemployed and unskilled individuals a chance to enter the workforce. Additionally, the registry provides supportive and cost-effective home care to elderly, ill and disabled individuals, permitting them to remain in their homes. It also includes a case management element, where the director meets with the elderly in their homes.

Timeliness

Because there is a great need at this time for the services provided by the Beloit Home Companion Registry, this agency will be able to expend all of the awarded dollars within the required 120 days. This program saw decreased funding in 2009. Therefore, there is an even greater need for these resources. This program offers an option for seniors who live on a limited income, want to remain in their homes, but do not qualify for long-term support.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. The Beloit Home Companion Registry offers health care employment to low and moderate income women and provides a valuable service to our seniors. This program also provides the training for the job as part of the program.

Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Hands of Faith

Hands of Faith, in collaboration with the 25 local churches and several local service organizations, will provide emergency shelter for homeless families and help to end the cycle of homelessness for

those families through case management, mentoring and short-term assistance for rental/security deposit monies.

Timeliness

Because there is a great need at this time for the services provided by the Hands of Faith, this agency will be able to expend all of the awarded dollars within the required 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. With the downturn in the economy, a greater number of families have found themselves unemployed and homeless. Hands of Faith provides these families a safe play to stay and gives them the resources to get back on their feet and reach economic self-sufficiency.

Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Merrill Community Center

This program will provide a safe haven for youth and seniors, while educating them to help them be productive and self-sufficient citizens. Merrill's program includes a Heritage Curriculum and an ongoing focus on Character Counts. Other educational, recreational and enrichment projects will be developed and implemented by the program director.

Timeliness

Because there is a great need at this time for the services provided by the Merrill Community Center, this agency will be able to expend all of the awarded dollars within the required 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. In these economic times, there is a greater need than ever for the services of the Merrill Community Center. The Center partners with the schools to provide needed educational opportunities as well as providing a safe place for the children to be when parents may be out looking for employment.

<u>Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity</u>

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Stateline Literacy Council

The Stateline Literacy Council is proposing to meet the increased needs of the Hispanic community by providing English language classes to clients; recruiting, training, and supporting volunteer tutors; and enhancing individual referrals to help new immigrants transition into American culture.

Timeliness

Because there is a great need at this time for the services provided by the Stateline Literacy Council, this agency will be able to expend all of the awarded dollars within the required 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. In these economic times, there is a greater need than ever for the services of the Stateline Literacy Council. With fewer jobs available, the job market is more competitive than ever. The Stateline Literacy Council provides literacy training, which can help someone who has remedial skills get a better job or get any job. It is much harder at this point in our history for someone with basic literacy skills to get a job.

Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Voluntary Action Center - Senior Chore Service

The Beloit Chore Service provides a registry of screened, qualified independent contractors who are offering affordable repair and maintenance services. This registry is made available to seniors.

Timeliness

Because there is a great need at this time for the services provided by the Senior Chore Service, this agency will be able to expend all of the awarded dollars within the required 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: assisting those most impacted by the recession and minimizing or avoiding reductions in essential services. In these economic times, there is a greater need than ever for the services of the Senior Chore Service. This program provides employment opportunities for individuals completing the work for our seniors. Additionally, at a time where the prices of everything are rising, it is important to have a low-cost way for seniors to make minor repairs to their houses.

<u>Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity</u>

Although this activity will not create jobs, it is estimated to allow for the retention of one part-time job currently in existence.

Economic Development Revolving Loan Fund

This program offers low-interest loans to businesses.

Timeliness

The Executive Director of the Greater Beloit Economic Development Corporation has working with a business that has a need for these funds. Therefore, a loan could be closed and awarded with 120 days.

Explanation of How This Activity Will Maximize Job Creation and Economic Benefit

This program will meet the following goals of the Act: preserving and creating jobs and promoting

economic recovery and providing investment needed to increase economic efficiency. The loan is expected to help the business create at least five jobs. This loan is expected to help facilitate a business expansion which will had economic investment and tax base to Beloit's economy.

<u>Full-time or Part-time Jobs Estimated to be Created and Retained by the Activity</u> This activity is expected to create at least five full-time jobs.
