# RESOLUTION APPROVING AN AMENDMENT TO THE 2011 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ACTION PLAN AND BUDGET

**WHEREAS,** the City of Beloit approved a CDBG budget with \$730,000 in new grant funds and \$410,190 in program income for a total budget of \$1,140,190 in 2011 Community Development Block Grant (CDBG) funds, and

**WHEREAS**, the Department of Housing and Urban Development has notified the City of Beloit that the City's estimated grant award will be \$614,916, which is a decrease of \$115,084 from the budgeted amount.

**NOW THEREFORE BE IT RESOLVED**, that the City Council of the City of Beloit, Rock County, Wisconsin hereby approves the amendment to the 2011 CDBG Budget and Action Plan to decrease the CDBG budget as indicated on the attached Exhibit A.

**Date:** July 5, 2011

#### Overview/Background Information:

In November, the City Council approved the 2011 Community Development Block Grant (CDBG) budget. At the time the budget was prepared, staff estimated a 2011 grant amount of \$730,000. We were recently notified by the Department of Housing and Urban Development (HUD) that we will be receiving \$614,916. Therefore, the City must amend its 2011 CDBG budget and action plan to account for this decrease.

#### Key Issues (maximum of 5):

- An Annual Plan was submitted to HUD in November of 2010 that included how the City intended to allocate
  its 2011 CDBG funds, which was approved by HUD. Since then, the City has received notice that its CDBG
  allocation will be approximately \$116,000 less than originally budgeted. This decrease in funding requires a
  revised budget and substantial amendment to the Annual Plan be submitted to HUD.
- All recommended projects are consistent with the 2010-2014 Consolidated Plan and Annual Action Plan because there are no new projects being proposed. The proposed amended budget is attached to this report.
- All recommended projects are eligible CDBG activities and meet one of the three national objectives.
- 4. All projects will be incorporated into the 2011 Annual Action Plan which is submitted to HUD.
- 5. A notice was published in the Beloit Daily News announcing the beginning of the 30-day review period and the date of the public hearing. No comments have been submitted to the Planning Department.

**Topic:** Consideration of a resolution allowing HOME funds to be used for acquisition/rehabilitation/resale activities by

the City of Beloit Housing Services Division

**Date:** July 5, 2011

Presenter(s): Tom Clippert Department: Community Development

#### **Overview/Background Information:**

In July 2001, the City of Beloit, Rock County and City of Janesville formed the Rock County HOME Consortium. This allows us to receive HOME funds directly from the Department of Housing and Urban Development (HUD) similar to CDBG. In prior years, the City has allocated its HOME dollars only to homeowner rehabilitation projects. For 2011, we allocated dollars for both homeowner rehabilitation and rental rehabilitation projects.

#### **Key Issues (maximum of 5):**

- 1. HOME Investment Partnership Program guidelines allow HOME funds to be used for homeowner rehabilitation projects, rental rehabilitation projects, and acquisition-rehabilitation projects. Historically, the City has allocated its HOME dollars to homeowner projects only. For 2011, we added rental rehabilitation projects to our program.
- 2. The City has approximately \$147,000 in HOME Program Income, and these funds are required to be spent before we spend our new grant dollars.
- 3. Staff has requested and CDA was recommended approval of an amendment to the HOME budget to allow \$60,000 to be used for an acquisition-rehab project. We have a property we own on Christilla that was purchased through the tax foreclosure process that we were planning to rehab with City funds. The proposal is to rehab this house with City HOME funds instead.
- 4. There are still funds available to fund both homeowner rehab and rental rehab projects in the City of Beloit.
- 5. This budget amendment requires a 30-day public review. A notice was published in the Beloit Daily News, and we have not received any comments from the public.

1. The meeting was called to order at 7:03 p.m.

#### 2. SPECIAL ORDER OF THE DAY/ANNOUNCEMENTS

- a. Finance and Administrative Services Director Paul York presented the Government Finance Officers Association Distinguished **Budget Presentation Award** to the City of Beloit for the 2011 City of Beloit Budget. Mr. York recognized the members of the Finance Department for their work and commitment to producing a high-quality budget document. Councilor Van De Bogart asked how many cities in Wisconsin received the award, and Mr. York indicated that 22 Wisconsin cities received the award in 2009.
- b. Proclamation recognizing July as Park and Recreation Month was presented by Vice President Van De Bogart to Director of Parks and Leisure Services Brian Ramsey. Mr. Ramsey thanked the Council on the behalf of the Parks, Recreation and Conservation Advisory Committee and the City of Beloit Leisure Services staff. He informed the Council about some of the department's summer programs and the golf course, and he invited the Council to attend the Parks & Recreation Tour on July 13, 2011. File 7148

#### 3. PUBLIC HEARINGS

a. Resolution authorizing an Exception to the Architectural Review and Landscape Code for the property located at 1255 Park Avenue. It was noted that Plan Commission recommended approval 4-0. Community Development Director Julie Christensen reviewed the staff report and recommendation. She said that the property owner planned to remove and replace his entire parking which required compliance with the landscape code and was applying for an exception to waive the open green space requirement and landscape strip requirement. President Leavy opened and closed the public hearing without participation. Councilor Luebke moved to adopt, second by Councilor De Forest. Councilor Newnham asked if the owner had exhausted all opportunities to add landscaping without losing parking spaces. He encouraged staff to always look at alternatives for additional landscaping, and he said that there may have been opportunities for additional landscaping along the alley. He noted that he is passionate about landscaping because he had lost parking at his former restaurant several years ago to accommodate additional landscaping requirements. Ms. Christensen said that the applicant has met the hardship test. Councilor De Forest indicated that any additional landscaping would hinder traffic patterns and that the applicant did address the spirit of the Ordinance by proposing additional landscaping on an adjacent property. President Leavy said that he was comfortable with the staff recommendation. The motion carried 7-0. File 8500

#### 4. CITIZENS' PARTICIPATION

- a. Perry Vernor, 928 Copeland Avenue, spoke about residential street parking in the Merrill Neighborhood, specifically on the 900 and 1000 blocks of Copeland Avenue. He said that currently there are two-hour parking limits and even/odd parking, and he requested that the two-hour parking regulations be removed. He noted that parking regulations near the school are not enforced and that residents tend to park wherever they want. However, he received a ticket for parking on Copeland.
- b. Gary Fields, 13826 Sundance Trail, spoke in favor of the Ordinance removing the requirement to post rental dwelling permits. He thanked Councilor De Forest for attending the Landlord's meeting and encouraged other Councilors to attend the meetings which take place on the 3<sup>rd</sup> Tuesday of the month at 7 pm at Dominico's.

Councilor Luebke left at 7:30 pm.

#### 5. CONSENT AGENDA

Councilor De Forest requested that item c. Intergovernmental Agreement with the School District for Provision of Adult Crossing Guard Services be removed from the Consent Agenda. Councilor Van De Bogart requested that item a. Approval of the Minutes from Joint City Council/Community Development Authority Meeting and Regular Meeting of June 6, 2011 be removed from the Consent Agenda. Councilor Newnham moved to adopt, second by Councilor Haynes, and the motion carried that the Consent agenda be adopted and acted upon as required by state and local codes except items a. and c.

- b. Resolution authorizing the City of Beloit to apply for and enter into a **Grant Agreement** for the Edward Byrne Memorial Local Justice Assistance Grant (JAG) Program FY 2011 and partner with Rock County through a Regional Memorandum of Understanding was adopted. File 7947
- a. Approval of the **Minutes** of the Joint City Council/Community Development Authority Meeting of June 6 and the Regular Meeting of June 6, 2011. Councilor De Forest moved to approve, second by Councilor Spreitzer. The motion carried 5-0-1 with Councilor Van De Bogart abstaining.
- c. Resolution approving an Intergovernmental Agreement with the School District of Beloit for provision of Adult School Crossing Guard Services. Councilor De Forest asked for clarification regarding the cost associated with the intergovernmental agreement. She indicated that the cost to the City had remained the same from 2010 but the number of guards had increased. She asked if the School District would incur the additional costs and if the Police Department would work with the school district regarding where guards might be placed. Police Chief Norm Jacobs said that the City had a limit on the money to support the School District for the program. Chief Jacobs indicated that the School District requested more guards because of the elementary school realignment, and he indicated that the Police Department would provide assistance with location suggestions upon request. Councilor Van De Bogart moved to adopt, second by Councilor Newnham. The motion carried 6-0. File 7749

#### 6. ORDINANCES

- a. Proposed Ordinance to amend Section 31.19 of the Code of General Ordinances of the City of Beloit pertaining to Occupancy Limits for Licensed Premises was given first reading. City Attorney Tom Casper explained the occupancy limit in this section was duplicative and did not serve a useful purpose. Councilor Van De Bogart moved to suspend rules for second reading, second by Councilor Spreitzer. The motion carried 6-0. Councilor De Forest moved to enact, second by Councilor Haynes. The motion carried 6-0. File 5663 Ordinance 3444
- b. Proposed Ordinance to repeal Section 14.06(5) of the Code of General Ordinance of the City of Beloit relating to the **Display of Rental Permits** was given first reading. Ms. Christensen explained that the requirement was no longer necessary because the information was now entered in the new MUNIS software system and easily accessible by City staff. Councilor Van De Bogart moved to suspend rules for second reading, second by Councilor Haynes. The motion carried 6-0. Councilor De Forest moved to enact, second by Councilor Haynes. Councilor De Forest commended City staff for being open to the concerns raised by the Landowners Association. Councilor Haynes reminded the public that this did not remove the requirement to obtain a rental dwelling permit. The motion carried 6-0. File 5130 Ordinance 3445
- c. Proposed Ordinance amending **Terrace Parking Regulations** was given first reading. Public Works Director Dave Botts said that the staff reviewed all of the terrace parking locations in the City and removed the locations where terrace parking was no longer available due to street reconstruction or other changes. Councilor De Forest moved to suspend rules for second reading, second by Councilor Newnham. The motion carried 6-0. Councilor Newnham moved to enact, second by Councilor Haynes. Councilor De Forest asked if all of the property owners of the locations with terrace parking were notified of the changes, and Mr. Botts indicated that they did notify people and that the goal of the Ordinance was not to remove parking, but to update the list so that it was accurate. The motion carried 6-0. File 7791 Ordinance 3446

#### 7. APPOINTMENTS

#### 8. COUNCILOR ACTIVITIES AND UPCOMING EVENTS

- a. Councilor Spreitzer said he had the privilege of participating in the Steve Gregg Memorial Bike Path Dedication, that he has enjoyed the City's trails and bike paths while the weather was nice, and that he enjoyed the meetings with the Janesville and South Beloit City Councils and the Beloit School Board.
- b. Councilor Newnham said that the staff and citizens did a great job on preparing for the All-America City award. He said that it is a great economic development tool, and he hoped the City would reapply for the award next year.
- c. Councilor De Forest acknowledged Parks and Recreation month and encouraged people to come to Big Hill Park. She expressed excitement about the collaborative meetings with the Janesville and South Beloit City Councils and Beloit School Board. She said that it was privilege and an honor to be part of the delegation to the All-America City Awards and thanked all the residents who attended in the delegation.
- d. Councilor Haynes commended everyone who went to the All-America City Awards in Kansas City and said that the spirit shown was amazing. He also said that he felt Beloit belonged with the cities who won.
- e. Councilor Van De Bogart said that he also enjoyed the trip to Kansas City and that everyone did a nice job. He expressed condolences to former Council member Marty Densch on the loss of his wife Colleen and expressed remorse that he could not attend the funeral. He encouraged everyone to take advantage of our wonderful summer time activities, reminded people to be careful around fireworks, and wished everyone a happy Fourth of July.
- f. President Leavy expressed condolences to Marty Densch. He said he rode his bike to the Steve Gregg Memorial Path Dedication and that he appreciated Steve Gregg's family being there. He also said that the City did a wonderful job on the dedication, the park, and the bike trail.

#### 9. CITY MANAGER'S PRESENTATION

a. City Manager Larry Arft presented a report on the City's participation in the All-America City Competition. He said the delegation was very dedicated and represented the City very well. He said the delegation received very positive feedback from the judges and the other delegations. He expressed disappointment that Beloit did not win but added that only 26 cities were selected to participate in the competition, so Beloit was in good company. He indicated that the competition is prestigious and being invited to participate is a great honor. He said that the City does not know if we will send another delegation next year but that it would be discussed in the weeks ahead. He said that it was a great experience and a great opportunity to showcase our food service industries and community pride. Councilor Spreitzer noted that he was thrilled to be a part of the delegation and that they all felt like winners. He said that he had the opportunity to meet a lot of great people from great cities and to showcase what Beloit had to offer. Councilor De Forest thanked Assistant to City Manager Beth Jacobsen and Samantha Timko for the work they did behind the scenes to make the presentation successful. Manager Arft indicated that Ms. Jacobsen was the captain of the delegation and did a wonderful job.

#### 10. REPORTS FROM BOARDS AND CITY OFFICERS

a. Resolution amending the **2011 Capital Improvement Budget** for the purchase of a 500 KW Trailer Mounted Generator for use by Water Resources. Mr. Botts explained the need for the device and how and where it would be used. Councilor Haynes moved to adopt, second by Councilor Newnham. Councilor De Forest asked why this item was not included in the original CIP and if it could be shared between other municipalities. She also questioned the liability of a sewer backup exceeding the cost of the equipment and requested a list of all equipment owned by the other local municipalities. Mr. Botts indicated that it was included in a previous CIP but may have been removed for various reasons. He indicated that, while they would be able to share the equipment, it was not feasible to share in the purchase price for logistical reasons. He said that there may be safety or response time issues with sharing the cost of the equipment. Councilor Van De Bogart asked it the Town of Beloit or the City of South Beloit had a piece of equipment similar to this and if we could purchase a used generator. Mr. Botts responded that he could not say if any other area jurisdictions had this type of equipment, and he described this purchase as an insurance policy. Councilor Spreitzer asked if this could power two lift station facilities, and Mr. Botts responded that it could

but that the City had another smaller generator in the CIP to power the Turtle Creek lift station. Mr. Haynes
asked what would happen if there was a failure, and Mr. Botts said that the other lift station on the west
side would have to be shut down which may create residential sewage backups. Councilor Spreitzer
moved that the Council lay over the item until the next meeting to look at options for a used generator or to
share the equipment with another local jurisdiction. Councilor Newnham seconded, and the motion carried
6-0. File 8463

## AN ORDINANCE TO REPEAL AND RECREATE SECTION 1.13 OF THE CODE OF GENERAL ORDINANCES OF THE CITY OF BELOIT PERTAINING TO CITY ELECTORAL WARD BOUNDARIES AND TO REPEAL AND RECREATE SECTION 1.14 PERTAINING TO POLLING PLACES

**WHEREAS,** the population of the City of Beloit has been determined by the Decennial Federal Census; and

**WHEREAS,** the 2010 federal census has determined the population of the City of Beloit to be 36,966; and

WHEREAS, the Board of Supervisors for Rock County, Wisconsin, did, within 60 days after the population for Rock County became available, adopt and transmit to the City Clerk of the City of Beloit, a Tentative County Supervisory District Plan, which was adopted by the County on May 12, 2011 and received by the City Clerk on May 13, 2011; and

WHEREAS, the Tentative County Supervisory District Plan provides for 29 supervisory districts in Rock County and proposes to assign part of two (2) supervisory districts and all of six (6) supervisory districts to the City of Beloit; and

**WHEREAS,** section 5.15(2)(b)(3) of the Wisconsin Statutes requires that the City of Beloit establish wards which contain not less than 600 nor more than 2,100 inhabitants; and

**WHEREAS,** consideration has been given to census block statistics and the convenience of voters residing in various proposed wards; and

**WHEREAS,** consideration has been given to the legal requirements that wards be kept compact and contiguous and that the boundaries of the wards observe the community of interest of existing neighborhoods; and

**WHEREAS,** consideration has been given to the tentative plan submitted by the Board of Supervisors for Rock County, Wisconsin, pursuant to Section 59.10(3) of the Wisconsin Statutes.

**NOW THEREFORE,** the City Council of the City of Beloit, Rock County, Wisconsin, do ordain as follows:

<u>Section 1.</u> Section 1.13 of the Code of General Ordinances of the City of Beloit is hereby repealed and recreated to read as follows:

**"1.13** <u>CITY ELECTORAL WARD BOUNDARIES.</u> The City of Beloit shall be and hereby is divided into twenty-four (24) wards and eight (8) supervisory districts. Said ward and supervisory district boundaries are shown on a map which is incorporated herein and shall be on file in the Office of the City Clerk and are described herein as follows:

#### Overview/Background Information:

The Clerk served on the 2011 Redistricting Ad Hoc Technical Committee for Rock County. This committee developed a Tentative County Supervisory Map based on the population data from the 2010 Census and the information provided by the Wisconsin County Association in the 2011 County Redistricting Guide. The Committee had 60 days to develop the map from the date the Census data was released. On May 12, 2011, the County Board adopted a tentative Supervisory District Map. The City of Beloit had 60 days from the date of adoption to approve an Ordinance establishing a City Ward Map. After the Ward Map is adopted, the County will have another 60 days to solidify the Supervisory District Map before the State redistricts the Assembly and Senate district lines. This phase of the redistricting process may impact the City's Ward Map and adjustments to the Ward Map may need to be made in the future.

#### Key Issues:

- Municipalities are required to adjust ward boundaries following the decennial federal census to conform to statutorily
  prescribed population ranges and meet other requirements including compactness, contiguity, and community of
  interest.
- Requirements for Constructing Wards:
  - Be comprised of whole census blocks;
  - Suit the convenience of voters;
  - Be comprised of contiguous territory (exception for "island" territory);
  - Take into account the county supervisory district plan;
  - Consider the population and racial and ethnic characteristics;
  - Comply with the population ranges specified by law (between 600 and 2,100 for the City of Beloit);
  - Lie entirely within one municipality and one county; and
  - Reflect the municipal boundaries in place on August 1, 2011.
- Staff constructed 24 wards using the above criteria. Some of the wards have similar boundaries to the current wards; however, the vast majority of both the ward numbers and boundaries have changed.
- o The proposed Ward Map and individual maps of each ward are attached to this report for review. In the Ordinance approving the ward boundaries, the wards are described by census block number. The County and State require the submittal of these numbers as part of the redistricting process.
- While completing the process of redistricting and creating the proposed Ward Map, staff found it necessary to change several of the previous polling places to accommodate voters in the new wards, accommodate the closure of two elementary schools, and showcase a new public facility.

- Currently, there are ten polling places. The proposed plan will reduce this number to nine polling places. One fewer polling place will reduce the number of Election Inspectors needed and will reduce the amount of supplies, materials, and programming packs needed for each election. These reductions will decrease the overall cost of elections slightly. The actual cost savings will would vary by election and by year, but staff has estimated that the reduction of one polling place will save roughly \$6,000 in 2012.
- Desirable characteristics of polling places include the following: convenient location, ADA accessibility, sufficient parking, large meeting room/space, secure location for equipment and material storage, safety of poll workers and voters, low-rent or free to use, and public, quasi-public, or community-service oriented building use.

#### Polling Place Changes:

- Staff held two voluntary workshops with Election Inspectors in May to gather input regarding the tentative
  ward plan and the polling place locations. After holding the workshops and contacting administrators at each
  polling place, staff determined that the following changes are in the best interest of the voters of the City of
  Beloit:
  - Royce, Wright, Merrill, and Morgan schools will no longer be used as polling places.
  - Converse, Gaston, Hackett, McLenegan, First Congregational Church, and Central Christian Church may continue to be used as polling places.
  - Todd School was previously used as a polling place and may be used again.
  - The Beloit Historical Society and the Beloit Public Library may be used as polling places.

#### Public Information

- The Clerk's office, in conjunction with the Government Accountability Board, will ensure that all voters know their new wards and polling places or know where to find that information before the first election in 2012 through a mass postcard mailing to all registered voters.
- The Clerk's office will also publish advertisements in the Beloit Daily News and other local papers and have information available on the City's website.
- The office also expects to field many phone calls prior to the first two Elections in 2012 and will add funds to the 2012 budget for temporary staff to assist in providing information during these times.

Consideration of this request supports Strategic Goal #1, which focuses on enhancing the quality of life for current and future generations.

The vast majority of the polling places are located within walking distance of the wards and voters they serve, which reduces the number of people who have to drive to vote thereby reducing dependence on fossil fuels.




City of Beloit Tentative Ward Map and Polling Places - July 2011








**Topic:** Resolution authorizing the City Manager to enter into a development agreement with NorthStar Medical Radioisotopes,

**Date:** 7/5/11

Presenter(s): Andrew Janke

Department(s): Economic Development

Overview/Background Information: NorthStar Medical Radioisotopes, LLC. (NorthStar) is proposing to develop a production facility in Beloit that utilizes Linear Accelerators to produce isotopes that are used in diagnostic medical imaging. This proprietary technology developed by the company allows for the first domestic production of molybdenum-99 (Moly-99) an isotope used to support 50,000 diagnostic procedures each day in the United States. NorthStar's process utilizes a stable non-radioactive isotope as a source material. Compared to current processes that use uranium, the NorthStar process produces significantly less waste by-products which can be easily handled and disposed of. As there is no reactor or highly radioactive material used in the process, it will be licensed by the Wisconsin DNR. The project involves the construction of an 82,000 square foot production facility on an M-1 zoned site west of Gateway Boulevard and south of Eagles Ridge Drive just north of the Gateway Business Park. The facility will include a 30,000 square foot Laboratory/Office and up to 14 LINAC facilities each containing four Linear Accelerators. A key component to the selection of the site was that Alliant Energy will be constructing a new electrical power sub-station immediately to the north of the site. This will ensure a source of affordable and reliable electrical power. The company will be investing \$194 million into the facility and they hope to break ground by mid-2012 and begin production by 2013. The company plans to create over 150 jobs by 2016. Job positions are mostly highly specialized, filled by scientists and engineers. Other positions being filled are in accounting, customer service, sales, material-handling, and shipping, among others. The State of Wisconsin and the City of Beloit were both involved in offering incentive packages that include:

#### Key Issues (maximum of 5):

- 1. The City has offered a TID #10 financed "Pay As You Go" Direct Developer Incentive. This incentive will be for 35% of NorhtStar's annual increment paid into the TIF District and will be paid out in annual installments over the course of ten years. If the district terminates prior to the tenth payment being made, up to three payments may be made in its final year.
- 2. The City is also offering a TID #10 financed \$50,000 training grant.
- The City will purchase 19.9 acres from Turtle Creek Development and 13 acres from MLG/BRC to create the 33 acre
   Project Site. Purchase price for both properties will not exceed \$900,000. The property will then be conveyed to
   NorthStar for \$1.
- 4. The state has agreed to support the project by establishing the project site as an Enterprise Zone which would support a Wisconsin Income Tax Credit allocation of up to \$14 million dollars.

Conformance to Strategic Plan (List key goals this action would support and briefly discuss its impact on the City's mission.): This business development project clearly supports Goal #2 since it will result in the creation of new jobs and will leverage new private investment.

Sustainability (Briefly comment on the sustainable long term impact of this policy or program related to how it will impact both the built and natural environment utilizing the four following eco-municipality guidelines.):

- Reduce dependence upon fossil fuels
   As Moly-99 is currently not produced in the U.S. therefore being able to source domestically less energy will be required for shipping.
- Reduce dependence on chemicals and other manufacturing substances that accumulate in nature Current production processes for Moly-99 uses uranium as a source material and that is costly and long lasting. NorthStar's technology uses a stable non-radioactive isotope that is easily handled and disposed of.

- Reduce dependence on activities that harm life sustaining eco-systems
   The proposed development will not impact wetlands or sensitive wildlife.
- Meet the hierarchy of present and future human needs fairly and efficiently
  The project achieves this by creating good paying jobs. The project will also be developed in an existing industrial
  park and therefore will not contribute to urban sprawl and no new public infrastructure will need to be extended.

Action required/Recommendation: Staff recommends approval of the resolution.

Fiscal Note/Budget Impact: The project will add increment to TID # 10 which is already cash flowing positively.

#### <u>DEVELOPMENT AGREEMENT</u> NORTHSTAR MEDICAL RADIOISOTOPES, LLC

#### **RECITALS**

WHEREAS, NorthStar desires to construct and operate a linear particle accelerator in the City (the "LINAC Facility"); and

WHEREAS, NorthStar has explored several alternative locations and found a site in the City suitable for NorthStar's construction and operation of the LINAC Facility; and

WHEREAS, the proposed LINAC Site is located in the City's Tax Incremental District No. 10 (the "<u>District</u>"); and

WHEREAS, the City and the State of Wisconsin wish to encourage and incentivize NorthStar to locate the LINAC Facility in the City; and

WHEREAS, NorthStar is willing to commit to construction of the LINAC Facility within the City upon the terms and conditions set forth in this Agreement; and

WHEREAS, the City established the District to promote development in the City and the District by making certain grants, paying development incentives, and incurring project costs; and

WHEREAS, as an inducement to NorthStar to develop the LINAC Facility within the District, in order to make the LINAC Facility financially feasible and in order to implement the District's project plan, the City finds it appropriate to provide the development incentives set out in this Agreement.

NOW, THEREFORE, the City and NorthStar agree as follows:

#### 1. ACQUISITION OF LINAC SITE; CONVEYANCE OF LINAC SITE TO NORTHSTAR.

- (a) The City and NorthStar have identified two (2) contiguous parcels of land, which together are suitable for the construction of the LINAC Facility. The first parcel is owned by Turtle Creek, LLC and consists of approximately 19.9 acres, as described on <a href="Exhibit A-1"><u>Exhibit A-1</u></a> (the "<u>Turtle Creek Land</u>"), and the second parcel is owned by MLG/BRC Beloit LLC and consists of approximately 13 acres, as described on <a href="Exhibit A-2"><u>Exhibit A-2</u></a> (the "<u>MLG/BRC</u> Land"). The City intends to enter into one or more option agreements or purchase contracts to acquire the Turtle Creek Land and the MLG/BRC Land (the "<u>Acquisition Agreement(s)</u>").
  - (b) Upon acquisition of the Turtle Creek Land and the MCG/BRC Land, the City shall, at its sole cost and expense, create one, single legal lot by filing and recording of a certified survey map ("CSM"), comprised of the Turtle Creek Land and the MCG/BRC Land, which combined parcel shall hereinafter be referred to as the "LINAC Site." The final CSM shall be subject to NorthStar's review and approval, which approval shall not be unreasonably withheld, conditioned or delayed. It is expected that the LINAC Site will consist of approximately thirty-three (33) acres, including approximately two (2) acres of preserved wetlands and one (1) acre along the southern boundary preserved for future road right-of-way. In the event said one-acre area is ever dedicated as a public right-of-way, there

shall be no costs assessed or charged to NorthStar for any such dedication or construction, and all costs associated therewith shall be the sole obligation of the City.

- (c) The parties' obligations under this Agreement shall be subject to the City's acquisition of the Turtle Creek Land and the MLG/BRC Land for an aggregate purchase price not in excess of Nine Hundred Thousand Dollars (\$900,000). In the event the City fails to enter into the Acquisition Agreements for the Turtle Creek Land and the MLG/BRC Land on or before the date which is ninety (90) days from the date of this Agreement (the "Acquisition Date"), this Agreement shall terminate and the parties shall have no further rights or obligations, unless NorthStar shall agree, in writing, to extend the Acquisition Date. Notwithstanding the foregoing, the City shall use best efforts to acquire the Turtle Creek Land and the MLG/BRC Land as contemplated herein.
- Land and subsequent creation of the LINAC Site, the City shall sell the LINAC Site to NorthStar for the sum of One Dollar (\$1.00) and other good valuable consideration, including the obligations of NorthStar set forth in this Agreement, pursuant to the terms of the Commercial Offer to Purchase attached hereto as <a href="Exhibit B">Exhibit B</a> (the "Offer"). Such conveyance shall be evidenced by a general warranty deed, subject only to municipal and zoning ordinances and agreements entered under them, recorded easements for the distribution of utility and municipal services, recorded building and use restrictions and covenants, together with the road right-of-way preservation area described herein. The sale of the LINAC Site from the City to NorthStar shall occur within five (5) business days of the last to occur of (i) NorthStar's receipt of all required permits and approvals from any governmental or regulatory authority, agency or body with jurisdiction over the LINAC Facility and/or the LINAC Site; (ii) completion of any required Federal, state or local review processes with respect to the LINAC Facility and/or the LINAC Site; and (iii) the expiration of any appeal

periods respect to (i) or (ii). The date by which (i), (ii) and (iii) are satisfied is hereinafter referred to as "Completion of the Approval Process." Notwithstanding the foregoing, NorthStar shall have no obligation to commence efforts to secure the permits or approvals or complete the permitting or review processes contemplated by (i) and (ii) respectively, until the City has delivered to NorthStar fully executed copies of the Acquisition Agreement(s).

- (e) Notwithstanding any provision herein to the contrary, NorthStar shall have the right to transfer or convey the LINAC Site to a wholly-owned limited liability company, provided NorthStar causes such wholly-owned subsidiary to agree in writing to observe all of the obligations of NorthStar set forth herein with respect to the LINAC Site.
- 2. CONSTRUCTION OF LINAC FACILITY. Subject to the conditions set forth herein, NorthStar shall construct the LINAC Facility on the LINAC Site. The LINAC Facility shall be constructed as generally shown on the site plan attached hereto as <a href="Exhibit C">Exhibit C</a>, subject to any changes or alterations (i) required by any governmental or regulatory authority, agency or body with jurisdiction over the LINAC Facility and/or the LINAC Site, or (ii) deemed reasonably necessary or advisable by NorthStar in furtherance of its operation of the LINAC Facility. It is expected that when fully built, the LINAC Facility will consist of approximately Eighty-Two Thousand (82,000) square feet of space. It is expected that the estimated cost to construct the LINAC Facility, together with all associated machinery and equipment to be located therein, will be approximately One Hundred Ninety-Four Million Dollars (\$194,000,000).
- 3. CONSTRUCTION TIMETABLE. If and when NorthStar purchases the LINAC Site from the City, NorthStar shall commence construction of the LINAC Facility, which the parties anticipate will be no later than June 30, 2012, and continue in accordance with the construction schedule attached hereto as <a href="Exhibit D">Exhibit D</a> (the "Projected Construction Schedule"), which Projected Construction Schedule shall be revised and updated by the written consent of both parties hereto

from time to time. The parties hereto anticipate that the LINAC Facility will be completed by December 31, 2016.

- 4. SITE PLAN REVIEW AND BUILDING PERMITS. NorthStar agrees to submit its building and site plans for the LINAC Facility to the City for review and approval in accordance with the City's zoning, building and architectural review ordinances. NorthStar shall use due diligence in its preparation of and pursuit of all necessary governmental permits and reviews.
- **5. ZONING.** The City represents that the Turtle Creek Land and the MLG/BRC Land is currently zoned M-1, general manufacturing district, and that upon creation of the LINAC Site, that no zoning changes are needed to permit construction or operation of the proposed LINAC Facility on the LINAC Site.

**6.PRECLOSING ACCESS.** The City acknowledges and agrees with NorthStar's need to have preclosing access to the LINAC Site (or, if prior to the creation of the LINAC Site, Turtle Creek Land and/or the MLG/BRC Land). The City agrees to use good faith efforts in negotiating the Acquisition Agreements referred to in Paragraph 1(a) herein so as to include authority for NorthStar and its authorized representatives to enter onto the Turtle Creek Land and the MLG/BRC Land prior to the closing and to do each of the following:

- (a) conduct any soil surveys, soil borings or other testing necessary to satisfy NorthStar that the Turtle Creek Land and the MLG/BRC Land is physically suitable for the construction of the LINAC Facility; and
- (b) conduct any environmental investigation or testing necessary to satisfy NorthStar that the Turtle Creek Land and the MLG/BRC Land is environmentally suitable for the construction of the LINAC Facility.

If NorthStar fails to close on the Turtle Creek Land and the MLG/BRC Land for any reason, NorthStar will restore the Turtle Creek Land and the MLG/BRC Land to its original condition.

NorthStar agrees to use reasonable efforts to minimize disturbance of the land and damages to crops growing thereon and shall be financially responsible for any crop damage or any other damages that are not capable of restoration. NorthStar agrees that in consideration of the preclosing access to the Turtle Creek Land and the MLG/BRC Land, NorthStar will indemnify and hold the City harmless from any liability arising out of the acts or omissions of NorthStar, its officers, managers, members, employees or agents while occupying, entering or leaving the Turtle Creek Land or the MLG/BRC Land.

#### 7. DIRECT DEVELOPER INCENTIVE PAYMENTS.

(a) The LINAC Site will be located in Tax Incremental Financing District (TID) #10 in the City of Beloit, which was established on January 1, 2001, and the boundaries of which were amended on the September 12, 2005 (the "District"). In consideration of and as an inducement to NorthStar's development of the LINAC Facility in the District, together with the benefits, including an increased tax base, which will accrue to the City, the City shall make a series of Direct Developer Incentive Payments (each a "DDI Payment") to NorthStar as provided herein. The first annual DDI Payment shall be made on September 1 of the year following the first tax year during which the LINAC Facility is assessed, and thereafter on September 1 of each of the next nine (9) consecutive years. For purposes of this Paragraph 7, the term "Available Tax Increment" shall mean thirty-five percent (35%) of the amount of real and personal property tax increment actually paid by NorthStar, or any successor or assign under this Agreement, and received by the City (as defined in Section 66.1105 Stats.) and generated solely by the development of the LINAC Facility above the Property Tax Increment Base during a calendar year. For purposes of this Agreement, the term "Property Tax Increment Base" means the aggregate value, as equalized by the Wisconsin Department of Revenue, of the LINAC Site and any personal property thereon as of September 12, 2005.

- (b) The City's obligations to make DDI Payments shall not be payable from or constitute a charge upon any funds of the City, and the City shall not be subject to any liability or be deemed to have obligated itself to pay the DDI Payments from any funds except the Available Tax Increment, and then only to the extent and in the manner herein specified.
- (c) If no Available Tax Increment is available during any year in which a DDI Payment is otherwise payable, the City shall have no obligation to pay any DDI Payment for that year under this Agreement. Such failure shall not constitute a default under this Agreement. For any year during which there is no Available Tax Increment, an additional year will be added to the total number of years for which NorthStar is eligible for DDI Payments; provided, however, this shall not extend the obligation of the City beyond the provisions of Paragraph 7(d) herein. Except as provided below, the City shall have no obligation to subsequently pay any such deficiency unless the deficiency is the direct result of the failure of the County to timely remit the proper amount of Available Tax Increment, in which case, such deficiency shall be paid promptly upon remittance by the County. If on any payment date there is insufficient Available Tax Increment to make the scheduled payment due on such date, the amount of such deficiency in the scheduled payment shall be deferred and shall be paid on the next payment date on which the City has tax increment in excess of the amount necessary to make the scheduled payment due on such payment date, provided sufficient tax increment is available and exists. Notwithstanding anything to the contrary set forth in this Agreement, interest shall not compound on any deferred payments or otherwise.
- (d) The City represents and warrants that the District terminates on October 16, 2023 (the "District Termination Date"). To the extent that DDI Payments, as provided for herein, remain due and payable following the District Termination Date, the City shall pay a multi-year final payment at the time the last DDI Payment is made prior to the District Termination Date. The multi-year final payment shall be in an amount equal to the number of

years DDI Payments would otherwise continue to be payable but for the District Termination Date, and shall also include the last payment due prior to the District Termination Date. Each DDI Payment included in the multi-year final payment shall be equal to the last DDI payment made prior to the District Termination Date. In no case shall the multi-year final payment include more than two years of DDI Payments (not including the last payment due or made prior to the District Termination Date).

- (e) The City's obligation to pay the annual DDI Payments as contemplated hereunder is conditioned upon continued production of medical radioisotopes and related products from the LINAC Facility, subject to normal interruptions to which production facilities are subject, including, without limitation, retooling, equipment upgrades and the like.
  - (f) DDI Payments attributable to personal property shall be based solely upon personal property actually located at the LINAC Facility.
  - (g) The DDI Payments shall not be deemed a "rebate" of real or personal property taxes, but rather the use of such taxes paid being a reasonable measure for the reimbursement of certain project costs incurred by NorthStar in connection with the development of the LINAC Facility.

#### 8. OTHER INCENTIVES.

- (a) Enterprise Zone Tax Credits. A written commitment has been issued by the State of Wisconsin to grant to NorthStar enterprise zone tax credits in the amount of \$14 Million (\$14,000,000), specifying certain conditions precedent to the disbursement of the tax credits. A copy of that commitment is attached hereto marked Exhibit E.
- (b) <u>Designation as Enterprise Zone</u>. The City will assist NorthStar in obtaining an Enterprise Zone ("<u>EZ</u>") designation for the LINAC Site from the State of Wisconsin Department of Commerce.

- (c) <u>Training Grant</u>. The City shall provide a grant in the amount of \$50,000 to be used by NorthStar for training new employees during the start-up period. Said grant shall be payable within sixty (60) days of initial occupancy.
- 9. JOB CREATION AND RETENTION. NorthStar agrees to create and fill at least one hundred fifty-one (151) new full-time positions (the "Minimum LINAC Positions") at the LINAC Facility on or before December 31, 2016. If NorthStar fails to create and/or maintains less than the Minimum LINAC Positions, each DDI Payment due during such period of non-compliance shall be reduced by an amount equal to the percentage difference between the Minimum LINAC Positions and the then-current number of actual jobs created and/or maintained at the LINAC Facility. This formula will be used to recalculate a DDI payment in any and all years the number of jobs maintained at the LINAC Facility falls below the Minimum LINAC Positions. For purposes of this Agreement, a "full-time" position means a regular full-time position for which the employee is required, as a condition of employment, to work at least forty (40) hours per week and two thousand eighty (2,080) hours per year, less time off for holidays, paid vacations and other leave approved by NorthStar.
- 10. INVESTMENT IN GREATER BELOIT ECONOMIC DEVELOPMENT CORPORATION ("GBEDC"). NorthStar agrees that in further consideration of the DDI payments contemplated in Paragraph 7(e) above, upon execution of this Agreement and until such time as all DDI payments have been made, NorthStar shall become an investor in GBEDC. As an investor, NorthStar shall pay annual investment dues to GBEDC in accordance with the annual dues schedule to which all investors in GBEDC are subject. Said dues are set on an annual calendar year basis. For the first year of this Agreement, NorthStar shall pay a prorated amount reflecting the number of months from the month of execution through December. Such prorated payment shall be due within 30 days of execution of this Agreement.

- 11. RECORDABLE DOCUMENT. A memorandum of this Agreement may be recorded with the Register of Deeds for Rock County, Wisconsin.
- 12. REPRESENTATIONS AND WARRANTIES OF NORTHSTAR. As of the date of this Agreement, NorthStar hereby represents and warrants to the City that:
  - (a) NorthStar is a limited liability company duly organized and existing under the laws of the State of Wisconsin.
  - (b) The execution and delivery of this Agreement and the consummation of the transactions contemplated hereby have been duly authorized by NorthStar's Board of Managers. No other proceedings on the part of NorthStar are necessary to authorize this Agreement or the transactions contemplated hereby.
  - (c) Neither the execution and delivery of this Agreement by NorthStar, nor the consummation of the transactions contemplated by this Agreement will violate any provision of NorthStar's Articles of Organization, Third Amended and Restated Operating Agreement, as amended, contractual obligations with others, or any applicable local, state or federal law.
- 13. REPRESENTATIONS AND WARRANTIES OF THE CITY. As of the date of this Agreement, the City hereby represents and warrants to NorthStar that:
  - (a) The execution and delivery of this Agreement and the consummation of the transactions contemplated hereby have been duly authorized by the City Council. No other proceedings on the part of the City are necessary to authorize this Agreement or the transactions contemplated hereby.
  - (b) Neither the execution and delivery of this Agreement by the City, nor the consummation of the transactions contemplated by this Agreement will violate any provision of the City's municipal charter, bylaws, contractual obligations with others, or any applicable local, state or federal law.

#### 14. COVENANTS OF NORTHSTAR.

- (a) NorthStar shall provide the City with satisfactory evidence that the person(s) executing this Agreement on behalf of NorthStar is properly authorized to do so.
- (b) NorthStar shall execute and deliver any documents reasonably required by the title insurance provider, including, but not limited to, resolutions or evidence of authority as may be required by the title insurance provider to issue a title policy with respect to the LINAC Site, showing title in the LINAC Site in the name of the "purchaser" identified in the Offer, provided that the title insurance provider has entered into a confidentiality agreement in a form reasonably acceptable to such "purchaser."
- (c) NorthStar shall pay when due all Federal, state and local taxes with respect to the LINAC Site and/or LINAC Facility; provided, NorthStar shall be required to pay such amounts with respect to the LINAC Site only after it has taken title to the same. Notwithstanding the foregoing, nothing in this Paragraph 14(c) shall restrict the right of NorthStar to challenge any tax or assessment.
- (d) During the term of this Agreement, NorthStar shall maintain insurance in such amounts and against such risks both generally and specifically with respect to the LINAC Site, as are customarily insured against in developments of like size, kind and character, including customary builders risk or equivalent insurance during construction and customary casualty, property and liability insurance. NorthStar shall provide the City satisfactory evidence of all such insurance. So long as this Agreement is in effect, in the event of damage to the LINAC Facility as a result of fire or other casualty, NorthStar shall use all insurance proceeds with respect to such casualty to repair the LINAC Facility to the same condition, as nearly as possible, as existed immediately prior to such casualty. Any proceeds of insurance remaining after NorthStar has repaired the LINAC Facility as contemplated herein shall be subject to no further limitations. Notwithstanding any provision herein to the contrary, the City shall have no interest or claim to any portion of the proceeds

of any insurance carried by NorthStar on the LINAC Facility or NorthStar's fixtures, equipment or personal property.

- 15. PROOF OF APPROVAL OF AGREEMENT. Each of the parties shall provide the other with a certified copy of a resolution of their governing body authorizing the entry into this Agreement and authorizing the persons designated as signatories below to execute this Agreement.
- AFFIRMATIVE ACTION. NorthStar has adopted or promptly following this Agreement will adopt an affirmative action plan to increase in its partners, associates, and employees members of under-represented groups in all of its departments, job classifications, and salary categories. In the event that NorthStar subcontracts any portion of this Agreement, NorthStar will include, in its subcontracts, a requirement that its subcontractors adopt or agree to adopt an affirmative action plan. NorthStar will also include a requirement that its subcontractors include a similar requirement in their contracts with their subcontractors. This provision is inserted herein in compliance with Section 1.09 of the Code of General Ordinances of the City of Beloit, and shall be interpreted so as to carry out the intent of that ordinance.
- 17. NONDISCRIMINATION. NorthStar will not discriminate against any qualified employee or qualified applicant for employment because of race, color, national origin, ancestry, religion, age, marital status, disability, sex, or sexual orientation. In the event any portion of this Agreement is subcontracted by NorthStar, NorthStar shall include in such subcontract a provision prohibiting the subcontractor from discriminating against any qualified employee or qualified applicant for employment because of race, color, national origin, ancestry, religion, age, marital status, disability, sex, or sexual orientation. This provision is inserted herein in compliance with Section 1.09 of the Code of General Ordinances of the City of Beloit, and shall be interpreted so as to carry out the intent of said ordinance.

- 18. APPLICABLE LAW AND JURISDICTION. This Agreement shall be governed by and construed in accordance with the laws of the State of Wisconsin, and the parties agree that the Rock County Circuit Court shall have jurisdiction to handle any litigation between the parties.
- 19. SEVERABILITY. If any provision of this Agreement is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions of this Agreement shall be valid and enforceable to the fullest extent permitted by law. In any case, any invalid or unenforceable provision shall be replaced by the City and NorthStar with a valid provision which most closely approximates the intent and economic effect of the invalid or unenforceable provision.
- **20. ENTIRE AGREEMENT.** This Agreement, together with the Exhibits attached hereto, contain the entire agreement of the parties regarding this project. All prior negotiations and discussions have been merged into this Agreement and/or the Exhibits attached hereto.
- **21. AMENDMENTS.** No amendment to this Agreement shall be binding upon any party hereto until such amendment is reduced to writing and executed by the parties.
- **22. AUTHORITY.** Each person signing this Agreement represents that he or she is authorized by his or her organization to execute this Agreement on behalf of that organization or entity.
- 23. FORCE MAJEURE. No party shall be responsible to the other party for any losses if the fulfillment of any term of this Agreement is delayed or prevented by civil disorders, wars, strikes, floods, fires, acts of God, or by any other cause not within the control of the party whose performance was interfered with and which, by the exercise of reasonable diligence, such party is unable to prevent, whether or not of the class of causes enumerated above, and the time for performance shall be extended for the period of delay occasioned by any such cause.
- **24. ASSIGNMENT AND TRANSFER.** NorthStar may not assign its interest in this Agreement to a third party without the prior written consent of the City. Notwithstanding the foregoing, NorthStar shall have the right to assign this Agreement and its rights and obligations

hereunder, in whole or in part, (a) to any subsidiary or parent of an entity under common control with NorthStar (each an "Affiliate"); or (b) in connection with any sale of all or substantially all of the assets, or change of control, of NorthStar or any Affiliate, whether direct or indirect, by merger or otherwise; provided that the City is promptly notified and provided a copy of all appropriate documentation, and that such assignee, transferee or successor agrees in writing, satisfactory to the City, to perform the obligations of NorthStar and/or such Affiliate arising under this Agreement. In addition NorthStar may sell, transfer or convey the LINAC Site to a third party without restriction at any time after the Completion of the Approval Process; provided such third party (a) executes an agreement approved by the City, with said approval not to be unreasonably withheld, wherein such third party assumes all obligations of NorthStar hereunder, including, without limitation, those set forth in Paragraph 6 and Paragraph 7; and (b) such third party has sufficient financial wherewithal to fulfill the obligations of NorthStar hereunder, in the reasonable opinion of the City. For the avoidance of doubt, upon execution and delivery of such Agreement to the City, as contemplated by the two preceding sentences, and in the case of the preceding sentence, a positive determination as to the financial wherewithal of such third party, the City shall perform all of its obligations set forth herein, including, without limitation, payment of any remaining DDI payments. The City hereby acknowledges and agrees that NorthStar has the right to make a collateral assignment of this entire Agreement to a lender as part of NorthStar's first mortgage loan on the LINAC Facility; provided, however, (i) NorthStar must first give notice to the City together with a copy of the proposed collateral assignment, and the City shall have five (5) business days to review the same; and (ii) the collateral assignment does not and does not attempt to amend, modify, add to, or supplement any provisions of this Agreement.

#### 25. INDEMNIFICATION.

(a) Each party hereby agrees to defend and hold the other parties, their officers, agents and employees harmless from any liability for any claims, including attorney's fees,

arising out of its negligent acts or omissions or the negligent acts or omissions of its officers, agents and employees.

- (b) NorthStar further agrees to defend, indemnify and hold the City, its governing body members, officers, agents, including the independent contractors, consultants and legal counsel, servants and employees thereof (hereinafter, for purposes of this Paragraph, collectively the "Indemnified Parties") harmless, except to the extent caused by any negligence, willful misrepresentation or willful misconduct of the Indemnified Parties from any claim, demand, suit, action or other proceeding whatsoever by any person or entity whatsoever arising or purportedly arising from the actions or inactions of NorthStar (or other persons acting on its behalf or under its direction or control) under this Agreement, or the transactions contemplated hereby or the acquisition, construction, installation, ownership, maintenance and operation of the LINAC Facility.
- 26. NO PARTNERSHIP CREATED. This Agreement does not create any partnership or joint venture between the parties hereto, or render any party liable for any of the debts or obligations of the other party. The City shall have no obligation or liability to any lending institution, architect, contractor, subcontractor, or other party retained by NorthStar to assist NorthStar in the performance of its obligations under the terms and conditions of this Agreement. NorthStar specifically agrees that no representation shall be made to any third party that NorthStar and the City are partners or joint venturers.
- **27. HEADINGS.** The headings set forth in this Agreement are for convenience and reference only and do not define or limit the scope or content of this Agreement or affect any of its provisions.
- **28. DEFAULT AND NOTICE OF DEFAULT.** Any party seeking to enforce its rights hereunder may do so only after giving advance written notice to the other party reasonably identifying the alleged breach and giving the breaching party sixty (60) days in which to cure the

alleged breach. In the event that any party institutes an action to enforce its rights hereunder, the prevailing party in such action shall be entitled to recover all costs, including reasonable attorney's and professional fees which may have been incurred in bringing such action. In the event of a material breach by either party, the non-breaching party retains as an available remedy, the remedy of rescission of this Agreement.

**29. NOTICES.** Notices to the parties to this Agreement shall be as follows:

#### Overview/Background Information:

This project will construct a decorative industrial art structure, a raised stage, decorative multi-colored lighting accents, a sloped lawn area, landscaped planters, and decorative benches, trash and recycling receptacles, and brick inlays.

#### Key Issues (maximum of 5):

- 1. Three (3) bids were received for this project. The low bid of \$ 287,169.50 was from Gilbank Construction, Inc. and is 6.9% less than the engineer's estimate of \$ 306,958.50.
- 2. Unused contingency funds from C11-03 State Street Reconstruction are available for use on this project.
- 3. A private donation of \$40,000 from the Fat Wallet Charitable Foundation via the Stateline Community Foundation is being offered to the City to help pay for the Gantry Plaza stage feature.
- 4. The costs for this project along with the costs for C11-03 State Street Reconstruction are within the total established budget for these projects.
- 5. The Downtown Beloit Association supports awarding this project, as shown in the letter from the DBA to the City Council dated June 23, 2011.

Pursuant to advertisements placed June 7 & 14, 2011, bids were received until 11:30 a.m. on June 22nd, 2011 for C11-24 Gantry and Plaza. A summary and tabulation of bids is attached.

Three (3) bids were received for this project as follows:

#### PROJECT INFORMATION

This project will construct a decorative industrial art structure, a raised stage, decorative multi-colored lighting accents, a sloped lawn area, landscaped planters, and decorative benches, trash and recycling receptacles, and brick inlays.

This project was previously bid, and all bids were rejected by the City Council on April 18, 2011. The low bid for the previous solicitation was \$316,516.40. The City Council directed Engineering to perform a Value Engineering analysis on the project to identify potential cost reductions and re-bid the project. The result of the Value Engineering is a reduction in cost of \$29,346.90, or 9.3%.

The project was re-bid with a base bid and two alternate bids. The base bid is for the Gantry structure itself, the multi-colored decorative lighting, the landscaped planters, irrigation, a two coat paint system with an estimated lifespan of 15-20 years, and sidewalk restoration. The Gantry Painting alternate is for a third coat of paint that will add approximately 10-15 additional years to the lifespan of the paint on the structure, increasing it to 25-35 years. The Plaza alternate will add the stage feature, the brick inlay, the Plaza around the stage, the decorative benches, and the sloped lawn area, which will complete all of items included in the original scope of the project as envisioned by the DBA design team. Awarding the Plaza

alternate is also a requirement to receive a grant from the Fat Wallet Foundation in the amount of \$40,000.

Upon review of the Contractor's Proof of Responsibility Statement, Gilbank Construction, Inc. is determined to be a responsible bidder.

I recommend that Gilbank Construction be awarded the project, including all alternates. The following is a breakdown of the proposed project cost:

This was done to allow the street reconstruction to be completed prior to the beginning of the Farmer's Market in June, while the Gantry design continued in the meantime. Adequate funding is already available for this project, so no budget amendment is required to expend additional funds. A financial summary of the complete project is shown below.
