PRAIRIE AVENUE RECONSTRUCTION PROJECT

At the time the new Inman Bypass is built, the Department of Transportation, working in conjunction with local jurisdictions, will also be reconstructing Prairie Avenue from Hwy. 11 in Janesville, south to Huebbe Parkway in Beloit. Local officials and residents were given a first look at a set of plans during a public meeting held this past Wednesday. Although we were somewhat disappointed to see a two-lane cross section, which is the same carrying capacity which currently exists along the roadway, there were many projected improvements. The bi-directional lane down the middle of the urban portion of the roadway will certainly improve turning movements and minimize traffic backups. There are also numerous intersection improvements throughout the corridor. Signalization will occur where warranted. The State Department of Transportation is accelerating the schedule for this work in order to have these alternative routes completed prior to the beginning of construction on the Interstate 39/90 project, which is scheduled to begin in 2015.

CITY FINALIZES PLANS FOR IMPLEMENTATION OF THE BACKYARD CHICKEN ORDINANCE

Please find <u>attached</u> the notice announcing a joint training session sponsored by the Beloit Backyard Chicken Group and the City's Community Development Department. The session is entitled "So You're Thinking about Getting Chickens" and the session has been scheduled for **Saturday**, **December 15 at 10:00 a.m. in the Beloit Public Library Community Room**.

Also, please note on the City's website that there is a permit application and a FAQ's brochure which describes in detail the Backyard Chicken regulations, under the "Forms" section and "Neighborhood Planning." The City will begin taking applications on Wednesday, January 2, 2013 at 8:00 a.m.

NEW DOG PARK OPEN FOR PUBLIC USE

Please find <u>attached</u> a press release announcing that the new dog park recently constructed adjacent to Leeson Park is now open for public use. The release provides more details, including the designated rules that have been established for dog park use.

Please note under the section entitled "Dog Park Users Fees and/or Dog ID Pass" that residents who wish to use the park can purchase an annual pass in conjunction with your required dog license. The passes are deeply discounted, will fasten on the dog's collar, and permit unlimited use throughout the calendar year. Without the pass, there will be a daily fee charged for each visit.

The park will be open for the balance of December without charge, so that residents will have an opportunity to use the facility and determine whether or not you wish to incorporate the park into your pet's exercise routine. Please note that the park is available for use by dogs only.

HO CHUNK NATION CASINO APPLICATION UNDER REVIEW

The Bureau of Indian Affairs recently announced a public scoping meeting on **Thursday, December 13, 2012** from 6:00 p.m. until the last public comments are received. The meeting will be held at Aldrich Middle School, 1859 Northgate Drive, Beloit, WI in the auditorium. Additional information about the meeting can be found on the <u>attached</u> formal notice.

The primary purpose for this meeting is to determine the scope and scale of work needed to complete the Environmental Impact Statement prior to the Nation's fee to trust application to set aside land for development of the Beloit casino project. Interested parties are invited to attend. The Agency will also be receiving written comments regarding possible subjects for study during the Environmental Impact Assessment process.

This is but one step in a fairly lengthy and complex application process. There is still no definitive timeline on when the Bureau and its parent agency, the US Department of the Interior, will make a final decision regarding this project.

SNAPPERS UPDATE

The Snappers lease agreement for Pohlman Field is up for renewal this year. Staff, working in conjunction with the City Attorney's office, has reviewed the existing document and is proposing a number of relatively minor changes to ensure that the language remains relevant to current operations. Mr. Ramsey, the Director of Parks and Leisure Services, will be meeting with the Snappers and we hope to have a draft on the City Council agenda for the December 17 meeting.

Work on the Pohlman Field improvements is also proceeding. Engineering staff is working on plans and specifications for replacement of the pedestrian concourses and the Parks maintenance crews are working on some of the smaller scale internal maintenance needs within the facility. Once again, we hope to have these maintenance related improvements completed prior to the arrival of the Class A affiliate of the Oakland Athletics in early April.

UPDATE ON I-39/90 WIDENING—43 INTERCHANGE RECONSTRUCTION

Planning is still proceeding with regard to the planned improvements to the interstate highways, including reconstruction of the Interstate 43 interchange at 39/90. Additional "value" engineering has been completed

and the DOT is studying additional alignment options for how this interchange could best be reconstructed. City Engineering staff is also reviewing the alignment options.

As previously noted, we hope to have revised alignment options, along with detailed traffic counts available for a series of stakeholder meetings which will be held early next year. The State Department of Transportation and the Federal Highway Administration are open to comments and suggestions regarding the final alignment decision and will incorporate those comments into the final planning process. Dates and times for those meetings will be announced well in advance.

BOUNDARY AREA ADJUSTMENT AGREEMENT WITH TOWN OF TURTLE

We are working on various issues related to upcoming negotiations between the City and the Town of Turtle related to developing a new, long-term Boundary Area Agreement. Much has been done in terms of preliminary planning for our first meeting; however, we are not quite ready to schedule that session. The hope is still to get one meeting in before the holidays; however, if that does not fit the busy holiday season schedule, we will be meeting immediately after the beginning of the New Year. It is anticipated that there will be a number of significant and some difficult issues that will need to be resolved as part of the Boundary Area Agreement renegotiation, so that this process will likely require an extended time frame to reach a successful conclusion.

COMPENSATION STUDY/NEW SALARY PLAN FOR NON-REPRESENTED EMPLOYEES

Earlier this fall, Council authorized the employment of a consultant to assist the City with doing a compensation study and preparing a new pay plan for the City's non-represented employees, which now include a large number of former AFSCME Union members. Work on that process is well advanced and the HR Director has been working closely with the consultant to begin finalizing the proposed pay schedule. Extensive comparative data has been assembled and also job content questionnaires completed by employees to assist the consultant in placing employees within the appropriate salary range. Although we found a few positions that were substantially under compensated and a couple that were significantly over the comparables, fortunately, most of the positions fall within a reasonable range of the mid-point; either at, slightly above or slightly below but within a range that the consultant felt was acceptable. In order to provide the time necessary for the consultant to complete her task and to make sure we provide adequate time to present the proposal to various stakeholders for input, this item will likely not go to Council until sometime in late January or very early February. As soon as the internal review process is completed, a Council workshop will be scheduled and the consultant will make a formal presentation, as well as answer questions. While we are running a little behind the schedule we set last fall, we would much prefer to take the extra time to ensure the accuracy and validity of this new pay plan as opposed to rushing forward to meet an arbitrary schedule.



October 16, 2012 – Beloit, WI: Any City of Beloit resident interested in running for a two-year term on the Beloit City Council may pick up a packet of information including nomination papers beginning Monday, October 29, 2012. The packets are available in the office of the City Clerk on the second floor of City Hall during normal business hours: Monday through Friday, 8:00 a.m. to 5:00 p.m.

- There are seven members on the Council and three seats will be on the ballot.
- Candidates must file required forms with the City Clerk before forming a committee and raising funds.
- The first day to circulate nomination papers is Saturday, December 1, 2012.
- Between 200 and 400 valid signatures of City of Beloit residents must be submitted.
- Nomination papers and all forms must be completed and filed with the City Clerk by 5:00 p.m. on **Wednesday**, **January 2**, **2013**.
- An informational session will be held in January for all candidates who have gained ballot access.
- The Spring Election will be held on Tuesday, April 2, 2013.
- Newly-elected Councilors will take office on Tuesday, April 16, 2013.

Opening New Dog Park

December 5, 2012 – Beloit, WI: On Friday, December 7, 2012, the City of Beloit Parks & Leisure Services Division will officially open their new Dog Park.

This new facility is located at the northwest intersection of Springbrook Court and Willowbrook Road in Beloit, in the detention basin area of Springbrook Creek. Access to the Dog Park is available through Leeson Park located at Milwaukee Road and Leeson Drive. A walking trail along Springbrook Creek at the east end of Leeson Park leads to the Dog Park entrance. Users of the Dog Park should park in the designated area in Leeson Park and walk their dog(s) onleash to the Dog Park, and only release their dog off-leash once they have entered the fenced in area.

The Dog Park is approximately 2.5 acres in size and is enclosed by 1700 linear feet of fencing. The enclosed off-leash area is divided into two separate areas; one area specified for small breed dogs (approximately .5 acre in size), and another larger area (approximately 2.0 acres in size) designed for large breed dogs. Dog owners will be required to either pay the daily fee that will be placed in a drop-box at the entrance gate, or they can purchase an Annual Dog Tag that can be worn by their dog.

All dog owners are responsible for the actions of their dog(s) and need to have control of their dog(s) at all times when using this special facility. Rules and user information is posted at the entrance area, and each dog owner should read and familiarize themselves with the appropriate usage requirements before entering.

DESIGNATED RULES:

- 1. Open daily from sunrise to sunset.
- 2. The Daily Dog Park User Fee must be placed in the Drop Box unless your dog bears the appropriate City of Beloit Dog Park ID.
- 3. Dogs are permitted off-leash within the enclosed fenced area only!
- 4. Owners are responsible for their dog(s) at all times!
- 5. Each Dog Park user is allowed a maximum of three (3) dogs per adult inside the dog park.
- 6. Dogs should not be left unattended.
- 7. Aggressive and/or threatening dogs must immediately be removed from the park.
- 8. The Dog Park is strictly for dogs only! No other pets allowed!
- 9. All owners are required to pick-up after their dog. Waste bags and receptacles are available, please use them and dispose of waste properly!
- 10. Dogs are prohibited in the park if they are under the age of four (4) months, or if they are a female dog "in-heat".
- 11. Dog treats are allowed only for dog training purposes.
- 12. Smoking is prohibited inside the enclosed fenced area!
- 13. Commercial use of the Dog Park is prohibited, without City authorization.

The City of Beloit Parks & Leisure Services Division strives to provide a fun, safe, and attractive environment for all its residents and visitors to our park sites. By using this special park, users agree and assume all responsibility and liability of risk by unleashing their dog(s) in this facility. This Dog Park is an unsupervised facility, therefore users are required to abide by all rules and proper etiquette at all times while on the premises and maintains proper supervision of your dog(s). The continual use of this park depends on users behaving responsibly and obeying all the rules as designated below. The main priority at all times is the proper control and supervision of one's dog(s).

SUMMARY: This notice advises the public that the Bureau of Indian Affairs (BIA) as lead agency intends to gather information necessary for preparing an Environmental Impact Statement (EIS) in connection with the Ho-Chunk Nation (Nation) application for a proposed 33-acre fee-to-trust transfer and casino project to be located in the City of Beloit, Rock County, Wisconsin. This notice also announces a public scoping meeting to identify potential issues and content for inclusion in the EIS.

DATES: Written comments on the scope of the EIS must arrive by December 26, 2012. The public scoping meeting will be held on December 13, 2012, from 6:00 p.m. until the last public comment is received.

SUPPLEMENTARY INFORMATION:

The proposed action would transfer approximately 33 acres of land from fee to trust status, upon which the Nation would develop a casino, hotel, parking, and other supporting facilities. The property is located within the incorporated boundaries of the City of Beloit, WI. Areas of environmental concern identified for analysis in the EIS include land resources, water resources, air quality, noise, biological resources, cultural resources, resource use patterns, traffic and transportation, public health/environmental hazards, public services and utilities, socioeconomics, environmental justice, and visual resources/aesthetics. Alternatives identified for analysis include the proposed action, a no-action commercial (non-gaming) construction alternative, a no-action no-construction alternative, a reduced-intensity development alternative, and an alternative site location alternative. The range of issues and alternatives are open to

revision based on comments received in response to this notice. Additional information, including a map of the project site, is available by contacting the person listed in the FOR FURTHER INFORMATION section of this notice. Other related approvals may be required to implement the project, including approval of the Nation's fee-to-trust application, determination of the site's eligibility for gaming, compliance with the Clean Water Act, and local service agreements. To the extent applicable, the EIS will identify and evaluate issues related to these approvals.

PUBLIC COMMENT AVAILABILITY

Comments, including names and addresses of respondents, will be available for public review at the BIA address shown in the ADDRESSES section, during regular business hours, 8 a.m. to 4:30 p.m., Monday through Friday, except holidays. Before including your address, phone number, e-mail address, or other personal identifying information in your comment, you should be aware that your entire comment—including your personal identifying information—may be made publicly available at any time. While you can ask in your comment that your personal identifying information be withheld from public review, the BIA cannot guarantee that this will occur.
