ROCK COUNTY DAY IN MADISON

This past Wednesday, the City Manager and the Director of Economic Development traveled to Madison, along with a significant number of other residents and public officials from throughout Rock County. The Roadmap for Progress, prepared by Forward Janesville with input from other agencies in the County, outlines key legislative initiatives, which impact this area. Most are economic development related, like the 39-90 widening and reconstruction, needed improvements to the tax increment financing statute, and requested modifications to make the State's income tax credit program more effective. Following the legislative briefing, we broke up into teams and visited all of the Senate and Assembly offices. Because of the pace of business in the Capitol, we often met with a key staff member and distributed copies of the Roadmap along with a briefing. In some cases, we were able to meet with Senators or Representatives in person to further underscore the significance of these policy initiatives.

Special emphasis was placed on reiterating the significance of the 39-90 project for the entire State of Wisconsin, not just Rock County. There seems to be a strong general consensus in the legislature that this project is, indeed, critical to maintaining the State's infrastructure and its economic viability, particularly the recreation industries, which thrive in the Dells and North woods areas of the State. The DOT has ranked this project the number one priority from among this group of scheduled improvements and we continue to remain optimistic that full funding will be provided in the fiscal 2015-2017 biennium, which would allow construction to begin in the summer of 2015, as scheduled.

UPDATE ON 139-90 PLANNING

Let's transition into an update regarding 39-90 planning and the completion of early concept designs. The consultant doing design work on behalf of the Department of Transportation has been working on some alternative alignment configurations for the very important Interstate 43 interchange here in Beloit. We anticipated having those prior to the end of 2012; however, that timeline obviously did not materialize. We are still waiting for the design concepts and have been assured that we will have approved alternatives before the end of March. In conjunction with the DOT, we will then initiate a series of stakeholder meetings to present the alternatives and receive community feedback before any decisions are made on how the interchange will be reconfigured.

2013 CONSTRUCTION PROJECTS

As we have previously indicated, there will be less construction in the City this season than we have seen in several prior years. Funds for infrastructure improvements continue to be limited due to reductions in the City's equalized assessed valuation. The downtown TIF District expenditure period closed last fall, and other than completion of some projects like the Phoenix building, which was approved and authorized prior to the deadline, little additional public improvements will be undertaken in downtown this year. We continue to receive positive news from the Downtown Beloit Association about business start-ups and façade renovations that are scheduled for 2013.

With the completion of planned improvements to Riverside Park, only shoreline stabilization remains to be completed. That work will be undertaken this year. Plans have been completed and are awaiting Department of Natural Resources review and permitting before we can proceed to bid on that work.

The City has decided to defer completion of final plans for a first phase of the annual intermittent resurfacing project to await the conclusion of winter weather. The weather this winter, particularly the freeze-thaw temperature cycles that we have experienced, have wreaked havoc on streets throughout the city. We want to wait until our weather pattern concludes in the Spring to do a more detailed analysis of streets and determine the final list for resurfacing in 2013. As with every year, there is nowhere near enough money to resurface all of the older streets that have not recently been reconstructed. As many as possible will be overlaid and extensive patching and repairs will be completed to others, as needed, to be sure that the streets remain serviceable.

WORK ON COMPENSATION PLAN

Work continued this week, not only among City management staff, but also the consultant on the proposed compensation plan for all of the City's non-represented employees. Following review of the plan by the City's management team, a number of suggestions were offered for various corrections and updates to the final plan, particularly pay range assignments for various employees. We are also making various updates to the reporting document itself, and hope to have that completed in the very near future.

Unfortunately, work on this very important project continues to take more time than we had anticipated. The Manager will be absent for a good part of next week attending the NLC Legislative Conference in Washington, D.C. so we plan a final review with the consultant and employee meetings to be scheduled during the week of March 18, 2013.

TAILGATING AT TELFER PARK

We have a meeting with the Snappers this Friday to discuss the tailgating issue and to raise a number of questions posed by City Councilors during the review of that proposed ordinance amendment at last Monday night's City Council meeting. The Snappers will be working with the Parks and Leisure Services staff to review those questions and concerns. We anticipate a supplemental staff report prepared from that process, which will be made available for Councilors prior to the future consideration of this request.

SAFETY BELT AND DRUNKEN DRIVING ENFORCEMENT

To combat drunken driving and increase safety belt use, the Beloit Police Department will intensify its traffic safety enforcement from March 4—20, which includes the St. Patrick's Day weekend. This increased enforcement is part of a \$35,000 grant that the Beloit Police Department received from the Wisconsin DOT Bureau of Transportation Safety.

CITY MANAGER AND COUNCIL PRESIDENT TO ATTEND NLC LEGISLATIVE CONFERENCE

The National League of Cities will be holding its Legislative Conference in Washington, D.C. beginning this Sunday and running through Wednesday, March 13. This is a regular annual event; however, City officials have not attended in many years because of the budget issues being addressed during the great recession. Both the City Manager and Council President will be attending this year, and we have scheduled meetings with both Wisconsin Senators and our new Congressperson, Mark Pocan. We hope to also meet the Chiefs of Staff or legislative liaison's representing each of these elected officials, since we rarely get an opportunity to get to know the Washington staff people working for our elected representatives. The sessions will also include a number of legislative briefings and other educational sessions, which will provide a good overview and update on activities going on in Washington, D.C. including the recently initiated sequester, which will impact municipalities.

LEAGUE OF WISCONSIN MUNICIPALITIES BOARD OF DIRECTOR'S MEETING

The League of Wisconsin Municipalities has scheduled a Board of Director's meeting for next Friday, March 15 in Madison. The City Manager will be traveling to Madison to attend that meeting and returning to the City that afternoon.
