BUDGET PREPARATION UPDATE

Departments and divisions continue to work on their submittals for the 2014 Operating Budget. The Capital Projects Review Committee completed their work on the 2014 element of the Capital Spending Plan last week and will be meeting later in the summer to validate that the project's selected will continue to fit within that capacity of parameters for next year.

Actual review of the Operating Budget will not begin until the early July, the next public meeting regarding the 2014 Budget preparation process is a workshop scheduled with City Council for **Monday, June 17 from 5:30 to 6:30 p.m.,** prior to the regularly scheduled City Council meeting.

GRINNELL HALL SENIOR CENTER UPDATE

I was honored to be invited to join the seniors for lunch at Grinnell Hall this past Monday. The hot meal program is excellent, with very high quality, nutritious food and eligible seniors in the community who have an interest should contact Grinnell Hall at 364-2875.

Following lunch, we toured the entire facility and I was very pleased with some of the changes that Paula Schutt, the new Senior Center Director, has underway. The recent transition process with the changes in Center Directors has gone extremely well and we were happy to see the continued growth and development of one of the City's most successful senior services.

CUNNINGHAM SCHOOL GROUND BREAKING

This past Wednesday at noon, I joined School Superintendent Steve McNeal and School Board President Shannon Scharmer at the groundbreaking ceremony for the new Cunningham School addition. Cunningham is the last of the existing buildings to begin the reconstruction

process. A substantial building addition, along with related site improvements will be completed, substantially expanding the capacity of the Cunningham campus. Once again, there was a very enthusiastic crowd of students, parents, staff and interested neighbors present for the event.

CITY CENTER COMMITTEE CONTINUES PLANNING AND CONNECTIONS ACTIVITIES

The City Center Committee met this past Thursday morning and continued their planning and coordination of various City Center improvement projects in both Beloit and South Beloit. Following the meeting, a number of the members actually toured the confluence site, viewing the potential for the anticipated future development of this site as a park to permanently preserve the Turtle Creek/Rock River confluence, which has played such a prominent role in the City's history.

FIRST MAJOR RECONSTRUCTION ON THE I-39/90 CORRIDOR TO BEGIN NEXT WEEK

On Thursday, June 13, we have been invited to join a number of State, County and other municipal officials at the ground breaking ceremony for the Hwy. 11/Racine Avenue interchange on I-39/90. This interchange, located in the City of Janesville, is actually the first major piece of infrastructure to undergo reconstruction along the 39/90 corridor. The entire interchange will be rebuilt, including the use of traffic circles to facilitate safe turning movements coming on and off the highway.

BUSINESS IMPROVEMENT DISTRICT (DOWNTOWN BELOIT ASSOCIATION) –

Implements the operating plan for the development, redevelopment, maintenance, operation and promotion of the downtown business improvement district. The annual plan and changes are submitted to the City Council for approval. Meets monthly at 8:00 a.m. on the 4th Thursday at 500 Public Ave. Term: 3 years.

COMMUNITY DEVELOPMENT AUTHORITY

Plans and implements economic redevelopment and housing initiatives; oversees the operations of the public housing office. Meets monthly at 4:30 p.m. on 4th Wednesday at Beloit City Hall Forum, 100 State Street. Term: 4 years.

EOUAL OPPORTUNITIES HUMAN RELATIONS COMMISSION - Created to improve the quality of life by the elimination of racism in the Beloit community.
