7TH ANNUAL BUSINESS EDUCATION SUMMIT SCHEDULED FOR AUGUST 22, 2013

Just a reminder that the Business Education Summit, which is jointly sponsored by the Greater Beloit Economic Development Corporation, the School District of Beloit, the Greater Beloit Chamber of Commerce, and Beloit College, will be held on Thursday, August 22, 2013 with registration beginning at 8:30 a.m. Once again, the session will convene in the Eclipse Center located at 100 Eclipse Center, Beloit, WI. This is a unique opportunity for educators and business as well as government leaders in the community to interact and to share perspectives regarding the needs of public education. The Beloit Public Library will hold training for "Adopt-A-Shelf" volunteers on Tuesday, September 17 from 3:30—5:30 p.m. in the Library meeting room, 605 Eclipse Blvd. Following training, volunteers may "adopt" a section of library shelves to help keep the books in order, straightened, and dusted. Volunteers are asked to commit to monthly visits for at least one year. Volunteers have assisted at the Library for many years to help maintain excellent services, while holding down costs for taxpayers. CITY AND SCHOOL DISTRICT EMBARK UPON ANOTHER COLLABORATION

At the Board of Education meeting held on August 13, 2013, the Board voted unanimously to enter into an Intergovernmental Agreement with the City for purposes of providing solid waste collection and recycling services to the School District. That same Intergovernmental Agreement will be on the City Council's agenda on Monday, August 19, 2013 for consideration. Following the general section of the Beloit Report, the descriptive information regarding the City Council agenda provides more information about the benefits, not only to the School District and the City, but to the taxpayers in the community as a result of this additional collaboration.

2014 BUDGET UPDATE

The City's Budget Preparation Committee will be getting together again next week, hopefully to do final reviews on the various components of the 2014 proposed operating budget.

The State will be releasing numbers this week regarding the many significant earnings and assessment changes for the coming year. Once again, we already know that most of the funds are in or near balance and we hope to be reviewing primarily balanced funds and accounts at this session. A great deal of work remains before the complete budget document is finalized and that work will continue through the month of September.

CITY COUNCIL MEETING - MONDAY, AUGUST 19, 2013

The City Council will hold a <u>workshop</u> at 6:30 p.m. in the City Manager's Conference Room, on Monday, August 19, 2013 for the purpose of reviewing the agenda of the regular 7:00 p.m. City Council meeting.

The attached agenda is for the Monday, August 19, 2013 regular City Council meeting beginning at 7:00 p.m. in the Forum.

3. SPECIAL ORDERS OF THE DAY/ANNOUNCEMENTS

a. The City will be presenting Certificates of Appreciation to the graduates of the "Landlord and the Law Workshops Series." These training seminars are jointly sponsored by the Beloit Property Manager's Association and the City of Beloit.

4. PUBLIC HEARINGS

- a. Resolution authorizing a Conditional Use Permit to allow a Residential Care Apartment Complex in an Office District along Cranston Road on a property addressed at 2157 Schuster Drive. This is the senior housing complex which was scheduled for construction this year but ended up taking longer to go through the plan approval process with the State than originally anticipated. The owners Conditional Use Permit expired and they must again receive Council authorization to proceed with their project. The Plan Commission recommended the project for approval.
- b. Resolution authorizing a Conditional Use Permit to allow indoor alcohol sale, possession, and consumption in a C-2, Neighborhood Commercial District, for the property located at 946 Wisconsin Avenue. This is for the restaurant La Fuente. Once again, the staff and Plan Commission have both examined this application and the Plan Commission recommended for approval.
- c. Resolution authorizing a Conditional Use Permit to allow a drive-in use, outdoor seating area, and sales, possession and consumption of alcohol in a C-2, Neighborhood Commercial District, for the property located at 2777 Milwaukee Road. This property is near the intersection of Cranston Road and there will be a new restaurant and retail space constructed on this site. City staff and the Plan Commission have reviewed this application and the Plan Commission has voted to recommend approval.

6. CONSENT AGENDA

- a. Approval of the Minutes from the Regular Meeting of August 5, 2013.
- b. Resolution approving a Class "B" Beer and "Class C" Wine License for the restaurant La Fuente, operating at 946 Wisconsin Avenue. This is the liquor application and will be authorized, assuming the above referenced Conditional Use Permit is approved by Council. The Alcohol Beverage License Control Committee has recommended for approval.
- c. Resolution approving **Change of Agent** for Wal-Mart Store located at 2785 Milwaukee Road. The Alcohol Beverage License Control Committee recommended for approval.
- d. Application for a **Planned Unit Development (PUD)** for the Woodman's Food Market location at 1877 Madison Road. This Conditional Use Permit is needed to relocate and reconstruct the automotive service station formerly located on the site and displaced by the latest warehouse construction project. This matter is being referred to the Plan Commission for their review and recommendation.

7. ORDINANCES

Three of the four proposed ordinances pertain to traffic schedule and directional modifications related to the school reconstruction project. All four of the Ordinances have been reviewed by the Traffic Review Committee and recommended for approval. As always with matters of this nature, the staff has included these on the agenda with a request for 2nd reading and approval, unless Councilors feel that any of the changes warrant additional delay.

- a. Proposed Ordinance to amend Parking Vehicles on the Near Side of Highways Adjacent to Schoolhouses for a number of locations around the City. This Ordinance is in relation to the rebuilding of the school facilities and the changes are needed to accommodate changes in access and parking at the new school sites. These modifications have been carefully reviewed by the City's Engineering staff, as well as School District staff, and have further been reviewed and recommended for approval by the City's Traffic Review Committee.
- b. Proposed Ordinance to **Remove Loading Zone Designations** along Poff Street and Townline Avenue near Converse School. Once again, these changes are related to school reconstruction and alterations in the configuration of the site. School staff, along with City Engineering staff, have reviewed the changes and the Traffic Review Committee has recommended for approval.
- c. Proposed Ordinance to Remove 2-hour Parking Restrictions in the Heritage View Parking Lot. These restrictions were initially placed, anticipating that primarily retail sales would occupy the bottom level of that facility. In reality, office uses now occupy the space and it is anticipated that a beauty spa will be occupying the balance of that space in the near future. The owner has requested that the 2-hour restriction be removed from the parking lot to better serve the businesses now located in the Heritage View building. Once again, these kind of parking restrictions are done at the request of local businesses and property owners. The Traffic Review Committee has reviewed this recommendation and recommended for approval.
- d. Proposed Ordinance Changing the One-Way Travel Direction on Locust Street between Eighth and Bluff. Once again, this is a change necessitated by site alterations needed as part of the school reconstruction program. This change has been reviewed by the City's Engineering Division with School District staff. The Traffic Review Committee has further reviewed and has recommended for approval.

8. APPOINTMENTS

We do have appointments that will be included on the agenda for Monday night's meeting.

11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution approving a Water Tower and Ground Space Lease with First National Bank and Trust Company for space on the water tower at 2875 Cranston Road. While it has taken some time to validate frequencies and locations to ensure that this antennae facility will operate appropriately to support First National Bank communication needs, this process has been concluded. A final location on the tower has been selected and the City is ready to move forward with this lease agreement. The Conditional Use Permit for a separate stand alone tower at the bank's Cranston Road facility has not been included on the agenda, since that can be withdrawn by the petitioner with a simple letter of request. Consequently, if Council authorizes the lease and location of the antennas on the tower, there will be no need to further consider a stand alone tower at the bank's facility.
- b. Resolution approving an Intergovernmental Agreement between the City and the School District of Beloit to provide solid waste and recycling services for the School District. There is a staff report and resolution attached that explains the value add if the City providing this service to the School District, which will save the District money. Recycling paper from the school system will be directly diverted to Beloit Box Board, which is our local vendor with a renewed contract approved by Council at the last meeting. This is also an opportunity for City staff to work directly with School District officials to try to expand the recycling program and improve diversion. The contract is set up for periodic reviews of volume to make price adjustments if the volume of trash and/or recyclables increases or decreases by more than 10%. The contract can also be terminated by either party with 90 days prior notice. Once again, this is an outcome of efforts undertaken by the City and other local jurisdictions to communicate and collaborate whenever possible to try to improve service delivery and reduce costs for local taxpayers. Not only will the School District be saving money directly from the contract price, but the additional sale of paper will also support the City's solid waste operations, keeping prices low for all Beloit residents.


