#### **BUDGET PREPARATION**

Extensive review and deliberation on the proposed 2014 Operating and Capital Budgets has been on-going for the past several months. Beginning with the Strategic Planning session in May; preparation of the proposed budget by the City Manager and staff; and finally, review by the full City Council culminating in the public hearing held this past Monday evening. Staff is now preparing the series of resolutions which will be included on the November 4, 2013 regular City Council meeting agenda for Council consideration. If approved, the resolutions will adopt the budget, approve both the HOME and CDBG programs, approve the Downtown Beloit Association budget, and finally, amend some fees and charges the City assesses for service delivery. No increases in utility charges, including solid waste collection fees, are included in the 2014 budget.

#### SCHOOL DISTRICT DEDICATES NEW NATATORIUM AT BELOIT MEMORIAL HIGH SCHOOL

I was pleased and honored to be included in the ceremonies this past Monday evening when the School District dedicated the new natatorium aquatic facility at Beloit Memorial High School. The community has undoubtedly heard and read much about the facility, if you were not among the large crowd of residents in attendance that evening. Once again, the School Board and Administration are to be congratulated for doing an excellent job of replacing the old, outdated and maintenance plagued facility with one of the nicest school aquatic facilities in the State.

#### **NEIGHBORHOOD REVITALIZATION**

Our Neighborhood Revitalization Committee met this past week and reviewed a number Neighborhood Improvement Programs being coordinated by the City's Community Development Department. We discussed the tax foreclosure properties that the City acquired, as well as those that went on to auction. We are happy to report that all of the structures that passed through the auction process were sold. Closings have just occurred on those properties and we have not yet received all of the updated ownership information. We also received good news this week that the City owned residential property at 122 Hackett Street sold for the list price. This is one of the homes the City acquired under the Neighborhood Stabilization Program. The property has undergone a complete renovation and was on the market for sale.

The City has additional residential properties that have been acquired and completely remodeled under the Stabilization Program. Some have even had a second round of improvements to make them more attractive to a potential buyer. #### **2014 City Council Nomination Information**

October 14, 2013 – Beloit, WI: Any City of Beloit resident interested in running for a two-year term on the Beloit City Council may pick up a packet of information including nomination papers beginning Monday, October 28, 2013. The packets are available in the office of the City Clerk on the second floor of City Hall during normal business hours: Monday through Friday, 8:00 a.m. to 5:00 p.m.

- The Spring Election will be held on **Tuesday**, **April 1**, **2014**.
- There are seven members on the Council and four seats will be on the ballot.
- Candidates must file required forms with the City Clerk before forming a committee and/or raising funds.
- The first day to circulate nomination papers is **Sunday, December 1, 2013**.
- A minimum of 200 valid signatures of City of Beloit residents must be submitted. Staff recommends that between 200 and 400 signatures be submitted to ensure ballot access.
- Nomination papers and all forms must be completed and filed with the City Clerk by 5:00 p.m. on **Tuesday**, **January 7**, **2014**.
- An informational session may be held in January for all candidates who have gained ballot access.
- Newly-elected Councilors will take office on Tuesday, April 15, 2014.

#### Rock County Flood Risk Information Open House Scheduled

General public provided opportunity to find out more about floodplain management in their community

Madison – Representatives from the Wisconsin Department of Natural Resources (WDNR), in cooperation with the Department of Homeland Security's Federal Emergency Management Agency (FEMA), will be hosting a Flood Risk Information Open House on Wednesday, October 30 beginning at 6:00 p.m. at Marshall Middle School, in the Cafeteria, 25 South Pontiac Drive, Janesville, WI. This Open House will provide the public with an opportunity to review a recently completed preliminary Flood Insurance Study (FIS) and its accompanying preliminary Flood Insurance Rate Maps (FIRM) that include base flood information and areas subject to significant flood hazards within the county. Information included in the FIS and the FIRMs is utilized by both public officials when permitting development in the floodplain and the federal government when making flood insurance determinations. Please note, there will not be a presentation at the Open House, rather this is an opportunity to view the preliminary maps and FIS in preparation for the upcoming 90-day appeal period.

The Open House will be staffed with representatives from various local and state agencies, to provide you the most current information about flood risk, flood insurance, floodplain development regulations, and the process for floodplain mapping within Rock County communities. New preliminary floodplain maps have been prepared and will be on display. Once the maps become effective in approximately one year, these maps will be used by floodplain permit officials, builders and developers, lenders, realtors, insurance agents and the general public to determine flood risk, develop mitigation measures, and encourage wise and responsible risk management decision-making.

Property owners, realtors, lenders, and insurance agents are encouraged to attend and take advantage of this opportunity to learn more about flood risk and hazard mitigation within their community. If you have any questions regarding this meeting, please contact G. Fritz Statz, at (608) 266-2709 or Gary Heinrichs at (608) 266-3093, Wisconsin Department of Natural Resources Floodplain Planners.

FEMA prepares the nation for all hazards and manages federal response and recovery efforts following any national incident. FEMA also initiates mitigation activities, trains first responders, works with state and local emergency managers, and manages the National Flood Insurance Program and the U.S. Fire Administration. FEMA became part of the U.S. Department of Homeland Security on March 1, 2003.

ALL INTERESTED PERSONS are advised that Rock County will hold a public hearing as provided by law to consider the location, design, and environmental aspects of the proposed improvement of County BT between County G (Prairie Avenue) and County S (Shopiere Road), including those aspects that may require a section 404 Clean Water Act permit from the U.S. Army Corps of Engineers for placement of fill materials into waters of the United States.

The Proposed Action (Project ID 5989-05-21) would construct a new roadway, County BT, which would provide a connector route between County G (Prairie Avenue) and County S (Shopiere Road) within the City of Beloit and Towns of Beloit and Turtle in Rock County. The purpose of this project is to create a direct connection between County G (Prairie Avenue) and County S (Shopiere Avenue), while improving safety and relieving congestion on the existing local roadway system.

It is anticipated that the relocation of two residences would occur as a result of the proposed improvement. Any person who feels they may be affected by the Proposed Action may obtain relocation assistance information by contacting Rock County.

The preferred alternative includes the construction of a new bridge over Turtle Creek, which involves the addition of the bridge and approach embankments within the existing Turtle Creek floodplain.

Further information concerning the proposed improvement is available at the Rock County Highway Division at the address given below.

The public hearing will be held on Tuesday, November 19, 2013 at Courtroom H, Rock County Courthouse, 51 S. Main St., in the City of Janesville. The hearing will be conducted from 6:00 P.M. to 9:00 P.M. with a presentation at 6:30 P.M. Information on how to present oral and written testimony will be provided at the public hearing.

As an informational service, staff engineers will be present from 6:00 P.M. and 9:00 P.M. on the day of the hearing for informal discussion of the proposal. Interested persons may review displays and other hearing materials, ask questions, and provide testimony. Exhibits of the proposal will be on display and a statement about the proposed improvement will be available for review.

All interested persons are invited to attend the hearing and present relevant oral and/or written testimony concerning the general location and design aspects, the social, economic, and environmental effects of the proposed improvement including those for which permits may be required under Section 404 of the Clean Water Act, and whether the improvements are in the public interest and consistent with the goals and objectives of area planning. Individuals will have the option of presenting testimony in a traditional hearing format in front of an audience, or one-on-one with a court reporter in a separated area.

Land acquisition schedules for construction will be available at the public hearing.

Relocation assistance will be discussed. It is anticipated that the relocation of persons will occur as a result of the proposed improvement. Any person who feels that he or she may be

thus affected by the proposed improvement may obtain relocation assistance information at the Rock County Department of Public Works, telephone (608) 757-5450.

Provisions have been made for the submission of written statements or other exhibits in place of or in addition to the testimony presented at the public hearing. This additional testimony will be included in the hearing transcript if postmarked no later than December 3, 2013. Mail this testimony to Benjamin Coopman, Rock County Director of Public Works at the address given below.

ALL INTERESTED PERSONS are further notified of the availability of an Environmental Assessment of the Proposed Action's impacts and effects which has been prepared and filed according to the Wisconsin and United States Environmental Policy Acts. This document indicates that no significant environmental impacts are anticipated to occur as a result of this improvement.
