

ALCOHOL BEVERAGE LICENSE CONTROL COMMITTEE

- 1. The meeting was called to order at 4:00 p.m. by Chairman Ralph Berkley with a quorum present.
- 2. Consideration of the minutes of the regular meeting of February 12, 2013. Motion to approve by Mr. Metter, second by Mr. Vickerman. Motion carried.
- 3. Consideration of the status of the Class "B" Beer and "Class B" Liquor License for Draeving Companies, LLC, d/b/a Thirsty Badger Bar & Grill, 2683 Prairie Avenue. Agent Michael Draeving, Sr. appeared.

The Committee reviewed the written submission of Mr. Draeving giving the timeline for construction projects at 2683 Prairie Avenue. The Committee found it to be reasonable and complimented Mr. Draeving on the thoroughness of his report. Mr. Tilley moved to recommend to the City Council that the licensee be granted additional time to complete remodeling and to open the business, second by Mr. Metter. Motion carried.

Attorney Krueger told Mr. Draeving that the Conditional Use Permit he obtained for the outdoor seating area will expire May 22, 2013. She said that if the use is not established by that time, he may have to apply for another Conditional Use Permit.

4. Consideration of an incident on February 12, 2013, Police Report 13-1219 at CVS Pharmacy #8534, 1063 Fourth Street, for failure to display an Operator's license. Manager Bradley Eyster and Agent, Judy Thomas appeared.

Captain Sciame stated he was notified that there were no licensed Operators at the CVS Pharmacy. Beloit Police Officers checked the store on February 12, 2013 where the clerk was licensed but did not have his license posted because it was at the other CVS store. The store manager, Bradley Eyster was issued a citation for failure to display the license to sell alcohol. Captain Sciame advised Mr. Eyster that he should license as many employees as possible so this does not occur again.

Mr. Eyster stated he has three employees licensed and two more are in process. Attorney Krueger advised Mr. Eyster that the licensed person must be within sight of the sale of the alcohol.
