Again this year, choral groups from the local high schools will be participating and this event represents one of the community's exciting holiday season events—not to be missed.

### PUBLIC MEETINGS ON I-39/90/I-43 INTERCHANGE RECONSTRUCTION DRAW LARGE CROWDS

We were very, very pleased, as was the Wisconsin Department of Transportation, with the turnout this past Tuesday for the Interchange reconstruction meeting. Both the 3:00 p.m. session and the open meeting from 5:00—7:00 p.m. were very well attended. It was also gratifying to hear so many good, relevant questions and a generally positive response to the new interchange and certainly the amount of investment that is being made in the City by both the Federal and State governments.

As previously noted, there were five options to be reviewed and residents, property owners and other stakeholders were invited to complete a written questionnaire outlining their preferences and the reasons for their choice. We have a meeting scheduled for late next week with the consultants and the transportation officials to review that material and to decide the next steps. We would hope to get the design process down to no more than two alignment options in the immediate future so that we can proceed at a good pace to get the project ready for construction.

On Tuesday evening, the consultants indicated that it will now likely be 2017 before this project is ready to actually begin construction.

### HOLIDAY SCHEDULE

The holiday schedule for the City begins the week after next. As in prior years, mid- and top management employees have been encouraged to use the slower paced holiday season to use up accumulated annual leave. Consequently, as in past years there will be a significant

number of City employees on vacation during the holiday season. As always, all City offices will be manned during office hours and all first responders will have incident command capacity throughout the holiday season. Please note the following holiday modifications:

1. All City offices will be closed on Tuesday, December 24 and Wednesday December 25 in celebration of the Christmas holiday.
2. All City offices will be closed on December 31 and January 1 in celebration of the New Year's holiday.
3. Solid Waste collection services will be delayed by one day beginning with Wednesday collection each of those two weeks. The Wednesday collection day will be moved to Thursday, Thursday to Friday and Friday to Saturday, as we normally do for the holiday routine. Trash will be collected as usual on Tuesday, December 24 and Tuesday, December 31.
4. The Beloit Library will be closed due to holidays on the following dates: December 24, 25, 31 and January 1. The outside book drop, located on the south side of the building, is open 24 hours a day. The City Manager will be on vacation most of the two weeks, beginning Monday, December 23 and concluding on Friday, January 3, 2014. The Manager will be available via cell phone and e-mail and will be in and out of the office intermittently for agenda preparation and as needed regarding any other item of business. The first City Council meeting for 2014 will be held on Monday, January 6, 2014.

The final Beloit Report for the year will be distributed next Friday, December 20; however, every effort will be made to provide an update on the January 6 City Council agenda prior to that meeting.

**CITY COUNCIL MEETING - MONDAY, DECEMBER 16, 2013**

The City Council will hold a **Special Meeting** and adjourn into closed session at 5:30 p.m. in the City Manager's Conference Room on Monday, December 16, 2013 for the purpose of performing the City Manager's annual **Performance Evaluation**. Council will adjourn the closed session meeting and reconvene at approximately 6:30 p.m. for a **Workshop** to review the agenda of the regular City Council meeting.

The attached **agenda** is for the Monday, December 16, 2013 regular City Council meeting beginning at 7:00 p.m. in the Forum.

**3. SPECIAL ORDERS OF THE DAY/ANNOUNCEMENTS**

- a. Proclamation of Appreciation honoring **Police Chief Norm Jacobs** as the longest serving Police Officer in Departmental History. We were recently informed that Beloit's Police Chief Norm Jacobs has passed a tenure milestone and is now the longest serving officer in the 156-year history of the Beloit Police Department. This is a significant accomplishment and we have prepared a proclamation expressing the City's appreciation to the Chief, both on the occasion of this mile-stone service accomplishment, as well as the quality services that he has provided the City of Beloit.

**4. PUBLIC HEARINGS**

- a. Proposed Ordinance amending the **Comprehensive Plan** to change the designation of property located at 1566 Forest Avenue from Single-family Residential –Urban to Institutional and Community Service. This is an additional parcel that was purchased for the expansion and improvements to Gaston School. As with other minor changes of this nature to support the school remodeling project, the City has this item on the agenda to suspend the rules for second reading and adoption. The Plan Commission unanimously recommended for approval.
- b. Proposed Ordinance amending the City of Beloit **Zoning District Map** for the same property located at 1566 Forest Avenue. Once again, the Plan Commission has unanimously recommended for approval and the item is on the agenda to suspend the rules for second reading and adoption.
- c. Resolution authorizing a **Conditional Use Permit** to allow a pick-up window for drive through services at the former KFC site at 204 Park Avenue. This property has been purchased and will be remodeled and reopened as a Domino's Pizza store. The Plan Commission has unanimously recommended for approval.

**6. CONSENT AGENDA**

- a. Approval of the **Minutes** of the Regular Meeting of December 2, 2013.
- b. Application for a **Conditional Use Permit** to allow an office use in an M-2, General Manufacturing District for a number of properties addressed on Third Street. This Conditional Use is for the Ironworks redevelopment project, which is currently underway. The developers are anticipating a number of office uses, as well as the possibility of a health club being located in this redevelopment. The M-2, General Manufacturing District zoning lists these types of uses as conditional, requiring review by the Plan Commission and approval by City Council. This item is being referred to the Plan Commission for their review and recommendation.
- c. Resolution approving a **Change of Agent** for the Beloit Mobil station located at 2883 Milwaukee Road. The Alcohol Beverage License Control Commission unanimously recommended for approval.
- d. Resolution approving **Change of Agent** for Adiktion, 1310 Cranston Road. This application was reviewed by the Alcohol Beverage License and Control Commission. The proposed new agent does not live in the area and could

not answer many of the questions about the administration of the liquor license in the State of Wisconsin.

Consequently, the Alcohol Beverage License Control Commission was uncomfortable with the applicant, and referred the matter back to Council without a recommendation. It's likely that Council will pull this matter off the Consent Agenda, since it certainly will need further review and consideration.

- e. Resolution approving a **Class "A" Beer License** for the recently remodeled and expanded Clark Gas Station, 903 Broad Street. The Alcohol Beverage License Control Commission recommended for approval.
- f. Resolution approving the **Appointment of Election Officials** for the 2014-2015 Election Cycle. This is a routine matter that comes before Council on an intermittent basis to approve the various election officials that have been appointed by the City Clerk to assist at the polling stations for this two-year election cycle.
- g. Resolution approving a **Service Agreement** between the City and Life Line Billing systems. This is the service that bills for Fire Department services for which a user fee has been approved by the City Council.
- h. Resolution approving a **Site Access Agreement** with the City of South Beloit, Illinois. This Site Access Agreement pertains to the property the city recently acquired on Shirland Avenue, a portion of which is located within the State of Illinois. An informal agreement exists between the two communities to eventually transfer title to that portion of the property to the City of South Beloit. South Beloit has requested authorization to do a Phase 2 environmental on the site because there are grant funds available for municipalities in Illinois, should any Brownfield problems exist. If some are found, they will be able to qualify for a grant for a clean-up, if they are identified prior to ownership.

## 7. ORDINANCES

- a. There are a number of modifications that are being proposed to the City's Property Maintenance Code and our **Residential Rental Dwelling Permit Program** following meetings with the Beloit Property Owners Association. The changes clarify some of the sections but do not make any material changes to code provisions which would undermine the life safety or habitability of residential units in the City. The ordinance received the first reading at the last meeting and is on the agenda for second reading and adoption.
- b. Proposed Ordinance adding some changes to the Index of Special Locations related to parking regulations. The adjustment is made to the schedule for **Parking of Vehicles on the near side of Highways adjacent to Schoolhouses** and is being adjusted to fit the new footprint of the Gaston School property. This item has been reviewed by the Traffic Review Commission and recommended for approval. The Ordinance is on the agenda for suspension of the rules for a second reading and adoption at this meeting.
- c. Proposed Ordinance establishing **No Parking** regulations on Bushnell Street. This is for a small section on the south side of Bushnell near Prospect Street where we have a bus stop that serves residential properties nearby. Vehicle parking has been blocking access for the bus to pull over to pick up passengers and we need to open this area to ensure that we have a safe pick-up point so that residents do not have to walk out into the street in order to board the bus. Once again, this item has been reviewed and recommended for approval by the Traffic Review Commission. The item is on the agenda to suspend the rules for second reading and adoption.

## 10. CITY MANAGER'S PRESENTATION

- a. Monica Krysztopa, from **Visit Beloit**, the Convention and Visitors Bureau, will be in attendance to provide Council with a briefing and update on a number of projects, programs and activities underway at Visit Beloit.

**11. REPORTS FROM BOARDS AND CITY OFFICERS**

- a. Resolution approving the 2014 Contract between the City of Beloit and **Dane County Humane Society, Inc.** and authorizing execution thereof. This contract provides for the continuation of a contract for services with the Dane County Humane Society. We had a similar agreement in place for the past calendar year and this would extend that agreement through 2014. Charges to the City are based on a "per animal delivered" basis, and are billed only when their services are utilized.
- b. Resolution approving 2014-2015 Contract between the City of Beloit and **Rock County Humane Society, Inc.** This is a lump sum dollar contract in the amount of \$90,000 with the Rock County Humane Society. Recent changes in management have adjusted operations at the Humane Society. The City utilizes the Rock County Humane Society for most of its stray animal housing needs. As in the past, this fee also allows residents of Beloit to drop off stray animals to the agency during business hours. It should be noted that the City has fully implemented its own in-house animal control service and that service will continue to be provided by the City and is not included under this contract.
- c. Resolution authorizing the **Transfer of Funds** from the General Fund Contingency Reserve Fund for 2013. Two transfers are recommended this year; one to the Legal Department budget and one to the Fire Department budget. The one to the Legal Department is to cover additional outside legal fees that were incurred this year as a result of a number of property tax assessment cases and appeals, including the City's own appeal of the commercial property value made by the State Department of Revenue. Other cases involved appeals by local property owners or the City's Board of Review.

The second transfer is for the Fire Department and relates to legal services incurred by the City related to contract negotiations and general labor relations and grievance matters. The Fire Department also incurred higher than anticipated overtime expenses this year due to a number of injuries and illnesses experienced by employees. New hires made this summer under the grant award have mitigated the overtime costs somewhat, but too late to meet this calendar year's budget limits.

Again, it should be noted that the sums represent transfers from the Master Contingency Account and do not require a supplemental appropriation.

- d. Resolution declaring **Doubtful Accounts**. Each year, the auditors require that we submit any uncollectible accounts to City Council for consideration for write-off. The city has one item this year which represented a payment that was due the City by a contractor for some work done by the Utilities Division in support of an earlier construction project. The contractor did not pay the bill and subsequently filed for bankruptcy. The bill is not collectible. Procedures have been altered to ensure pre-payment for any work provided by the City on behalf of outside contractors, should this need again arise.
