PROPOSED DEVELOPMENT ON CITY OWNED PROPERTY ALONG BURTON STREET, NEAR FIR, DELL AND ASPEN DRIVES

As has been reported in the newspaper, we had an unusually contentious workshop meeting this past Tuesday evening to hear a preliminary presentation by Mirus Partners about a planned Tax Credit Financed housing development to be located on City owned land along Burton Street, across from the Woodman's Supermarket complex. Although this was a very low density, low profile development involving attached residential units, with lots of green space and separation, adjacent neighbors were very "concerned" about this residential development. Neighborhood opposition was the primary reason we held a workshop instead of simply processing a normal application. A great deal of work and expense would be required by the developers and the City to prepare the number of documents that require Council's approval before a tax credit financed application project can be filed with the State Oversight Agency. The intensity of the opposition and the fears that were articulated concerned both City officials and the developers. Councilor comments also indicated that it is unlikely such a project would be approved by the Council with that level of neighborhood opposition. Consequently, the developers have decided not to move forward with a formal application at this time.

The city owned property on Burton is currently used for agricultural purposes; however, it is in the developed portion of the City, has been platted for residential development, and hopefully at some point we will find a use for this parcel. If it continues to remain available and we anticipate the likelihood of another project coming forward as the economy continues to improve. For the foreseeable future, however, we will anticipate retaining the farm leases currently in place for this parcel.

City Clerk to Draw Ballot Order by Lot on January 13, 2014

January 8, 2014 – Beloit, WI: On Monday, January 13, 2014, at 4:00 p.m. in the City Clerk's office, the City Clerk will draw lots to determine the order of City Council candidates' names on the April 1, 2014 ballot. The City Clerk's office is located on the second floor of Beloit City Hall, 100 State Street, Beloit, Wisconsin 53511.

State law requires the ballot order for the 2014 Spring Election to be determined by January 14th. The Clerk will print the name of each candidate who has gained ballot access on a piece of paper and place the papers in a box. The ballot order will then be chosen at random by picking the names out of the box.

There will be four City Council seats on the ballot, and the following individuals have gained ballot access (in no particular order):

- Sheila De Forest (incumbent);
- Charles M. Haynes (incumbent);
- Chuck Kincaid (incumbent); and
- Anna Kelly


