BELOIT HEALTH SYSTEMS CELEBRATES OPENING OF NEW CANCER CENTER

This past Thursday evening I was honored to participate in the ribbon-cutting ceremony officially opening the Beloit Health System and UW Cancer Center located in 1670 Lee Lane at the intersection of Milwaukee Road. The Center is not only functionally state-of-the-art but also a very attractive facility and a tremendous asset to the growing Milwaukee Road corridor. UPDATE ON I-39/90 RECONSTRUCTION

Following Council's vote on Monday evening to support design alternative 2, we prepared a letter notifying the State Department of Transportation of the City's official recommendation. Obviously, the Interstate Highway is part of the Federal Highway network and the Federal Highway Administration (FHWA) will make the final decision regarding all design features for the new highway, as well as the I-43 interchange. Federal Highway officials have also articulated an interest in the design alternative to extend Milwaukee Road to Gateway Boulevard creating a Collector Highway linkage from the East to the West sides of the Interstate Highway.

City officials will be attending the I-90 business group meeting in mid-February to continue discussions with this group about the design alternatives and to answer questions about the future reconstruction of the interstate infrastructure. A great deal of work remains in the design and approval process before the Department of Transportation will receive clearance to move forward with right-of-way acquisition ultimately bidding for project construction. At the present time the department is telling us it will probably be 2017 before the project is actually ready for construction.
