UPDATE ON COUNCILOR RESIGNATION

This coming Monday night, May 19, 2014, Councilor Leavy's resignation e-mail will be presented to the City Council for acceptance. Later in the agenda, a resolution will be considered by Council to initiate the appointment process provided for in Section 1.06 of the Municipal Code for filling a vacancy on the City Council. More information about the contents of the resolution and the process are included later in the Beloit Report under the agenda section. The agenda itself, of course, is available on the City's website with a link from the home page. The agenda includes a copy of the Public Notice and the application form that will be used if Council approves the appointment process.

It should also be noted that Councilor Leavy's resignation does not take effect until the end of May, so Councilor Leavy will hopefully be in attendance and participating at this City Council meeting.

BUDGET/STRATEGIC PLAN

The Strategic Planning session with Council was held this past Monday, May 12 and ran the entire day, as anticipated. There was a great deal of discussion and input and a number of modifications to the draft plan were made by Councilors during the workshop. Revisions to the draft plan are being completed and we anticipate having a resolution on the agenda for the Monday, June 2, 2014 City Council meeting to consider adoption of the Strategic Plan. Departments and Divisions will begin submitting their operating budget numbers in June. There will be a Council workshop to preview the budget preparation process before the regular City Council meeting on June 16, 2014.

Also, the Farmers' Market pre-sale will be held again downtown on Saturday morning, May 17. A special feature at this week's pre-sale will be an extensive **display of Public Works equipment**. There will also be gifts and entertainment options for children, so make sure you bring your family downtown on Saturday, May 17 to browse the Farmers' Market pre-sale and have an opportunity to go through the many interesting Public Works Department displays that will be set up that morning.

Later in the morning on **Saturday, May 17, the Beloit Fire Department will host an Open House** at the Headquarters Station located at 1111 Church Street. Apparatus and informational displays will be available for public viewing from 10:00 a.m.—2:00 p.m.

UPDATE ON INTERSTATE 39/90/43 INTERCHANGE AND 39/90 WIDENING

We attended the regular monthly team meeting with Wisconsin Department of Transportation and Federal Highway Administration officials, along with the consultants working on the design for widening of the Interstate 39/90 and the reconstruction of the I-43 interchange. Once again, we had a good open discussion and dialogue.

Most of the meeting was devoted to reviewing various engineering details related to the radii of curves, distances and design details that were not impactful on the community. The final portion of the meeting began a serious look at signage throughout the corridor and gave us the first opportunity to see some of the proposed signs that would be added at the Hart Road interchange. We made several comments to upgrade that language to make it clear that was the City of Beloit exit for southbound I-43 traffic and also to ensure that Highway 81 as well as the name Milwaukee Road get prominent display on the signage as you approach that interchange. In addition to the directional signage, there will also be a number of blue service signs installed that will identify the hotels, restaurants and service stations providing services at that interchange. Hopefully, by the next meeting we will see a number of the revisions that will begin to get the signage plan into final form.

SPRING TREE PLANTING

The City of Beloit's Department of Public Works is accepting requests through Friday, May 30, 2014 from residents for terrace trees to be planted this spring. The terrace tree species selection will be determined by the City Forestry Supervisor, taking into account the size of the terrace, presence of utilities, and exotic invasive insects. Trees will be planted on a first-come, first-served basis. To be placed on the list, please call the Department of Public Works at 608-364-2929.

A press conference was held at 12:30 p.m., followed by a luncheon and business meeting that continued throughout the afternoon. As the host community, I had an opportunity to address the assembled Mayors and City Managers from around Wisconsin and presented them with a brief PowerPoint that illustrated the wonderful Beloit story of how an old industrial city recovered from the economic adversities of the 1970's and 80's to create a modern high quality urban place.

3. SPECIAL ORDERS OF THE DAY/ANNOUNCEMENTS

- a. Motion to accept resignation of Councilor Leavy. The City received an e-mail resignation from Councilor Kevin Leavy, which will undoubtedly be accepted with regret. Kevin is currently the longest serving City Councilor and has completed over 10 years of service to the City. Please note that the resignation is not effective until May 31, 2014. Therefore, Councilor Leavy will be participating in the balance of the City Council meeting.
- b. Presentation of Plaque to **Kevin Leavy**. The Council President will present a plaque to Councilor Leavy to recognize his extraordinary record of service to the City of Beloit.

4. PUBLIC HEARINGS

- a. Resolution authorizing a **Conditional Use Permit** to allow an Outdoor Seating Area and the outdoor sale, possession, and consumption of alcohol for a property at 1901 Liberty Avenue, to be operated as Clara Bo and Gatsby Wine Bar. This application was received and processed for the new business that will occupy the former Liberty Inn building at this address. A great deal of work and effort has been invested in the building and an outdoor seating and sales area would be integral to the operation. A variance needed on the type of fence the owners desire was approved by the City's Board of Appeals and the Plan Commission unanimously recommended approval of the Conditional Use Permit.

6. CONSENT AGENDA

- a. Approval of the **Minutes** from the Regular Meeting of May 5, 2014.
- b. Resolution approving an **Amendment to the Class "B" Beer and "Class B" Liquor License** for the new restaurant and wine bar business to be located at 1901 Liberty Avenue. This license amendment would permit the outdoor sales in the seating area and will only be considered by Council if the Conditional Use Permit is approved.
- c. Application for the renewal of a **Class "B" Beer and "Class C" Wine License** for Salvador's Restaurant, located at 907 Bayliss Avenue. This is the annual renewal of this license, which was not processed earlier due to the late arrival of this renewal application.
- d. Resolution awarding **Public Works Contract** for Street Resurfacing. This is the first street maintenance contract awarded in 2014. As Councilors are aware, there are additional funds available for street maintenance in the City's Capital Spending Plan for 2014. Plans are being prepared for a significant amount of concrete street repairs and we also have some crack filling and other major maintenance operations that come from this account. We hope to have a second round of asphalt street repairs later in the season, contingent upon the funding remaining from this account after the completion of other needed maintenance.

7. ORDINANCES

- a. Proposed Ordinance to repeal and recreate Chapter 10 of the Code of General Ordinances relating to the **Electrical Code**. Because of the extent of the redrafting and reorganization of the City's Electrical Code,

this draft ordinance was not red-lined, as is our normal practice. Therefore, the staff report contains an unusually detailed listing of all of the modifications included in the new proposed ordinance. Councilors will note that the most significant change is to remove the local licensing requirement, because of recent statutory changes, which prohibit local municipalities from licensing electrical contractors. While revising the ordinance to adapt to the change to the new statute, staff and the City Attorney's office both reorganized and modernized some of the old provisions included in the Ordinance. This item is on the agenda for a first reading only at this meeting.

- b. Proposed Ordinance to amend sections of the Municipal Code related to the **Wastewater Pretreatment System**. This is a relatively minor change to the regulatory ordinance requiring an addition to the year-end compliance report to include a list of all environmental control permits held by the user. This modification was required by the Wisconsin Department of Natural Resources, based on a recent audit of the sewer system operation.
- c. Proposed Ordinance to establish a **3-hour Parking Time Limit** in most of the parking stalls in the City's Public parking lot which serves the Angel Museum. In reviewing the site, I noted that 3-hour parking signs have been installed there for some time and apparently this ordinance would codify those existing restrictions. The matter was reviewed by the Traffic Review Committee and is recommended for approval. This item is on the agenda with a request for a suspension of the rules for second reading and adoption.
- d. Proposed Ordinance to establish **No-Parking** on a portion of Ironworks Drive and Third Street in the Ironworks campus. The no-parking area would be along the curb and has created safety problems for traffic, not only utilizing the roadway but entering and exiting parking lots in this area. Plenty of parking is available in the adjacent parking lots, but often drivers hunt for the closest location. Once again, the Traffic Review Committee has recommended for approval and this item is on the agenda with a request to suspend the rules for second reading and adoption.

8. APPOINTMENTS

Council will have appointments at this meeting.

10. CITY MANAGER'S PRESENTATION

This evening we have two presentations to share with Council. Both are brief enough to fit comfortably within the time period normally associated with a regular City Council meeting and include important information for Council and the community.

- a. **Parks and Recreation** presentation on summer activities. This is the annual spring presentation from Parks and Leisure services, outlining the parks facilities and programs available within the City as well as the recreation programs planned for this coming summer season.
- b. This is our annual **Code Enforcement** presentation, which is also done in the Spring of each year to provide property owners and residents with updated information regarding the City's Code Enforcement activities.

11. REPORTS FROM BOARD AND CITY OFFICERS

- a. Resolution authorizing the Schedule of Fees for Chapter 10 of the Code of General Ordinances for the City of Beloit related to the **Electrical Code**. This resolution establishes the fees for the above introduced Electrical Code. We realize that Council will likely not have acted on final adoption of the Code change; however, for over a decade the City has had a separate fee resolution in place that incorporates the fees for various municipal services. Because it has been so many years since it was updated, the Electrical Code still included those fees in the Ordinance. The fees, as presented, are unchanged, merely being moved from the Ordinance to a Resolution. The only addition is a re-inspection fee for no-shows in the amount of

\$15.00, which has been added to the schedule. While there is no separate staff report attached, information regarding the fee schedule resolution is included in the staff report with the proposed change to the regulatory ordinance. If you look under key issues, bullet point #4, Section 10.04 deals with fees and indicates that the fees have been moved to an accompanying fee resolution per existing City policy. Since we currently have an electric code in effect, Council can act on this resolution rather than wait until the new ordinance is approved.

- b. Resolution approving an attempt to fill a **Vacancy in the Office of City Councilor**. As provided for in Section 1.06 of the City's Municipal Code, when a vacancy occurs in a City Council seat with more than six months remaining on the term, Council must fill the vacancy. The Municipal Code provides a detailed process for how that is to be done. If, for some reason, Council opts not to follow the appointment process, then a special election must be called and held to fill the seat (per state law). The staff report was prepared by the City Attorney's office, and includes a detailed explanation of each provision of the Municipal Code, as well as the State Statute, a copy of which is attached in the packet for the Council's information. As you will note, the resolution proposes to fill the vacancy by appointment utilizing the procedures established in Section 1.06 of the Municipal Code. If approved by Council, all applications would be submitted by 5:00 p.m. on June 4, 2014 with a City Council meeting scheduled the following day, June 5, 2014 at 6:00 p.m. for the purpose of reviewing applications and selecting finalists. At that public meeting, the City Clerk would also select the order of interview by drawing lots. The interviews themselves would be scheduled for Monday, June 9, 2014 at 6:00 p.m. All meetings related to the selection process would be held in the Forum at City Hall and open to the public. Candidates applying for a position, per the provisions of Section 1.06, will be sequestered and not allowed in the interview room until their interview time. Attached to the resolution is a copy of the notice to the public, which will appear in the local paper on Tuesday, May 20, 2014 if the resolution is approved by Council, along with the application form for appointment to Beloit City Council which must be completed by all interested applicants and submitted to the office of the City Clerk by the deadline specified.

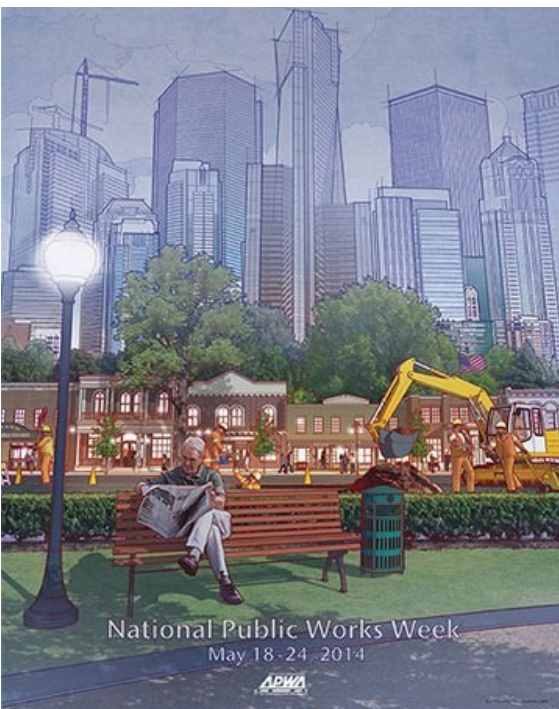

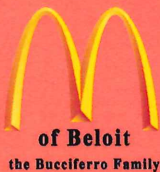
