### REGINA HENDRIX APPOINTED TO FILL VACANCY ON БЕЛОIT CITY COUNCIL

Following interviews with six finalists for the Council vacancy created by Councilor Leavy's resignation, the City Council voted initially in a tie, with three votes going to Regina Hendrix and three votes for Dorothy Harrell. After Mrs. Harrell withdrew from consideration, the Council voted by acclamation to select Regina D. Hendrix to fill the unexpired term on the City Council. Her term of office will expire on April 21, 2015. Councilors thanked all six of the candidates for their interest in the City of Beloit, and encouraged them to continue to be active and involved citizens, helping to keep our great City a wonderful place to live, work and play.

The reception, awards, exhibit and sale are all scheduled for Friday, June 13, 2014 from 5:00 to 8:00 p.m. at the Beloit College Hendricks Center for the Arts, 409 Pleasant Street in downtown Beloit.

### 2015 BUDGET PREPARATION

While City staff continues to work on their initial budget submittals, the City has the next public workshop scheduled for **Monday, June 16, 2014 at 5:30 p.m.** to 6:30 p.m. The workshop will be a prelude to the regular City Council meeting and will be held in the Forum at City Hall, 100 State Street. The subject will be a preview of various City policies, including an update on changes to the City's fund balance and how that will impact the General Fund budget preparation.

### WORKSHOP SCHEDULED FOR MONDAY, JUNE 30, 2014 REGARDING MUNICIPAL COURT FINES AND SANCTIONS RELATED TO JUVENILE OFFENDERS

Some weeks ago, a group of residents approached the City Council, questioning the process used by the Municipal Court to sanction juvenile offenders for various offenses. City staff, in consultation with the Municipal Court, have been doing research and preparing information related to the subject. A Council workshop will be held on **Monday, June 30, 2014 beginning at 6:30 p.m.** in the Forum at City Hall, 100 State Street to further discuss this issue. Representatives from the City and the court will have a presentation on the numerous programs and alternatives available for repeat juvenile offenders, and will explain more about court operations, as well as the truancy and day time curfew enforcement. There will be ample opportunity for questions and discussion. The City Council, of course, will be present to participate in the discussion.

## **INTERSTATE 39/90 UPDATE**

Earlier this week, we once again traveled to Madison to participate in a design team meeting related to the Interstate 39/90 widening and the I-43 interchange reconstruction. Much of the discussion centered around engineering details related to radii separations and minor design details that all have to be resolved before the project will receive Federal Highway Administration approval to actually begin the plans and specifications for construction. We were advised at the meeting that traffic studies at both the entrance to Kerry Ingredients and the new Gateway-Milwaukee Road intersection do not meet warrants for traffic signalization. We understood that the entrance to Kerry would not likely generate sufficient traffic to warrant signalization, but were somewhat surprised at the Gateway-Milwaukee intersection. City Engineers will also take a look at the data and further evaluate whether a signal should be installed at this location as part of the initial construction. The designers did not have the updated signage plan available for this session and anticipate that plan will be reviewed in July.

The next community meeting will be held in Beloit the first week of August. We will have an exact date, time and location, hopefully in time for next week’s Beloit Report. This will be the next opportunity for the public to get an update on the status of design planning to date and an opportunity to ask questions and to comment on any aspects of the project about which you have an interest or concern.

## **NORTHSTAR RADIOISOTOPE READY FOR PHASE ONE CONSTRUCTION**

We had a recent meeting with the NorthStar team regarding the status of their business development. The

company is in a bit of a rush to get the first phase of their construction underway. That initial building will be a 50,000 sq. ft. combination office and support facility. Future phases, including the actual linear accelerator building that will be used for production, will be constructed at a future date. City staff has been working this week on getting the Development Agreement modified for this latest project alteration and will also be working with the company and its' designers to get their project to construction as soon as possible.

#### **4. PUBLIC HEARINGS**

- a. Proposed Ordinance amending the Future Land Use Map of the **City of Beloit Comprehensive Plan** to change the future land use designation of the property located at 308 W. Grand Avenue from Single-family Residential, Urban, to Office. This Comprehensive Plan amendment accommodates an additional parcel of land purchased by an office use at this location. The Comp Plan is being amended to reflect the reality of the new use of this parcel. City staff and the Plan Commission have both reviewed and concur in this request. The Plan Commission recommended for approval. The Ordinance is on the agenda for a Public Hearing, followed by a request to suspend the rules for second reading and adoption.

#### **6. CONSENT AGENDA**

- a. Approval of the **Minutes** of the Regular Meeting of June 2, 2014.
- b. Resolution approving renewal of a **Class "B" Beer and "Class C" Wine License** for Salvador's Restaurant, located at 907 Bayliss Avenue. This was a late submittal for a routine annual license renewal. The Alcohol Beverage License Control Commission (ABLCC) has recommended for approval.
- c. Resolution approving renewal of a **Class "B" Beer and Reserve "Class B" Liquor License** for BMC Property Management, d/b/a Rivals Sports Bar and Grill, 443 East Grand Avenue. This was a late submittal for a regular annual license renewal. The Alcohol Beverage License Control Commission (ABLCC) has recommended for approval.
- d. Resolution approving **Change of Agent** for The Alibi, 1180 Madison Road. The Alcohol Beverage License Control Commission (ABLCC) has reviewed the request and recommended for approval.

- e. Resolution approving **Change of Agent** for CVS Pharmacy, 2149 Prairie Avenue. The Alcohol Beverage License Control Commission (ABLCC) has reviewed the request and recommended for approval.
- f. Resolution approving **Change of Agent** for Beloit Express, Inc., d/b/a Holiday Inn Express, 2790 Milwaukee Road. The Alcohol Beverage License Control Commission (ABLCC) has recommended for approval.
- g. Resolution approving **Improvements** within Riverside Park-West, located at 1055 Third Street. This particular resolution authorizes the installation of a small boat dock at this location. This project will be funded with TIF #14 revenue and was included in the City's Capital Spending Plan for 2014. The Plan Commission has recommended for approval.
- h. Resolution setting a date for a Public Hearing for the **Vacation** of Milwaukee Road Frontage in the City of Beloit. This request is from the School District of Beloit and is supported by the City's Planning staff. A portion of the frontage road in front of the new Fruzen Intermediate School currently under construction would be vacated. The property would be used by the School District for access drives to enter and exit the new facility. City staff supports this request, which would result in the internal driveway system for the new Intermediate School being located on School District property. This item is on the agenda for referral to the Plan Commission for their review and recommendation.
- i. Resolution authorizing the City Manager to apply for the **National Clean Diesel Grant** through the Leonardo Academy that provides for the reduction of Diesel Emission and Fuel Consumption. City staff recently learned of this grant opportunity. The grant would be used to cover a portion of the cost for new trucks included in the City's budget for acquisition this year. Because of the grant deadline, the City Manager authorized the submittal a few weeks ago, contingent, of course, on Council's final approval of the grant application process. Councilors will recall that from time to time, to meet deadlines we have submitted the necessary applications and then forwarded the resolution for Council consideration. We are still a ways from receiving the grant and if Council, for whatever reason, did not want to move forward with the application process, it would obviously be withdrawn.
- j. Resolution approving the conveyance of a **Utility Easement** to the City of Beloit. This easement is located at the corner of the intersection at 856 Fourth Street. As noted previously, the property owner was making required improvements to the site and discovered a traffic signal cable crossing his property. The easement has been agreed to between the City and the owner which will allow the cable to remain in that location.
- k. Resolution awarding **Public Works Contract C14-12** Soil Cap for 202 Shirland Avenue. Councilors will recall that this is the old service station property that we purchased to add additional space to the Wastewater Treatment System's pumping station located on Shirland Avenue. All of the demolition on the site has been completed; however, the final soil cap needed on the site was deferred, pending Department of Natural Resources permits for the work. The remaining concrete on the site will all be removed and a clean dirt cap will be placed on top and property seeded at the conclusion of the process.
- l. Resolution releasing City's **Right of First Refusal** and waiving lease restrictions on property located at 2555 Kennedy Drive. This parcel was sold by the City back in the 1980's for an industrial development and has had a building on it since that time. The building set vacant during portions of the great recession and now has a buyer with a tenant and the project is ready to go to closing. Unfortunately, the buyer's attorney discovered an old covenant included with the title that, first of all, gave the City a right of first refusal for buy-back on the property and second of all, prohibited renting of buildings in the Industrial Park. The first covenant, the right of first refusal, was done routinely and is still used to protect the City from a developer/speculator buying the property from the City at a discounted "incentive" price, promising a specific development and then later selling the land itself for a profit for another unrelated project. The ones that we

use in more contemporary times expire once the construction is completed on the site. This one had no expiration date and will need a specific waiver by Council for the closing to proceed.

The second provision in the covenant prohibited renting of buildings. While this is a very common practice in Industrial parks all over the United States, at the time this park was developed City officials did not want developers buying and building structures on speculation and then later renting the space to tenants. Again, this is a very common practice in industrial development, but at the time City officials felt that they wanted owner occupants only in the industrial park and all the sites were initially sold to owners that actually occupied and run their businesses on the parcel of land. Obviously, we have an opportunity here to sell, reoccupy and create jobs on a parcel by establishing an owner tenant relationship, which would be very much in the interest of the City, as well as of industrial owners in the park. Councilors will also need to act to waive this specific provision in the covenants in order for this project to proceed to closing.

## 7. ORDINANCES

- a. This is the second reading for a proposed ordinance to establish an inspection and permitting program for **Private Wells** operated within the City's Water Utility Service area. The program as described in detail is being implemented under mandate from the State's Department of Natural Resources. . Councilors will note that we did make a substantive change regarding the fees related to the permits. We were reviewing that section following Council's comments at the last meeting and an earlier workshop, and the City Attorney once again noted that we were inserting fees into the ordinance when, in fact, current City policy is to do all of our fees via resolution. Consequently, we removed the amount and authorized the fee by ordinance. The specific amount will be set by resolution that will follow later on the agenda.

## 11. REPORTS FROM BOARD AND CITY OFFICERS

- a. Resolution adjusting award amount and authorizing **Final Payment** of the Public Works Contract for the 2013 Street Resurfacing program. Councilors will note from the staff report that we ended up spending somewhat more than the original contract amount, in part because upon excavation a number of base problems were identified that were not previously known by the Engineers. We also added two paving projects to the bid; one to resurface Reynolds Drive and a second to redo a number of the driveways in Big Hill Park. The driveways in Big Hill Park were seriously deteriorated condition and all needed resurfacing. Some work was anticipated for 2013, with the balance to be completed in 2014. Splitting the work was not practical, and while the contractor was mobilized and on site, we wanted to complete all of the paving projects. An arrangement was made to pay for this cost out of the street resurfacing budget with a "payback" which would come from the Parks Improvement Capital Budget for 2014. That modification allowed all of the driveways in the park to be resurfaced; however, contributed to the amount expended on this project exceeding the original contract limits. Reynolds Drive was not initially on the list for resurfacing; however, the new owners who had just spent a significant amount of money completely remodeling the former Alcoa Industrial Complex called the condition of the street to the City's attention. Upon examination, it was clear that the seriously deteriorated condition would adversely influence their ability to lease or sell the property for a new industrial user. Consequently, the roadway was added to the paving contract and it was done on a relatively tight timeline to support the new owners' marketing efforts. Since this contract did go over the original authorized contract amount, Council President asked that it be placed under item 11 for additional discussion.
- b. Resolution for **Fees** for Private Wells. As noted above, we pulled the actual fee amount out of the ordinance and inserted it in the resolution. We also added a second enacting paragraph, which notes that the fees will be waived for any completed permit applications that are received by December 31, 2014. That should allow sufficient time for a waiver of fees with the first permitting process.
- c. Resolution authorizing the City Manager to enter into a Wisconsin Economic Development Corporation (WEDC) Idle Industrial Sites Development **Agreement** with Hendricks Commercial Properties. This is the

agreement that facilitates transfer of the Wisconsin Economic Development Corporation grant that was awarded to assist with the redevelopment of the Ironworks Campus.

- d. Resolution amending the **2014 Capital Budget** for the WEDC Idle Industrial Site Grant Project. This money has to move through the City's books, so consequently will require a supplemental appropriation to the City's 2014 Capital Budget. Since this is a "pass through" of a grant amount, it will have no impact on other projects or City operations.
- e. Resolution approving **Compliance Maintenance Annual Report**. Every year the Wastewater Facility was required to go through a fairly extensive compliance report to ensure that all operations meet or exceed the operating permit standards for the facility. As you will note, the City received a very high score on the report and no other capital expenditures or changes to operations are necessitated based on the final compliance score.
