HERITAGE DAYS WEEKEND

This coming weekend is again Heritage Days in the City of Beloit and many interesting activities are scheduled, particularly at the various historical museums, as well as the Wright and Logan Museums on the Beloit College campus. ROY CHAPMAN ANDREWS HISTORIC SIGN DEDICATED

This evening, City officials and representatives from the Roy Chapman Andrews Society will meet on the south tip of Turtle Island, to unveil and dedicate a sign commemorating Roy Chapman Andrews, one of Beloit's most interesting historical figures who became world renowned for his exploits in Mongolia and other remote locations, where he discovered dinosaur eggs, numerous fossils, and contributed much to the archeological record.

The dedication is scheduled for **5:30 p.m.** and is open to the public.

DOWNTOWN BELOIT ASSOCIATION BANS PETS FROM THE SATURDAY MORNING FARMERS' MARKET

The DBA Board voted a few weeks ago to ban pets (other than service dogs) from the organization's Farmers' Market, held each Saturday morning throughout the season on State and Grand streets downtown. The Board received considerable input, both pro and con, regarding the decision and met recently to consider those comments and also reconsider the ban. The Board once again voted to move forward with the ban on pets at the Farmers' Market, to take effect tomorrow, Saturday, September 6, 2014. Considerable effort has been made to communicate with pet owners and the number of pets appearing each week at the market has dropped significantly. The DBA requests the cooperation of all shoppers. Please leave your pet at home for the brief period required to shop at the market.

KNOCK ON YOUR DOOR TO BE AUCTIONED ON SEPTEMBER 12, FROM 6:00-8:00 PM

The doors that were specially painted by local and regional artists and placed throughout the City will be collected next week and placed on display in the Beloit Historical Society, 845 Hackett Street. Next Friday evening, September 12, 2014 from 6:00—8:00 p.m., all of the doors will be auctioned to interested businesses and individuals, with the proceeds donated to the Angel Museum. Many of the doors were beautifully done and, if you're interested in acquiring a rare piece of original art while supporting the Angel Museum, this will be a unique opportunity.

COLLABORATION WITH BELOIT CHAPTER OF NAACP REGARDING ESTABLISHMENT OF A YOUTH DROP-IN CENTER IN THE CITY

Last week, I met with Birdia McAlister, president of the NAACP Beloit Chapter, who brought in a proposal to establish a youth drop-in center, somewhere in the City of Beloit. While we have many organizations from the YMCA, the Boys and Girls Club, the Merrill Community Center, the City's Leisure Services programs and, of course, after school structured activities, there is still concern that there are not adequate late afternoon and evening

activities available for teens in the community. We had a very interesting discussion and I followed up with communications with various other municipal leaders looking at where such a program could be domiciled, how we would get young teens to and from the facility, and what kind of programming could be made available. Obviously, the goal would be to get such a facility open as soon as possible, so we have been looking for a site that could accommodate such a program without requiring many months of lead time to remodel and repurpose another building and purchase equipment and furnishings. Follow up communication will continue with the leadership of the NAACP, as well as other community leaders and teens in the immediate future in an effort to get such a facility operational.

FALL TREE PLANTING

The City of Beloit's Department of Public Works is now accepting requests from residents for terrace trees to be planted this fall.

The terrace tree species selection will be determined by the City Forestry Supervisor, while taking into account the size of the terrace, presence of utilities and exotic invasive insects. Trees will be planted on a first-come, first-served basis. Public Works will accept requests through Friday, October 17, 2014.
