CURRENT EVENTS AND ACTIVITIES

BUDGET PREPARATION

Work on the 2015 proposed Operating, Library and Capital Improvements Budgets will continue this coming Monday, **October 13, 2014 with a full day workshop** from 8:00 a.m. to approximately 5:00 p.m. to provide an opportunity for Department and Division Directors to individually present their budget submittals to the City Council. The budget workshop will be held at the Beloit Public Library, 605 Eclipse Blvd. in the Community Room and is open to the public. Please see attached workshop agenda.

Just a reminder that the actual public hearing on the budget is scheduled for **Monday**, **October 20**, **2014** as part of the regular City Council meeting in the City Hall Forum, 100 State Street.

SPECIAL CITY COUNCIL MEETING TO FOLLOW WORKSHOP

We have scheduled a **Special City Council Meeting** following the conclusion of the Budget Workshop **on Monday, October 13, 2014** (meeting notice <u>attached</u>) for Council's consideration of two items. The first, a resolution on the agenda authorizes City staff, through special Counsel, to file an appeal of the City's 2014 equalized assessed valuation to the State Tax Appeals Commission. The City filed an appeal on our 2013 commercial assessments, which is still pending. Although the State Department of Revenue suggested that this matter could be settled, (it should have been settled initially) we have not received a good faith response from the Department regarding additional submittals made to document property values for that year. Consequently, our consultant and special counsel have recommended that the City also appeal its 2014 commercial equalized assessed valuations, since it was impacted adversely by the earlier 2013 commercial assessment reduction. Special counsel would aggregate both cases and request a single hearing before the Tax Appeals Commission. In order to move forward with the second appeal, the Council resolution is required.

The second item would be to recess into **Closed Session** to hear a briefing from the City's Economic Development Director regarding the status of negotiations with a potential land purchaser and economic development prospect for the City. This session will be for briefing purposes only, and no formal action of Council is requested at this time.

UPDATE ON PLAN TO ESTABLISH A YOUTH DROP-IN CENTER

Thursday, October 9, 2014, the Task Force that has been formed to explore and hopefully establish a Youth Drop-In Center in Beloit met for its first formal working session. The meeting was held at the Boys and Girls Club, and the Task Force heard a presentation from Fred Buggs, Chief Professional Officer, regarding what is needed for a successful Teen Center operation. The Task Force had a good, open discussion and a number of ideas and suggestions came forth for follow up evaluation. The Task Force formed several subcommittees to do further research on elements of the plan and set the next meeting for Wednesday, October 22, 2014 at the Boys and Girls Club.

FALL TREE PLANTING

The City of Beloit's Department of Public Works is accepting requests from residents for terrace trees to be planted this fall.

The terrace tree species selection will be determined by the City Forestry Supervisor, while taking into account the size of the terrace, presence of utilities and exotic invasive insects. Trees will be planted on a first-come, first-served basis. Public Works will accept requests through Friday, October 17, 2014. 
