LEGISLATIVE BRIEFING

As we do following each general election, the City held a Legislative Briefing for our newly elected State legislative delegation. Senators—elect Ringhand and Nass, along with re-elected Representative Loudenbeck, were in attendance. The session was to provide an overview briefing on the City of Beloit, including an update on the community, our budget and financial situation, economic development and job creation needs, as well as a quick overview of the League of Wisconsin Municipalities Legislative Agenda for the coming year. The briefing also includes a reference book of materials that the legislators can use from time to time if they need information about the City. As always, the delegation was very attentive, asked a number of questions, and I want to take this opportunity to express our sincere appreciation for their attendance and their coming service to the residents of the City of Beloit.

- a. Approval of the Minutes of the regular and special meetings of November 17, 2014.
- b. Application for a **Class "B" Beer and Reserve "Class B" Liquor License** for Eclipse Event Center, 100 Eclipse Center. This application will replace an existing license at the facility and is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.
- c. Application for a **Class "B" Beer and Reserve "Class B" Liquor License** for Lucy's #7 Burger Bar. This is a new business that will be located at 430 East Grand Avenue in the Phoenix building. The application is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.
- d. Application for a **Planned Unit Development—Master Land Use Plan** for property located at 2250 West Hart Road, for a proposed Assisted Living Facility. This is a portion of the original Park Meadow North

subdivision. This area was platted but never developed as single family homes. It is a relatively large parcel and an Assisted Living Facility would fit nicely at this location. I'm sure the developer's also noted the proximity to nearby medical facilities, as well as shopping opportunities. This item is being referred to the Plan Commission for their review and recommendation.

- e. Application for a **Zoning Map Amendment** to change the zoning district classification of the property located at 1400 Frederick Street from Single-family Residential to Public Lands and Institutions. This application is for a partial parcel purchased by the School District to add parking and related facilities for McNeel Intermediate School. The request will be forwarded to the Plan Commission for their review and recommendation.
- f. Application for a 2-Lot **Certified Survey Map** for the properties located at 1400 and 1524 Frederick Street. This is an accompanying request for the same parcel in order to facilitate School District use of the land. This item has also been referred to the Plan Commission for their review and recommendation.
- g. Resolution approving **Final Payment** for Public Works Contract for Concrete Pavement Repairs that were made in 2013. The work is not complete and the contract ready for final payment.

7. ORDINANCES

- a. Proposed Ordinance to remove the **No-Parking restriction** on Hobart Place. Because of the narrowness of the street and limited access into Hobart Place, the City staff had recommended against removing the no-parking restrictions. After consideration of the request and hearing from neighborhood residents, the Traffic Review Committee recommended for approval of the resolution.
- b. Proposed Ordinance to add **No-Parking regulations** on Lovell Avenue. This item was referred by the Traffic Review Committee, which recommended for approval.

10. CITY MANAGER'S PRESENTATION

a. Annual Snow and Ice Control Plan Presentation from the Public Works Department. We have obviously noted that, although it is normally timely to give this presentation at the first meeting in December, this year we are already past our second winter storm event. Nevertheless, the presentation contains valuable information about the ice control and snow removal plans that are in place in the City, as well as resident requirements for parking during declared Snow Emergencies and sidewalk clearing requirements.

11. REPORTS FROM BOARD AND CITY OFFICERS

- a. Resolution amending the Mutual Cooperation Agreement under the National Affordable Housing Act. This is the Intergovernmental Agreement (IGA) that oversees our participation in the HOME program. The staff report provides detail on the need to make an amendment to the IGA because of two changes being made that directly affect the City of Janesville and Rock County. Some surplus funds are being transferred from Rock County to the City of Janesville so that they can be expensed under guidelines provided for in the Act. The other change to the Agreement provides more flexibility in how some of the funding awarded to the Community Action Agency is actually expensed. The Agency has been using funds in a manner fully compliant with the HOME grant program, but not specifically covered in the IGA. Again, these changes do not directly impact the City of Beloit. Nevertheless, we are a signatory of the contract and need to approve the amendment.
- b. Resolution adopting a **Meet and Confer Agreement** between the City of Beloit and the Beloit Police Supervisory Association. Negotiations between the City and the Beloit Police Supervisory Association have concluded. The terms of the Agreement are the same as the Agreement recently approved between the City and the Beloit Police Patrol Officers.

c. Resolution adopting a **Collective Bargaining Agreement** between the City and the Transit Union. Transit workers are the only employees, other than Police and Fire, allowed to retain full collective bargaining rights following the adoption of Act 10. Our Transit workers have elected to remain represented and we have recently concluded negotiations, which provide for a new four-year agreement with increases similar to those in the recent Police contract. No other major changes are included in the proposal.
