#### **CITY MANAGER RECRUITMENT PROCESS**

The City Council met this last Friday, January 9, 2015 and interviewed three executive recruitment firms as a prelude to selecting a recruiter to assist with the upcoming City Manager search. Following those interviews, the Board voted unanimously to engage GOVHR USA as the consultant for this project. Heidi Voorhees, one of the co-owners will be working with Council and coordinating the search for candidates.

The first phase of the process is to develop a recruitment profile and a job notice. This process will be coordinated next Wednesday, Thursday and Friday, when the consultant is in town to meet with community leaders and public officials. Ms. Voorhees will be doing personal interviews with all seven City Councilors, all Department Directors, the incumbent City Manager, and the City Manager's staff, as well as holding meetings with various business and community leaders. This process will result in a written document that overviews the City for perspective applicants while at the same time listing traits and characteristics that the community feels will be highly desirable in their next City Manager.

#### **Public Input Meeting**

Council has also requested that an open public session be scheduled so that any person with an interest in the City or the recruitment process will have an opportunity to share their thoughts on the traits and characteristics that the new City Manager will need to be successful in Beloit. The <a href="attached">attached</a> press release notes that the meeting will be held in the <a href="Community Room at the Beloit Public Library">Community Room at the Beloit Public Library</a>, 605 <a href="Eclipse Blvd">Eclipse Blvd</a>. at 6:30 p.m. on <a href="Thursday">Thursday</a>, <a href="January 22">January 22</a>, 2015. Again, all residents and other persons with an interest in the recruitment process are urged to attend.

#### City Conducting a Survey to Obtain Citizen Input

For residents who are unable to attend the open session, a survey has also been prepared and is posted to the City's website. Simply go to <a href="www.beloitwi.gov">www.beloitwi.gov</a> and you will see a link directly on the home page to the survey. Residents may want to both attend the public meeting and complete the survey. We certainly would like to encourage as many interested parties as possible to complete the survey to assist Council in their development of a recruitment profile that will be used for this important process.

Following the conclusion of this series of meetings and interviews, the consultant will prepare the documents over the weekend and returning those for Council review during the following week. Following Council's approval, the notices will begin

appearing on various websites and publications frequented by public administrators, particularly those that have city management experience. The consultant will also be sending out invitations to a broad array of trained managers and administrators that they have become acquainted with over the years. There will be subsequent meetings with Councilors to screen and select candidates for interviews, and interviews will be scheduled probably not until late March, following the initial outreach and recruitment effort.

#### MLK DAY CONVOCATION SCHEDULED AT BELOIT COLLEGE ON MONDAY, JANUARY 19, 2015

Beloit College will be holding their traditional Martin Luther King, Jr. Day Convocation on Monday, January 19, 2015 beginning at 4:15 p.m. in the College's Eaton Chapel, 700 College Street. The convocation this year will feature an address by Regina Hendrix, entitled "A Dream Deferred?". Ms. Hendrix grew up in the City of Beloit, and has been very involved in community and youth activities. In addition to being on staff at Beloit College, she currently serves on the Beloit City Council. The Convocation is open to the public.

#### TEEN CENTER PLANNING CONTINUES WITH A "PARTY AT THE CLUB"

A "Party at the Club" is scheduled for Saturday, January 24, 2015. The Task Force planning for the possible establishment of a youth teen center here in the City of Beloit has scheduled an event as a means of gauging interest in such a facility on the part of our teen population. The event has been named "Party at the Club" and will involve numerous activities, as well as access to all club facilities. The event is scheduled for Saturday, January 24, 2015 at the Boys and Girls Club, 1851 Moore Street, and will be separated into two parties. Students in grades 7 and 8 will be welcome from 5:00—7:00 p.m. and students in grades 9-12 will begin their party at 8:00 p.m., running until 10:30 p.m. This will be a great opportunity to see firsthand what a Teen Center would look like; the breadth and variety of facilities that will be available for teens to use, and to sample some of the types of programming that would be offered intermittently at such a facility. #### SPRING PRIMARY NEEDED IN THE CLINTON SCHOOL DISTRICT PORTION OF BELOIT

A small portion of the far east end of the City of Beloit is located in the Clinton School District. The City was notified this past week that a determination has been made that a primary is required in that district. Consequently, the City Clerk's office will be holding a primary election on February 17, 2015 in Wards 23 and 24. This primary will impact only about 300-500 residential units in the City of Beloit; however, the polling place for those wards will remain open the entire day as required by State Law to facilitate participation in the primary voting by eligible residents who reside in the Clinton School District. #### I-39/90 UPDATE

The I-39/90 Planning Committee met again this past Tuesday and the project continues to progress on schedule. We were very happy to see that submittals for various planning details made by the committee to the Department of Transportation officials have been approved, which included the use of signalized intersections as opposed to traffic circles, and provided for the extension of Hwy. 81/Milwaukee Road east all the way to Hart Road, so that both the east and west sides of the interstate will be directly connected with arterial access. The project is nearing completion of this phase of design and will soon be submitted to the Federal Highway Administration for formal approval. As part of that design process, a public hearing has been scheduled and will be held in the Community Room at the Beloit Public Library, 605 Eclipse Blvd. on **Wednesday**, **February 11**, **2015 from 5:00 p.m. to 8:00 p.m.** Residents and other interested parties are encouraged to attend and comment on the highway design project.

#### URBAN ALLIANCE TO HOLD STRATEGIC PLANNING SESSION

The City Manager was out of the community most of the day on Friday, attending a Strategic Planning session of the League of Wisconsin Municipalities Urban Alliance. The session was held in the City of Appleton.

  - a. Approval of the Minutes of the regular meeting of January 5, 2015 and special meeting of January 9, 2015.
  - b. Resolution approving a two-lot **Certified Survey Map** for the property located at 2036 Townhall Road. This resolution will divide what was formerly a single parcel into two lots.
  - c. Application for a **Zoning Map Amendment** to change the zoning district classification of a property at 1401 Townhall Road from Public Lands and Institutions to Development Holding District. This was the parcel that was previously owned by the Beloit School District and has been sold to a private individual; therefore, the zoning classification needs to be changed. The Development Holding District is the most restrictive of all of the City's zoning classifications, so that if the owner wishes to ever develop the site, it is likely they will need to apply to the City for an additional rezoning.
- 8. APPOINTMENTS—There are appointments on the agenda for this meeting.
- **10. CITY MANAGER'S PRESENTATION** —No presentations are scheduled for this meeting.

#### 11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution approving two contracts between the City of Beloit and **Dane County Humane Society, Inc.** Basically, these contracts will extend our service relationship with the Dane County Humane Society for a period of six (6) months. The organization has notified the City that they will no longer provide services to Rock County municipalities after that date.
- b. Resolution declaring **Doubtful Accounts**, authorizing amounts to be written off, and receiving and filing the 2014 Report of the Comptroller. Only three accounts are recommended to be written off, and those represent housing rehabilitation loans where the property was foreclosed and the individual has gone through a bankruptcy proceeding and been relieved of their repayment responsibilities. Consequently, these three loans are not recoverable. As we have previously noted, the bad debt represents a tiny percentage of the total outstanding loans, most of which are performing as expected. At the current time, there are 284 open loans in the program. The three being written off represent \$42,300 of the almost \$4.3 million amount outstanding at this time.
- c. Resolution authorizing the Issuance and Establishing Parameters for the Sale of \$1.265 million in **Storm Sewer System Revenue Refunding Bonds**. Once again, Ehlers and Associates has been monitoring the market place and noted that the interest rate spread is favorable for the City to refinance the Storm Water Sewer Loans, which were originally issued in the amount of about \$1.5 million. This would be a negotiated sale and City officials would be able to authorize the transaction when interest rates hit a point where the City would evidence the savings of at least 2.15% on projected debt service cost. Consequently, there would be no public bid or additional board action required to effectuate the refinancing. A representative from Ehlers will be in attendance at the meeting on Monday to further explain this process and why it is recommended for this particular refinancing.
- d. Resolution adopting a **Collective Bargaining Agreement** between the City of Beloit and the International Association of Fire Fighters (IAFF). Following an approval of an agreement with the bargaining unit representing Police Officers, we

contacted the Fire Union, with whom we were still in negotiations, and asked about discussing the agreement between the City and the Police Officers, which included a revised plan for providing medical insurance coverage to future retirees. An all-day bargaining session ensued, and while we were not able to reach an agreement on the full package involving modifications to the retiree health care program, both parties agreed to the basic concepts included in the agreement with the Police Officers. The resolution on the agenda provides for a four-year contract with the Fire Fighters, including a 2% salary adjustment for 2014 (which will be paid retroactively); a 0% increase for 2015; 1% for 2016; and an additional 1% raise in 2017.

**January 12, 2015** – **Beloit, WI:** The Clinton Community School District has determined that a primary election will be necessary for the Clinton Community School Board election on April 7, 2015. This primary election will be held on February 17, 2015.

Portions of City of Beloit Wards 23 and 24 are located within the Clinton School District boundaries. Electors in Wards, 23, 24, and 25 regularly vote at Central Christian Church, 2460 Milwaukee Road. Central Christian Church will be open from 7:00 a.m. to 8:00 p.m. on Tuesday, February 17, 2015, for voters who live in the City of Beloit and in the Clinton Community School District to cast ballots for the Spring Primary Election.


