### UPDATE 01/19/15 Shooting Porter & Randall

The open investigation into the January 19th shooting that resulted in the death of Terez Herd has progressed to the point that, after conferring with the Rock District Attorney's Office, the following arrests were made or suspects identified:

Samuel Brooks, 25

Dajhaun Allen, 17

Antonio Henderson, 31



Samuel Brooks is currently incarcerated at the Rock County Jail on unrelated matters. On 04/29/15 Samuel Brooks was arrested at the jail by a Detective from the City of Beloit Police Department for the following:

- 2<sup>nd</sup> Degree Reckless Homicide (Violent Crime in a School Zone - enhancer)
- Substantial Battery
- Felon in Possession of a Firearm
- Discharge a Firearm (In a School Zone – enhancer)
