13TH ANNUAL ART WALK

The 13th Annual Art Walk comes to Downtown Beloit on Friday, May 15 from 5:00-9:00 p.m. and Saturday, May 16 from 10:00—2:00 p.m. Again this year there will be numerous artists in various businesses throughout Beloit's downtown. MANAGER COMPLETES EMPLOYEE BRIEFINGS

The City Manager has completed some 12 separate meetings with various groups of City employees, presenting an update on the first ten years of implementation of the City Center Plan. A PowerPoint presentation includes a mix of public infrastructure and private investment completed throughout the seven City Center Districts that were first identified in the City Center Plan, which was sponsored and facilitated by Beloit 2020. Following the presentations, the Manager also briefed employees on the upcoming transition to a new City Manager. The presentation has also been shared with the City Center Committee, the City Council, and several other local organizations, as well. CITY OF BELOIT RECEIVES RECOGNITION FROM THE ROCK RIVER COALITION

The Rock River Coalition has notified the City that we will be receiving an award, both for strategies the City has implemented to reduce salt usage, which ultimately ends up in the State's waterways, as well as the tremendous improvements that we have made along the Rock River, including the extensive flood mitigation and Shoreline Stabilization projects that have been completed in the last several years. Staff directly responsible for those program initiatives will be joining the City Manager at the Coalition's annual meeting and awards ceremony next week for the presentation. We will place this recognition on an upcoming agenda to share with the entire community.

LEAGUE OF WISCONSIN MUNICIPALITIES MEETINGS

Next Wednesday, May 13, the City Manager will travel to Madison to participate in a number of League sponsored activities. The League's Lobby Corps will meet at 9:30 a.m. to receive a briefing on legislative initiatives. Following that session, we will meet with our State Legislative delegation to review the League's legislative priorities. of the State Representatives and Senators are invited and the League discusses its legislative priorities. We also have guest speakers from among the legislative leadership explaining the status of various bills, particularly the budget bill undergoing review at the present time.

Following that luncheon, the Urban Alliance will meet during the afternoon, followed by a League Board meeting starting at 4:30 p.m. It will be a long day in Madison; however, this is a very critical time with the biennial budget bill moving through the Joint Finance Committee.

ECONOMIC DEVELOPMENT UPDATE

The new owner of the **Cub Foods building** has already begun some clean up and demolition work on the site on Park Avenue. A meeting is being arranged to go through proposed plans for the site. The new owner is very serious about completing most of the planned improvements to this building and site yet this year.

Pratt Industries continued with construction on their site in the Gateway Business Park. The City's structural engineer has concluded and approved their submittal for a building permit. The footing and foundation permits have been issued and only a few site plan issues remain to conclude review before a full building permit will be issued for the project.

Chicago Fittings is also continuing with their construction and **Buffalo Wild Wings** is also moving forward with the building renovation for their new restaurant on Milwaukee Road.

Lucy's Burger Bar opened for business on Grand Avenue and the sushi bar and grill is undergoing interior build out with an opening yet to be scheduled later this summer.

SPRING TREE PLANTING

The City of Beloit's Department of Public Works is accepting requests from residents for terrace trees to be planted this spring. The terrace tree species selection will be determined by the City Forestry Supervisor while taking into account the size of the terrace, presence of utilities and exotic invasive insects. Trees will be planted on a first-come, first-served basis. Public Works will accept requests through Friday, May 22, 2015.
