INDEPENDENCE DAY SCHEDULES

City offices will be closed on Friday, July 3rd in observance of Independence Day.

The Beloit Public Library, 605 Eclipse, and the Recycling Drop Off Center at 2351 Springbrook Court will be closed on Saturday, July 4 in observance of the Independence Day holiday.

SLOW-NO-WAKE DECLARED ON PORTIONS OF THE ROCK RIVER ON JULY 4TH

Rock County Sheriff Robert Spoden has declared a slow-no-wake speed restriction on the Rock River from the West Beloit Rock Town Line Road Bridge to the Portland Avenue Bridge on July 4 from 8:30 p.m. to midnight. Please see the attached press release for more information.

CITY COUNCIL MEETINGS - MONDAY, JULY 6, 2015

The City Council will hold a <u>Workshop</u> in the City Hall Forum, 100 State Street at 5:30 p.m. on Monday, July 6, 2015. The purpose of the workshop is to discuss preparation of the City's **2016 Budget**.

The City Council will hold a <u>Workshop</u> in the Forum Conference Room at 6:30 p.m. to review the agenda of the regular 7:00 p.m. City Council meeting.

The attached agenda is for the Monday, July 6, 2015 regular City Council meeting beginning at 7:00 p.m. in the Forum.

4. PUBLIC HEARINGS

- a. Resolution authorizing an amended Conditional Use Permit to allow expanded Contractor Office & Storage Yard uses in a DH, Development Holding District, for property located at 2100 Newark Road. The applicant has proposed the construction of a 3,000 square foot office and storage addition to an existing storage/shop building, along with temporary use of a converted manufactured home to be used as office space during the construction process. Since purchasing the property in 2014, the applicant has performed substantial clean-up. The Plan Commission reviewed this item and voted unanimously to recommend approval of the amended Conditional Use Permit, subject to conditions recommended by Planning staff.
- b. Resolution authorizing a Conditional Use Permit to allow a Rooming House in a C-1, Office District, for the property located at 1105 East Grand Ave. The applicant is seeking a permit to establish and operate a rooming house consisting of four sleeping rooms as well as one efficiency apartment to house a property supervisor. The City Council considered the application at a public hearing. The Plan Commission voted to recommend approval of the CUP, subject to conditions recommended by Planning staff.
- c. Public Hearing to Solicit Input on the Community Development, Housing, and Homeless needs in the City for inclusion in the **2016 Annual Action Plan** and Resolution approving 2016 Community Development Block Grant (CDBG) Local Funding Priorities. The City is in the process of preparing the 2016 Annual Action Plan for submittal to the Department of Housing and Urban Development to maintain eligibility for Community Development Block Grant funding. The Community Development Authority (CDA) board recommends that City Council approve funding priorities for inclusion in the 2016 CDBG application.

- b. Application for a **Class "A" Beer License** for Dave's Bait & Tackle, 901 Bayliss Avenue. This is a new business and the application will be referred to the Alcohol Beverage License Control Committee for review and recommendation.

- c. Resolution placing **Advisory Referendum** question on April 5, 2016 ballot. The City Clerk was served with a petition from "South Central Wisconsin Move to Amend" requesting an advisory referendum be placed on the April 5, 2016 ballot. The referendum question and information is included with the City Council Agenda packet, and available for review on the City's website.
- d. Resolution setting a date for a public hearing for the Vacation of Tuck-A-Way Lane Right-of-Way in the City of Beloit. The Planning and Building Services Division received a petition to vacate Tuck-A-Way Lane, which is a 142-foot dead-end street intersecting with Claremont Drive at the northern edge of the Parkmeadow North subdivision. A developer has received preliminary approval to construct a 100-unit assisted living facility, and has proposed private driveways connected that development to both Claremont Drive and West Hart Road in lieu of the public street known as Tuck-A-Way Lane. This item will be referred to Plan Commission for their review and recommendation.
- e. Proposed Ordinance to amend Sections 30.17(1)(b)2, (b)3, (b)6 and (b)7a of the Code of General Ordinances of the City of Beloit pertaining to **Electronically Variable-Message Signs**. Staff has drafted an Ordinance to amend four sections of the City's Outdoor Sign Regulations. The purpose of the proposed amendments is to allow the Central Christian Church on Milwaukee Road to use an Electronically Variable-Message (EVM) sign to notify the public of programs at the church. This item will be referred to Plan Commission for their review and recommendation.

10. CITY MANAGER'S PRESENTATION

- a. Presentation "**Hearing Loops Program**". Nick Dimassis, Library Director, will give a presentation and information on a grant awarded to several public libraries allowing public meeting rooms at the library to be fitted with a device to enhance the hearing experience for those who have hearing aids with T-coils.
- b. 2014 **Audit Report.** The City of Beloit's 2014 Comprehensive Annual Financial Report (CAFR) is available on the City's website. Representatives from Baker Tilly Virchow Krause, LLP will present their report on the audit to the City Council at the July 6, 2015 regular Council meeting. Slow-No-Wake Declared on Rock River for 4th of July Celebration

Following discussions with officials from the City of Beloit and Town of Beloit, Sheriff Spoden is declaring a slow-no-wake speed restriction on the Rock River from the West Beloit Rock Town Line Road Bridge to the Portland Avenue Bridge on July 4 from 8:30 p.m. to midnight. This area of the Rock River becomes very chaotic and dangerous due to the large number of boats on the Rock River for the 4th of July fireworks celebration. The slow-no-wake restriction will insure all boaters are traveling at a safe speed before and after the event.

The Sheriff's Office and Town of Beloit Boat Patrol units will be on the water on July 4th, and will be enforcing safety violations including the slow-no-wake ordinance.

The Sheriff's Office is providing public notice of the Rock River's Fourth of July's slow-no-wake status. Deputies will place slow-no-wake signs along the river at all public access points between the West Beloit Rock Town Line Road Bridge and the Portland Avenue Bridge the morning of July 4.

Boat Safety Tips

- When boating between sunset and sunrise navigation lights must be displayed.
 Navigation lights must be functional and meet visibility requirements, as required by state law.
- Boats anchored are required to display a white light visible in all directions.
- No other lights (including docking lights) may be used which could be mistaken for or interfere with those required above.
