### EMERALD ASH BORER (EAB) INFECTED ASH TREE REMOVAL

Mike Ferger, Forestry Operations Supervisor, advises residents that the City of Beloit is in the process of removing dead, hazardous ash trees from terraces that are infected with the Emerald Ash Borer. Homeowners are responsible for their yard trees, and photos of the common signs and symptoms of infestation are available on the State of Wisconsin EAB website: [www.emeraldashborer.wi.gov](http://www.emeraldashborer.wi.gov) or the City of Beloit's webpage: [www.beloitwi.gov](http://www.beloitwi.gov)

### FIRE HYDRANT FLUSHING

The City of Beloit Water Resources Division will perform their annual fire hydrant flushing program from July 27—November 1, 2015. This flushing program ensures that fire hydrants are in good working condition in case of emergencies, and to help flush sediment out of the distribution system.

Mike Tinder, Water Supervisor, cautions residents that you may experience discolored water, low water pressure or a disruption of service during this time period. He urges residents to reduce water use and consumption and wait to do laundry until after 6:00 p.m. during the flushing program. During evening hours, residents should open their cold water faucets until the water runs clear before using it. The water *is safe to drink* during this time period.

## CITY COUNCIL MEETING - MONDAY, JULY 20, 2015

The City Council will hold a **Workshop** in the City Manager's Conference Room at 6:30 p.m. to review the agenda of the regular 7:00 p.m. City Council meeting.

**4. PUBLIC HEARINGS**

- a. Proposed **Ordinance** to amend Sections 30.17(1)(b)2, (b)3, (b)6 and (b)7a of the Code of General Ordinances of the City of Beloit pertaining to Electronically Variable-Message (EVM) Signs. The purpose of the proposed amendments is to allow the Central Christian Church on Milwaukee Road to use an EVM sign to notify the public of programs at the church. After review and modification, the Plan Commission unanimously recommends for approval.

**6. CONSENT AGENDA**

- a. Approval of the **Minutes** of the regular meeting of July 6, 2015 and the special meeting of July 6, 2015.
- b. Application for a **Conditional Use Permit** to allow a single-family attached dwelling in C-2, Neighborhood Commercial District, for the property located at 911 East Grand Ave. The applicant owns the building with an animal grooming business located on the first floor. The applicant would like to convert the upstairs of the building, with the intention of living in the second story apartment. This item will be referred to Plan Commission for their review and recommendation.
- c. Application for a **Conditional Use Permit** to allow the sale of alcoholic beverages in C-2, Neighborhood Commercial District, for the property located at 901 Bayliss Avenue (Dave's Bait and Tackle). The building on the subject property is currently vacant, with plans to reopen as a bait and tackle shop in August. The applicant is seeking permission to sell alcohol in the shop. This item will be referred to Plan Commission for their review and recommendation.
- d. Application for a **Conditional Use Permit** to allow outdoor seating area and outdoor sales, possession, and consumption of alcohol in the CBD-1, Central Business District-Core, for the property located at 430 E. Grand Avenue. This application is for the Zen Sushi & Grill, opening soon on the ground floor of the Phoenix building. The applicant proposed the use of the raised concrete patio area on the west side of the Phoenix building. This patio area was approved by Planning staff in 2013, with the expectation that Hendricks Commercial Properties would eventually lease the westernmost storefront to a restaurant tenant. The applicant has also applied for a Sidewalk Café License. This item will be referred to Plan Commission for their review and recommendation.
- e. Resolution authorizing Final Payment of Public Works **Contract C15-06, Colley Road Main Extension**. This project extended a 10" water main on Colley Road for 2,975 ft. east of Gateway Blvd. The work has been completed satisfactorily and in conformance with the requirements of the contract, and staff is recommending final payment.
- f. Resolution approving a **Change of Agent** for The Local Sports Bar and Grill, 443 E. Grand Avenue. The Alcohol Beverage License Control Committee (ABLCC) reviewed this item at their July 14, 2015 meeting and determined the applicant meets the qualifications for appointment as required by state law. The ABLCC unanimously recommends approval of the Change of Agent.

**7. ORDINANCES**

- a. Proposed Ordinance to Repeal and Recreate Section 1.10 of the Code of General Ordinances for the City of Beloit pertaining to **Emergency Management**. The City of Beloit has reorganized the Emergency Management Function and reassigned these duties to operate under the auspices of the Fire Department. The goal of this ordinance change is to mirror state statute for terminology and to be compliant with the National Incident Management System and the National Response Framework.

The Beloit Police Department, Beloit Area Crime Stoppers, and the Beloit Fire Department will once again collaborate in the celebration of the **32nd National Night Out on Tuesday, August 4, 2015.**

On August 4<sup>th</sup> from 5:30-8:30 p.m., residents in the neighborhoods throughout Beloit are asked to lock their doors, turn on and display outside lights and spend the evening outside with their neighbors. Last year over 30 neighborhood blocks registered to participate in Beloit’s National Night Out celebration.

As in the past, Beloit Police Officers, Firefighters, City Officials, Beloit Area Crime Stopper Representatives and Elected Representatives will visit many of the block parties and cookouts. Each neighborhood block will be responsible for planning special activities. Barricades will be available at no cost to the neighborhoods.

National Night Out is designed to heighten crime and drug prevention awareness, as well as to generate support and participation in local anti-crime efforts. It is also a time to strengthen the neighborhood spirit and police community partnerships, and sends a message to criminals, letting them know neighborhoods are organized and are ready to fight back.

All neighborhood blocks participating in this year’s National Night Out activities should register with the police department. Applications are available at the Beloit Police Department, 100 State Street, and the Beloit Fire Station Headquarters, 1111 Church Street.
