#### Dear Beloiters:

As I near 120 days in office, I want to let you know what we have accomplished within the Beloit Police Department (BPD) to achieve our goals of enhancing leadership, strengthening community relations, and transitioning to modern-day policing.

We have created new voluntary teams and position responsibilities on the department to increase the motivation, satisfaction, and performance of our members, leverage existing competencies, and create service efficiencies to the public:

#### Vision, Mission, Values and Communication Team (VMVCT)

We have identified a new unified vision and mission statement as well as a set of core values we stand for, are committed to, and hold ourselves accountable for. The final versions were voted on by all members of the department and will serve as a guiding light going forward. This statement and values will be embedded within our organization in many different ways—internally and externally. Please monitor the BPD website for the debut of these important guiding statements.

#### Assessment and Recruitment Team (ART)

The Department has revamped the process of assessment and recruitment both in terms of shortening the time from testing-to-job offer, as well as the actual assessment tasks. For the first time members representing our African-American and Hispanic communities were included as part of the oral assessment team.

ART is completing a brand new recruitment video emphasizing our role as guardians and embedding our new vision, mission, and core values. This inspiring video will be released on our website soon.

ART is also recruiting at various high schools and colleges. In concert with our school resource officers and community service providers, they are seeking those interested in law enforcement that are currently attending middle school and are discussing a mentoring program.

#### **Uniform Team**

This team of department members is currently evaluating all aspects of our uniform (officer, civilian, detective) for functionality, design, durability, and cost.

#### **Strengthening Community Relationships**

#### Social Media

Our Department has exponentially expanded our use of social media to inform our citizens, identify suspects and/or obtain crime information, message the good work of the department being done, and stay in touch with our community. In addition, our website has been updated with press release and future updates are in progress.

#### **Partnerships**

As part of a citywide effort, a community symposium was held with key citizen, community, and business stakeholders. A second symposium is scheduled for Oct. 20, 2015 at Merrill Elementary School. These symposiums have been a new chance for the City and the Department to listen to community leaders and residents and truly build the basis for a stronger community as a whole.

The Department has partnered with the Stateline Women's Fund Foundation to address human trafficking—specifically the sex trafficking of young women in our region. This was not a well-known topic; however, it is a national issue and concern. We have had two meetings involving numerous service providers, elected officials, criminal justice partners (District Attorney, etc.) and community members. This is a big issue in Beloit with our immigrant community, young female runaways and missing persons.

In addition we have partnered with the Beloit Boys and Girls Club on a baseball card project that will feature BPD officers.

I'm exceptionally proud to report the partnership with the Department of Corrections to start the first ever Parolee Roll Call Program (PRCP). This program brings newly paroled persons into our shift briefings where they meet BPD officers and have an opportunity to build a relationship. PRCP is geared towards assisting

these persons with their reintegration into society, while ensuring an added level of accountability and face-to-face communication with beat officers.

Also, we have changed our internal evaluation process to include a stronger focus on community engagement versus attaining numbers and tickets.

#### **Hiring Process**

The Department no longer screens out applicants prior to the written test. All interested parties who meet the legal requirements (no felony or misdemeanor DV convictions, age 21, etc.) may apply. We implemented a validated physical readiness test that is representative of the physical abilities officers must have without undue adverse gender impact. We have also engaged community groups to get their input on how to better diversify our department and mentor potential candidates.

#### **Enhancing Leadership**

#### **Accountability**

The Department has established shift commanders to ensure accountability and leadership on a 24/7 basis for the patrol force. A shift commander is a shift sergeant who is charged with overall decision-making, review of arrests, resource allocation, and is the conduit to the media during that shift.

#### **Training**

Through the cooperation and assistance of WI DOJ, enhanced training was provided to our officers at the current in-service and specialized training at BPD (Sept-Nov. 2015). This includes topics of concern for the community, such as sexual assault, domestic violence, and human trafficking investigative processes, identifiers, and best practices. These are issues that are traumatic for victims--we have increased our competencies exponentially at no additional cost.

In addition, we are conducting joint training with our crisis negotiations unit and SWAT. This is critical in terms of current-day mental health issues. The focus is on resolving and de-escalating these situations without the use of force. Future crisis training for the remainder of the force is pending.

Officers are also being exposed to the concepts of Procedural Justice and Legitimacy. These pillars are critical to instilling trust, cooperation, and support with the community and are topics of national discussion for law enforcement executives. It involves a large cultural shift in how law enforcement views its mission and relationships both internally & externally.

Leadership in Police Organizations, an International Association Chiefs of Police program, will be offered to officers this spring and is an internationally recognized leadership program for law enforcement.

Interview and interrogation training will occur in January by a nationally recognized instructor. This course will be hosted in Beloit thereby creating significant cost savings and increased opportunities to train most of the force.

#### **Transitioning to Modern-Day Policing**

#### **Expanded Position Responsibilities**

The Department has created a Crime Analyst position from an existing position. For the first time, BPD has a dedicated specialist with an understanding of modern day crime analytics and technology to identify crime patterns, conduct link analysis of suspects and/or wanted persons, and create intelligence and information-sharing reports for BPD and our external partners. This frees up officers and detectives, allowing them to concentrate on investigation and arrest. Future analysis includes how our officers and shifts are staffed versus where crime is being committed, etc.

Our three school resource officers are now assigned to one sergeant for continuity and in addition to their normal duties are tasked with preparing a daily informational report that is shared with beat officers. This expands information sharing in the case of incidents at school that may boil over into the neighborhoods, be a source of future criminality or bullying, missing/runaways, or threat to the community. Having this information helps beat officers should they be called to the residence after school hours. This is done in concert with school administrators who are also part of the information loop.

#### <u>Investigations</u>

Shift Commanders are monitoring and assigning follow up on cases handled by the patrol officers with an increased focus on identifying suspects, arresting them, and solving cases to prevent future victimization.

The Department has established a case management and follow up system in the detective bureau to better track investigations and prioritize cases.

All felony adult sexual assaults (omits 4th degree grabbing) are investigated by a detective instead of a beat officer.

We added two temporary detectives to fill shortages created by retirements until a full process can be conducted.

The Department is actively seeking wanted felons, absconders, and new suspects.

We are tracking cases in the D.A's office and established a solid working relationship to enable successful prosecution of cases and address needed investigative follow up.

#### **Policy Changes**

The Department has installed new procedures to approve, monitor and track overtime expenditures. This will better position the Department to identify future staffing and resource needs, as well as better project budgetary needs.

In addition we have issued numerous temporary directives to existing policies to enhance accountability, increase efficiency, or eliminate roadblocks to innovation.

- Internal investigation policy, which made it difficult to track citizen complaints, has been scraped and a new policy is in process.
- Established shift overlap to ensure 24/7 coverage on the street.
- Allowed officers to carry life-saving tourniquets, wear exterior vest carriers, have rifles accessible from the squad.
- Rewriting our evidence policy to ensure property is promptly returned to owners.

As you can see we have accomplished quite a bit in 120 days. Our success is due largely to the dedication, commitment, and self-sacrifice by ALL members of the Beloit Police Department. I am very proud of what has been attained and look forward to future successes for BPD and the Beloit community.
