## 2016 CITY COUNCIL ELECTION INFORMATION UPDATE

## Jan. 5, 2016 —

The City of Beloit currently has four City Council seats open for a two-year term to be elected at large during the Spring Election and Presidential Preference Vote (Presidential Primary) to take place on Tuesday, April 5, 2016.

- The four city councilor incumbents are: Sheila De Forest, Charles Haynes, Ana Kelly and Chuck Kincaid.
- The deadline for incumbents not seeking reelection to file the Notice of Non-Candidacy with the City Clerk is 5p.m., December 28<sup>th</sup>, 2015. Failure to notify the clerk extends the filing deadline 72 hours for that office.
  - The Clerk received Notification of Non-candidacy from President Charles Haynes on December 21<sup>st</sup> and Notification of Non-candidacy from Chuck Kincaid on January 4<sup>th</sup>, 2016.
  - Because Councilor Kincaid did not file prior to the December 28<sup>th</sup> deadline, the deadline for filing for this office has been extended to Friday, January 8<sup>th</sup> at 5pm.
- Nomination papers and all forms must be completed and filed with the City Clerk by 5 p.m. on Tuesday, Jan. 8, 2016.
- The spring election will be held on Tuesday, April 5, 2016.
- Newly-elected City Council members will take office on Tuesday, April 19, 2016.
- As of 5pm January 5<sup>th</sup>, 2016 the following people have filed for candidacy:

The Municipal Judge office is also up for re-election and the Clerk's office received notice of non-candidacy from Judge William T. Henderson on December 10<sup>th</sup>. There is only one candidate qualified for ballot status at this time. Melissa Brooke Joos, 643 Terrace Lane, Beloit has completed and turned in the required paperwork to appear on the April 5<sup>th</sup>, 2016 Spring ballot for Municipal Judge in the City of Beloit.
