# **Community Meetings, Activities, and Functions:**

- Participated in the monthly Rock County Breakfast with representatives from the City of Beloit, City of Janesville and Rock County. Met Dr. Charles Clark, Southwestern Regional Executive Officer/Dean with the University of Wisconsin Colleges and University of Wisconsin-Extension. Dr. Clark will oversee UW-Baraboo/Sauk County, UW-Richland, and UW-Rock County.
- Participated in the City Center Committee and update of the strategic plan.

### **TESTIMONY IN MADISON**

Much of the day Tuesday was spent in Madison to testify on SB445. The bill under discussion originated in the Assembly as AB 568, which has since been amended.

In its original form, the bill would have eliminated the City's ability to continue its rental registration and permit inspection program, which has been in place since 1994. This was of utmost concern because the City's inspection program frequently uncovers life safety concerns that could go unaddressed without the program in place.

The bill also would have prohibited the creation of new historic preservation districts without 100% owner approval. A previous compromise on the requirements for fire sprinklers was also impacted by the bill. The amended version addresses many of the City's concerns and would allow the continuation of rental registration and permit inspections. New historic preservation districts may be created under the amended bill with the support of 2/3 of the property owners, which the City finds reasonable. We will continue to carefully monitor these bills and any additional changes that may impact the City.

Previously, Fire Chief Brad Liggett and I spent an entire day in Madison to testify before the Assembly on the same bill (AB568).

### POLICE DEPARTMENT SWEARS IN NEW OFFICERS

On Monday morning, January 4, 2016, I was pleased to attend and participated in the swearing in ceremony for two new Police Officers, Ryan Kelley and Jeremy Reinhold.

Next week, on **Monday, January 11, 2016 at 9:30 a.m., in the City Hall Forum**, 100 State Street, the City Clerk will swear in four new Police Officers; Joshua Buroker, Deven Highland, Brandon Jones and Nicholas Smith. Following a brief presentation, Christian Dalton and Richard LeFeber, currently Patrol Officers with the Beloit Police Department, will be administered the Oath of Office by City Clerk Lorena Stottler and thus promoted to the rank of Sergeant.

Photo opportunities will be available, and the public is invited to attend the ceremony.

On January 4, Interim Chief David B. Zibolski received approval from the Police and Fire Commission to establish a Sergeants promotional list, which will be valid for one year.

# SPECIAL CITY COUNCIL MEETING - MONDAY, JANUARY 11, 2016

The attached <u>agenda</u> is for the **Monday**, **January 11**, **2016 special City Council meeting** beginning at 7:00 p.m. in the Forum.

- 2. Resolution Combining Polling Places for February 16, 2016 Spring Primary Election. A Spring Primary Election may take place in the City of Beloit on February 16, 2016. If the election is necessary, it is likely that only one contest will be on the ballot in Beloit (Justice of the Supreme Court). Historically, elections with only one contest on the ballot have experienced extremely low voter turnout. Because of that, the City Clerk's office is requesting that the City Council combine the regular nine polling places into two. One will be on the west side at the Beloit Historical Society, and one on the east side at Central Christian Church.
- 3. An Ordinance to Amend Section 1.14 of the Code of General Ordinances of the City of Beloit Pertaining to Polling Places. The School District of Beloit has sold its retired school buildings. One of those schools, McLenegan Elementary, was a polling place for Wards 19, 20 and 21, making it necessary to find a new polling place location. River of Life United Methodist Church was the best fit for the wards, given the regulations and requirements under the law. Additionally, the proposed ordinance updates the addresses for Gaston School and Hackett School. This is a Second Reading.
- 4. An Ordinance to Create Section 15.06(1)(e) of the Code of General Ordinances for the City of Beloit relating to the Possession and Consumption of Alcohol Beverages in Big Hill Center. City Ordinance allows the issuance of beer and wine picnic permits for consumption or possession (and not sale) of beer or wine in Leeson, Big Hill, Telfer, Wootton, Summit, Hilliard, and Riverside Parks, as well as within the Rotary River Center. However, no designation has been approved for the new Big Hill Center that would allow similar use in renting this new facility. Parks and Recreation staff, as well as the Par, Recreation & Conservation Advisory Commission, agree that users of the new Big Hill Center should be permitted to possess and consume alcohol beverages in a similar manner as allowed within the Rotary River Center in Riverside Park. Therefore, this new section of the Code has been drafted. This is a Second Reading.
