MINUTES TRAFFIC REVIEW COMMITTEE October 26, 2015, 1:30 p.m. City Manager's Conference Room

The regular meeting of the Traffic Review Committee of the City of Beloit, WI was held October 26, 2015 at 1:30 p.m. in the City Manager's Conference Room. G. Boysen called the meeting to order at 1:30 p.m.

1. Roll Call.

2. Approval of the minutes from the July 27, 2015 Traffic Review Committee meeting.

4. Discussion of traffic concerns along Milwaukee Road.

A 15 MPH school speed limit zone will be designated in front of Fran Fruzen School. S. Deforest asked about signalization, which was not recommended by traffic consultant report because signal warrants were

not met. T. Nee asked what other recommendations were in report. J. Dupuis gave brief overview of traffic study report. P. Charles asked for clarification of 15 MPH zone. M. Ramsden asked about crossing at Lee Lane.

5. Request to install Autistic Child signs in 1500 block of Forest Avenue.

J. Dupuis gave the staff report.

Staff recommendation is to not install the Autistic Child signs. There was a motion by M. Flesch, second by C. Fryar to approve staff recommendation. Motion passed.

6. Discussion of traffic concerns along Porter Avenue.

Discussion regarding the current conditions and potential changes were outlined. M. Flesch requested that the Police Department work with neighborhood group and come back with a supported recommendation for the committee to take a look at.

Dupuis mentioned that a consultant was hired for the downtown parking study.



2.	In discussions with Mr. Tilley, he brought forward concerns that trucks are regularly using Park Avenue as a through route.						
3.	The Traffic Review Committee endorsed a proposal to update the City's designated truck routes in 2010. The City Council passed an ordinance designating the routes in November of 2010.						
4.	The attached map shows the truck routes near the area of concern along Park Avenue.

Background Information: The City of Beloit received a request from Brian Kaiser of Kaiser Property Group, Inc. related to truck traffic along Reynolds Drive.						
Key Is	sues (maximu	m of 5):				
1.	Trucks are required to use posted truck routes when making pick-up/drop-offs to businesses located on a posted route however, they are allowed to travel the shortest/most practical route to/from places located off of a posted route.					
2.	Mr. Kaiser stated that the building has an address of 1 Reynolds Drive and trucks with deliveries for the facility are mistakenly turning on Reynolds instead of using the delivery docks located off of Kennedy Drive.					
3.	Once trucks turn down Reynolds, they are 'stuck' and either have to turn around at the end of the street which is causing damage according to Mr. Kaiser or back up all the way to Cranston Road.					
4.	The facility is located in the Industrial Park which is intended for truck use.

Key Is	ssues (maximu	m of 5):					
1.	The ranch styl	e condos located between 2047-2117 Colony Court are owned by the Meade's.					
2.	There are 6 building and each building contains three units for a total of 18 units.						
3.	The City of Beloit will be changing to automated garbage collection in June of 2016. As part of the program, each residence will be supplied two 96-gallon containers, which means that every other week when recycling is picked up, potentially 36 containers will be lined up in this short stretch of Colony Court.						
4.	The Meade's were concerned about where those containers would be located and the ability of the truck to pick-up garbage if parked cars are blocking the access.						
5.	I spoke with the supervisor in charge of the program and she indicated that they don't anticipate any problems with parked cars and the ability of the trucks to pick garbage. She further stated that the new automated garbage program should not be a reason to remove on-street parking.
