CITY COUNCIL MEETING - MONDAY, MARCH 7, 2016

The City Council will hold a **Workshop** in the City Manager's Conference Room on March 7, 2016 at 6:30 p.m. to review the agenda of the regular 7:00 p.m. City Council meeting.

The attached **agenda** is for the Monday, March 7, 2016 regular City Council meeting beginning at 7:00 p.m. in the Forum.

6. CONSENT AGENDA

- a. Approval of the **Minutes** of the Regular Meeting of February 15, 2016
- b. Resolution approving the **Construction of a Parking Lot** in Turtle Creek Park located at 1312 E. Grand Ave. The *Beloit Parks, Recreation, and Open Space Plan (2012-2016)* recommends the construction of a parking lot at Turtle Creek Park. The proposed parking lot will provide safe and reliable off-street parking for the visitors and guests of Turtle Creek Park and prevent further damage to the area currently being used for parked vehicles. Members of the Park, Recreation and Conservation Advisory Commission, Landmarks Commission, and Plan Commission have reviewed the construction of the parking lot and have unanimously voted to approve the improvement.
- c. Resolution approving authorizing **Final Payment for C14-12**, Soil Cap for 202 Shirland Avenue. The work has been completed and final payment is recommended.
- d. Resolution awarding **Public Works Contract C16-04**, Wisconsin Avenue Reconstruction—Woodward to White. Three bids were received for this project, with the low bid coming from Rock Road Companies. This project will restore pavement and improve street lighting.
- e. Resolution awarding **Public Works Contract C16-02**, Concrete Pavements Kettle, Cranston and Gateway. This project will construct turn lanes for Pratt Industries and repair slabs on Kettle Way. Four bids were received for this project, with the low bid coming from Parisi Construction Co., Inc.
- f. Application for **Class "B" Beer and "Class B" Liquor License** for Evans Group, LLC, d/b/a Royalty, 530 E. Grand Avenue, Donta Evans, Agent. This is a request to transfer the license from "The Bop" to a new business on the same premise, to be established as "Royalty." Refer to Alcohol Beverage License and Control Committee for review and recommendation.
- g. Application for **Class "A" Beer and "Class A" Liquor License** for Beloit Mobil on the Run, 2883 Milwaukee Road, Akbir Kang, Agent. This is a request to transfer the license from ND Gas LLC to a new business on the same premise. The business will remain "Beloit Mobil on the Run." This item will be referred to Alcohol Beverage License and Control Committee for their review and recommendation.
- h. Consideration of a **Change of Agent** on the Class "B" Beer and Reserve "Class B" Liquor License for Buffalo Wild Wings, 2747 Milwaukee Road, to James F. Gleich.

- i. Consideration of **Change of Agent** on the Class “B” Beer and “Class B” Liquor License of Beloit Snappers, 2301 Skyline Drive, to Timothy Hinds

7. ORDINANCES

- a. An **Ordinance to Amend Section 15.01 and to Repeal Sections 15.07(2) and (3)** of the Code of General Ordinances of the City of Beloit Pertaining to Regulations of Knives. On February 7, 2016, 2015 Wisconsin Act 149 became law. The Act strictly limits the authority for local governments to regulate knives. The proposed ordinance removes sections of the Code of General Ordinances for the City of Beloit that are no longer permissible under the new law.

11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution approving Advanced **Life Support Intercept Ambulance Service Agreement** with the Village Fire Protection District of Clinton, Wisconsin. This agreement will solidify the fire department’s ability to continue Advanced Life Support Services.
- b. Resolution approving **First Amendment to Clubhouse Food and Beverage Operating Agreement** for Krueger-Haskell Municipal Golf Course. The current food and beverage operator at the Krueger-Haskell Municipal Golf Course is D&D Buck, LLC. Their contract calls for an increase of \$2,100 in the lease payment to the City in 2016; however, they did not make a profit in 2015 and are asking that the City accept an amendment to their agreement to lower their lease payment to the same level as they paid in 2014.

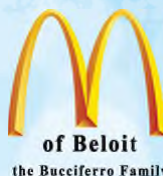
