PUBLIC NOTICE

The Community Development Department, in partnership with Community Action and the Beloit Police Department, is preparing a Neighborhood Revitalization Strategy for the Near Westside (Hackett) and Merrill Neighborhoods. As part of this strategy, we have identified an area on the westside where we would like to target our housing resources. **On Monday, June 13, 2016 starting at 6:30 p.m.**, we will be providing a tour of this proposed targeted area to the City Council and the Community Development Authority. We are seeking their input and insight into how we should use the federal grant dollars we currently receive in these neighborhoods. We are interested in focusing our efforts along Bluff Street between Shirland Avenue and West Grand Avenue, as well as the 300—500 blocks of Vernon Avenue, Highland Avenue, and Euclid Avenue. There will be a few stops along the way, in which the passengers will get out and walk through two specific properties already owned by the City. This is an informational tour and no action will be taken by either board at this event. (Public Notice attached.)

CRANSTON ROAD AND US HWY 51 PROJECT UPDATES

As of June 6th, the latest updates from the Department of Transportation for the USH-51 and Cranston Road project include:

- Storm sewer work continues north of Cranston Road. Once the storm sewer crew gets south of Cranston, Rock Road will bring in a final grading crew to grade the dirt and start placing the aggregate for the road base.
- Concrete curb work is expected to begin the week of June 13, 2016.
- The stage 2 traffic pattern that is currently in use is expected to remain at least through July 4th.
- When the concrete curb is poured it will need some time to cure and get hard enough for vehicles to cross. To allow
 for the concrete to harden, residents in that area will be asked to park out on the gravel roadway at times. Rock Road
 will coordinate those temporary closures. This will also be necessary when the sidewalks and concrete driveways are
 poured.

SLATS 2040 LONG RANGE TRANSPORTATION PLAN—Potential Transportation Improvements Survey

The Stateline Area Transportation Study (SLATS), the designated metropolitan planning agency for the region, is nearing the completion of the 2040 Long Range Transportation Plan (LRTP). The LRTP is a document that outlines a comprehensive transportation vision for the Beloit region and identifies specific and conceptual projects to address current and future year mobility needs. The LRTP is multimodal meaning that it addresses roadways (including truck traffic), public transportation, non-motorized (bike and pedestrian) facilities improvements. You can help us identify the priority projects that should be included in the 2040 LRTP by taking a brief survey regarding the potential improvements.

Before you begin the survey, it may be helpful to download a map that highlights the approximate location of the potential future roadway improvements within the study area. This map may help you better answer survey question #11 and is available by clicking here and selecting Roadway Improvement Priority Map (Use with Question #11) in Survey #2.
