## **POLITICAL SIGNS REMINDER**

The November election is getting closer, and the City of Beloit Planning and Building Services Division reminds residents that the City's Sign Ordinance allows the display of political signs, while protecting community aesthetics and promoting traffic safety.

Political signs may be displayed on private property without a Sign Permit, subject to the provisions in Section 30.33 of the Sign Ordinance. However, political signs may not be displayed in the public right-of-way or on other government property, including parks, street terraces, medians, and vacant lots. Unlawful signs may be confiscated and/or result in municipal citations being issued. On Election Day, no sign may be displayed on public property within 100 feet of any entrance to a building containing a polling place. If you have any questions or concerns, or to report an unlawful sign, please call the Planning and Building Services Division at 608-364-6700.

In addition, the Beloit Police Department reminds the public of Wisconsin Statute 12.13(3)(h), which states that "no person may...Deface, destroy or remove any legally placed election campaign advertising poster with intent to disrupt the campaign advertising efforts of any committee registered under ch. 11, or alter the information printed thereon so as to change the meaning thereof to the disadvantage of the candidate or cause espoused. Nothing in this paragraph restricts the right of any owner or occupant of any real property, or the owner or operator of any motor vehicle, to remove campaign advertising posters from such property or vehicle."

# Human trafficking exhibit is set to open in Beloit

BELOIT — "Bought and Sold: Voices of Human Trafficking," an exhibit to draw attention to the issue of human trafficking, was set up south of Rotary Center at Riverside Park on Wednesday.

The opening ceremony for the event is scheduled to take place at 5 p.m on Friday evening.

Assembled by ArtWorks of Freedom founder and artistic director Kay Chernush, the exhibit was brought to Beloit by the Women's Fund of the Stateline Community Foundation, in conjunction with Beloit Against Sexual Exploitation.

The exhibit consists of 14 dual-sided panels that each stand at 80 inches tall and 45 inches wide. The exhibit has traveled across two continents and has appeared in multiple locations in Wisconsin as part of Wisconsin's mandate to serve victims of human trafficking, including in The Chazen Museum of Art in Madison and locations in Milwaukee and Racine.

"We decided we wanted to be a part of this to get information out to people about what the problem really is," said Marline Holmes of the Women's Fund of the Stateline Community Foundation.

Beyond awareness, the long term goal is to raise support and inspire reform that provides services to individuals affected by human trafficking across the state, nation and world, according to Holmes. All of that needs to start at Beloit, she said, by serving the populations that desperately need attention to avoid having them swept up by human traffickers.

"We have a large number of homeless youth (in Beloit)," said Holmes. "It's really the youth that we are concentrating our efforts on."

# I-39/90 Expansion Project to benefit from \$40 million federal grant

The Wisconsin Department of Transportation (WisDOT) has received preliminary notice of a \$40 million federal grant to support the I-39/90 Expansion Project in Dane and Rock counties. The grant will accelerate construction of a four-mile segment of I-39/90 near Janesville between WIS 11 (Avalon Road) and US 14 by two years. The grant is being awarded by the U.S. Department of Transportation (U.S. DOT) through the Fostering Advancements in Shipping and Transportation for the Long-term Achievement of National Efficiencies (FASTLANE) program.

"We are pleased that Wisconsin was successful in applying for this grant in the very first year of the FASTLANE program," stated WisDOT Secretary Mark Gottlieb. "The grant will supplement existing funds and help us accelerate necessary improvements to this important regional commercial route."

The \$40 million FASTLANE grant, along with existing state and federal funds, is expected to allow construction on the four-mile segment of I-39/90 to begin in 2018 instead of 2020 as previously planned.

This grant segment project will reconstruct and expand I-39/90 from four lanes to eight lanes on the existing alignment. The segment currently carries an average of 57,000 vehicles daily, with the highest daily volume in 2015 at 73,000 vehicles daily, representing the highest traffic volumes of any segment along the entire 45 miles of I-39/90 from the Illinois state line near Beloit north to Madison. The corridor is a major freight route with heavy trucks comprising about 28 percent of freeway traffic.

Secretary Gottlieb noted the grant application was endorsed by a coalition of federal and state lawmakers along with community leaders. "The FASTLANE grants are targeted to projects that strengthen the national economy," Secretary Gottlieb said. "We are grateful for the support of our congressional delegation, state legislators and local organizations who recognize that I-39/90 is a vital link for commerce and tourism not just in south-central Wisconsin, but throughout the state and Midwest."

The \$40 million award for I-39/90 is currently in a 60-day congressional review phase and is expected to be formally awarded this fall. Nationally, U.S. DOT is expected to award up to \$800 million in FASTLANE grants, an amount expected to rise to \$1 billion annually in future years. The program is authorized for another four years and WisDOT will evaluate options to apply for additional projects in 2017.

Special Voting Deputies appointed by the City of Beloit will be administering absentee voting for the residents of this facility for the **August 9<sup>th</sup> Partisan Primary** at the above time and place. Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. Citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot.

Only observers from each of the two recognized political parties whose candidates for governor or president received the greatest number of votes in the municipality at the most recent general election may accompany the deputies to each facility where absentee voting will take place. The observers may observe the process of absentee ballot distribution in the common areas of the home, facility, or complex. Each party wishing to have an observer present shall submit the name of the observer to the City Clerk no later than the close of business on the last business day prior to the visit.
