MINUTES TRAFFIC REVIEW COMMITTEE July 25, 2016, 1:30 p.m. City Manager's Conference Room

The regular meeting of the Traffic Review Committee of the City of Beloit, WI was held April 25, 2016 at 1:30 p.m. in the City Manager's Conference Room. G. Boysen called the meeting to order at 1:30 p.m.

1. Roll Call

2. Approval of the minutes from the April 25, 2016 Traffic Review Committee meeting

Minutes of the April 25, 2016 meeting were approved on a motion by R. Norder, second by D. Stauffacher. Motion carried.

3. Public Participation

Don Parish of 100 Sun Valley Drive mentioned the speeding along Sun Valley and requested a traffic study for stop signs at House Street and replacing Yield signs at Poff/Cleora. States the intersection at Cleora has multiple accidents from people ignoring yield signs. Mr. Parish presented photos of the area. J. Dupuis indicated a traffic study could be completed for the intersection and data will be provided at a future meeting.

4. Request to remove parking on the South side of Public Avenue

J. Dupuis reviewed the request from Meals on Wheels to remove parking along Public Avenue. Meals on Wheels uses the area for pick-up/drop-off during the hours of 10 AM and 1 PM. Staff recommendation is to remove parking on the south side of Public Avenue adjacent to 424 College Avenue between 10 AM-1 PM. On a motion by R. Norder and seconded by C. Fryar the request was approved. Motion carried.

5. Ordinance to include signals at Cranston/Gateway and Cranston/Colley in the Index of Special Locations.

J. Dupuis reviewed the request to include the two signal locations in the Index of Special Locations. Both of the locations were improved as a result of Pratt Industries building a new facility along Gateway Boulevard. Staff recommendation is to add by ordinance the signals at the two intersections to the Index of Special Locations. On a motion by R. Norder and seconded by C. Fryar the request was approved. Motion carried.

6. Request to remove parking on the North side of West Grand Avenue

J. Dupuis reviewed the request to remove parking on the north side of West Grand Avenue adjacent to 715 W. Grand Avenue. The City recently razed the building at 715 W. Grand and City crews removed existing driveways, and repaired/replaced curb& gutter and sidewalks. The property is located at a skewed intersection and the removal of parking will allow for better vehicle sightlines. Staff recommendation is to remove the parking on the North side of the roadway adjacent to 715 West Grand Avenue. On a motion by C. Fryar and seconded by R. Norder the request was approved. Motion carried.

7. Committee Member Participation

R. Norder asked about the traffic signal at the intersection of 4th and Portland. J. Dupuis indicated the signal will be installed within a week or so. Also asked about the pedestrian timing at the intersection of Broad and State.

8. The next meeting is scheduled for August 22, 2016

The next meeting of the Traffic Review Committee is scheduled for August 22, 2016.

9. Adjournment.



Topic / Purpose for Presentation: Request to allow 30 minute terrace parking in front of 819 Clary Street.									
Background Information: The City of Beloit received the request from Shelley Cousin, Board member of Little Turtles' Playhouse, Inc.									
Key Issues (maximum of 5):									
1.	The property at 819 Clary Street was recently renovated to allow for a child care center.								
2.	The center is able to serve up to 48 children between the ages of 0-6 yrs.								
3.	The terrace parking stalls would be limited to 30-minutes on weekday between the hours of 6 AM-6 PM.								
4.	Alternate overnight parking would be in effect for this area due to the limited time frame for the 30 minute parking.								
5.	Construction in the right-of-way is not needed, as the terrace parking area already exists.								
Action Required / Recommendation / Evaluation:									
Staff recommendation is to designate terrace parking in front of 819 Clary Street with a 30-minute time limit between the hours of 6 AM-6 PM, Monday-Friday.
