4. PUBLIC HEARINGS

- a. Resolution authorizing a Conditional use Permit to allow Indoor Entertainment-Oriented Venue for the purpose of a banquet hall facility, in a C-2, Neighborhood Commercial District, for the property located at 1703 Park Avenue in the City of Beloit. The subject building is the former Gearhart's TV repair business with 2,720 sq. ft. of floor area. There are approximately 10 unstriped parking stalls on the subject property. If approved, the applicant intends to make the first floor of the building available for private parties, and requested permission to allow customers to bring their own alcoholic beverages. This practice is unlawful. Several neighbors have objected to the use due to concerns about traffic, parking, noise and loitering. The City Engineer also expressed concern regarding the lack of off-street parking. The subject property is surrounded by residential uses on three sides, and the increased noise, light and activity may be detrimental to public comfort and welfare. Plan Commission unanimously recommended for denial 6-0.
- Proposed Ordinance amending the City of Beloit Zoning District Map to change the Zoning District Classification of the properties located at 631, 640, 654 & 657 Bluff Street, from R-1B, Single-Family Residential District to C-1, Office District. Plan Commission recommendation for approval 6-0. First reading.

- b. Application for a Planned Unit Development (PUD) Master Land Use Plan, to allow mini-storage units and duplexes, for property located at 1402 Townline Avenue and 1405 Madison Road. The PUD is one of three land use applications needed for this project. This item will be referred to Plan Commission for review and recommendation.
- c. Application for a Zoning Map Amendment to change the Zoning District Classification of the properties located at 1402 Townline Avenue and 1405 Madison Road, from C-2, Neighborhood Commercial District to Planned Unit Development (PUD). This item will be referred to Plan Commission for review and recommendation.
- d. Application for a Conditional Use Permit (CUP) to allow a 6-story hotel, in a C-3, Community Commercial District for property located at 3022 Ford Street (former Wicks Lumber site). The applicant has proposed the construction of a 127-unit hotel building. This item will be referred to Plan Commission for their review and recommendation.
- e. Resolution rejecting all Bids for Public Works Contract C16-21, Beloit Public Library Blender Café. Six competitive bids were received but all were significantly higher than the available funding for the project and the architect's estimate. Staff recommends sending the project back to the architect for the preparation of cost saving revisions and alternates. A revised project may be re-bid early next year. Adequate funding is currently not available from the Library budget.

11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution approving the State Plan of Operations Agreement between the State of Wisconsin and the City of Beloit related to the LESO Program. The U.S. Department of Defense 1033 Program permits the Secretary of Defense to transfer excess Department of Defense (DOD) supplies and equipment to local law enforcement agencies for use in their law enforcement duties. The program requires an agreement between the state and recipient agency as a condition of receipt of the DOD property.
- b. Resolution authorizing the City of Beloit to apply for the 2017 Alcohol Enforcement Task Grant from the State of Wisconsin Department of Transportation—Bureau of Transportation Safety. The Beloit Police Department is seeking approval to apply for a \$50,000 Alcohol Enforcement (OWI) Taskforce Grant for 2017. As administrators of the grant, the City will coordinate deployment strategies and fund disbursement with task force members throughout Rock County, complete activity reports, and submit and process reimbursement claims for member agencies.
- c. The City Council may adjourn into closed session pursuant to Wis. Stats. §19.85 (1)(e) to discuss potential real estate transaction, the discussion of which would harm the City's competitive or bargaining interest if held in open session, namely the potential sale of a portion of 1801 Gateway Boulevard.

Three City Council Seats Open for Election

Dec. 2, 2016 — The City of Beloit is launching the 2017 election process for a two-year term on City Council. Beginning Thursday, December 1, 2016, anyone interested in running for City Council may pick up an information packet including nomination papers. Packets are available in the office of the City Clerk on the second floor of City Hall during normal business hours: Monday through Friday, 8 a.m. - 5 p.m.

- There are seven members on City Council and **three** seats will be on the ballot.
- The first day to circulate nomination papers is Thursday, Dec. 1, 2016.
- A minimum of 100 valid signatures of City of Beloit residents must be submitted. Staff recommends that between 100 and 200 signatures be submitted to ensure ballot access.
- Nomination papers and all forms must be completed and filed with the City Clerk by 5 p.m. on Tuesday, Jan. 3, 2017.
- The spring election will be held on Tuesday, April 4, 2017.
- Candidates must file required forms with the City Clerk before forming a committee and/or raising funds.
- An informational session may be held in January for candidates who have gained ballot access.
- Newly-elected City Council members will take office on Tuesday, April 18, 2017.
