4. PUBLIC HEARINGS

- a. Public Hearing on Proposed Substantial Amendment to the 2015-2019 Consolidated Plan to Incorporate Two Neighborhood Revitalization Strategy Areas (NRSA's). One of the Strategy Areas will be defined as the Merrill Neighborhood and one to be defined as the Near West Side (or Hackett) Neighborhood. Neighborhood revitalization projects include activities of sufficient size and scope to have an impact on the decline of a geographic location within the jurisdiction of a unit of general local government.

- b. Resolution approving the Sale of Land to Wisconsin DOT for Highway Right-of-Way. Plan Commission recommendation for approval 6-0. As part of the interstate Highway 39/9/43 and Hwy. 81 Interchange Reconstruction Project, the Wisconsin Department of Transportation is seeking to acquire 0.531 acre of the property located at 2001 Gateway Boulevard from the City of Beloit for right-of-way purposes. The interchange will be reconstructed beginning in fall 2018.
- c. Resolution authorizing an exception to the Architectural Review and Landscape Code for the property located at 1344 E. Grand Avenue. The applicant would like to install brown vertical steel siding on all three rear exterior walls of the building. The submitted specifications indicate that the new steel siding will cover more than 25% of each rear exterior wall surface. Plan Commission recommendation for Denial 6-0.
- d. Resolution awarding Public Works Contract C17-03, Parking Lot Rehab. Four competitive bids were received, with the low bid being from Thunder Road LLC. This project will apply sealcoating to parking lots at the Rotary River Center, Wootton Boat Launch, and City Hall.
- e. Resolution approving Change of Agent on the Class "B" Beer and Reserve "Class B" Liquor License for Fiesta Cancun Authentic Mexican Restaurant of Beloit, Inc., located at 2648 Prairie Avenue, Beloit from Jennifer Dominguez to Araceli De Vicente. Alcohol Beverage License Control Committee recommendation for approval 5-0.
- f. Application for a Conditional Use Permit to allow 101 foot exhaust stack in M-2 district at 3150 Kettle Way—Kettle Foods. This item will be referred to Plan Commission for review and recommendation. The applicant has proposed extending the height of the kettle cooker exhaust stack from 76 feet to 101 feet in order to meet Wisconsin Department of Natural Resources air quality requirements.
- g. Application for a Conditional Use Permit to allow a Bar/Restaurant with Outdoor Seating Area and to allow Indoor and Outdoor Sales, Possession and Consumption of Alcohol in an M-1, Limited Industrial District, for the proposed

Microbrewery to be located at 1895 Gateway Boulevard. This item will be referred to Plan Commission for review and recommendation. If approved, food and alcohol would be served in the restaurant portion of the building and outdoor patio, which are allowed as a conditional use in an M-1, Limited Manufacturing District. The Liquor License Application was submitted on July 1, 2017 and will be reviewed by the Alcohol Beverage License Control Committee on August 8, 2017.
