#### **PUBLIC MEETING FOR UPCOMING I-39/90 WORK**

The Wisconsin Department of Transportation (WisDOT) is preparing to reconstruct and expand approximately 12 miles of Interstate 39/90 from Hart Road north to the I-39/90

and US 14 interchange (Exit 171B) in Janesville. Work is tentatively scheduled to start in September and will be completed in spring of 2020 (weather permitting).

A **Public Meeting** to learn more about the project, including the planned construction staging and schedule, and how to stay informed during the construction is planned for **Tuesday**, **August 22**, **2017 from 5:00—6:30 p.m.** at the Holiday Inn Express Conference Center, 3100 Wellington Place, Janesville. WisDOT representatives will be available to discuss the project and exhibits showing the planned improvements will also be on display.

#### FOURTH STREET BRIDGE REPLACEMENT

Fourth Street will remain closed at Lenigan Creek between North Street and Maple Avenue through September 25, 2017 due to the bridge replacement. Access to businesses within the work zone will be maintained. A bicycle and pedestrian detour route is posted for the area. Drivers and pedestrians should exercise caution when traveling through the area.

The proposed bridge will be a single span 228 foot long Warren Truss. The bridge will be prefabricated and delivered to the site in sections, assembled and then set on concrete abutments. The bridge will be of steel that rusts to a patina and will not be painted. Refer to Plan Commission for review and recommendation.
