LAW ENFORCEMENT TASK FORCE ACTIVITY

Officers from the Beloit Police Department will participate in the Rock County Impaired Driving Enforcement Task Force on February 17, 2018. More officers will be on patrol to discourage driving while impaired. The Rock County Impaired Driving Enforcement Task Force includes the Rock County Sheriff's Department and the Janesville, Town of Beloit and City of Beloit police departments. Funding for the special enforcement periods is provided via a grant from the Wisconsin Department of Transportation.

POLLING PLACES COMBINED FOR SPRING PRIMARY ELECTION

A Spring Primary Election will take place in the City of Beloit on February 20, 2018. The contests for the ballot include a primary for State Supreme Court and the School District of Beloit School Board. Because of low anticipated voter turnout, the regular nine polling places will be combined into two; one on the west side at the Beloit Historical Society, and one on the east side at Central Christian Church. Voters who typically vote in Wards 1-12 will vote at the Beloit Historical Society, and voters who typically vote in Wards 13-25 will vote at Central Christian Church. I-39/90 PROJECT COMPLETION ADVANCED TO 2021

We received the following information this week regarding the I-39/90 Expansion Project. Governor Walker announced WisDOT will advance \$32.7 million of the I-39/90 project work into state fiscal year 2018. This will put the project on track to be completed in the fall of 2021 (a full year ahead of schedule). This includes the entire I-39/90 project with the exception of the I-39/90 and US 12/18 (Beltline) Interchange, which is currently undergoing environmental analysis. <u>City of Beloit to Combine Polling Places for the</u> <u>February 20, 2018 Spring Primary Election Only</u>

February 9, 2018 – The City Council of the City of Beloit has combined polling places for the Spring Primary Election to be held on February 20, 2018, in the City of Beloit.

The following polling place locations will be used for the wards indicated. <u>City of Beloit Polling Places:</u>

Wards 1 - 12	Beloit Historical Society	845 Hackett Street
Wards 13 - 25	Central Christian Church	2460 Milwaukee Road

Voters in wards 1-9, who usually vote at Converse, Gaston, and Hackett Schools, will join voters in wards 10-12 and vote at the **Beloit Historical Society**, **845 Hackett Street**, **Beloit**, **WI 53511** <u>for this election only</u>.

Voters in wards 13-22, who usually vote at the Beloit Public Library, First Congregational Church, Todd School, and River of Life UMC, will join voters in wards 23-25 and vote at **Central Christian Church, 2460 Milwaukee Road, Beloit, WI 53511** for this election only.

The City Council combined polling places due to the low expected voter turn-out for this spring primary election, which includes a primary for State Supreme Court Justice and Beloit School Board.

registration, Voter ID implementation, finding your polling place and requesting an absentee ballot. All Polling Places in City of Beloit are open from 7:00 A.M. to 8:00 P.M. All polling places are accessible to elderly and disabled voters.

NOTICE TO ELECTORS IN THE CITY OF BELOIT VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail or in person.

Making application to receive an absentee ballot by mail

The deadline for making application to receive an absentee ballot by mail is:

5 pm on the fifth day before the election, February 16th, 2018.

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

The first day to vote an absentee ballot in the clerk's office is: January 30, 2018

The last day to vote an absentee ballot in the clerk's office: February 16, 2018

No in-person absentee voting may occur on the day before the election.

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper counting location before the polls close on February 20, 2018. Any ballots received after the polls close will not be counted.
