ROCK COUNTY IMPAIRED DRIVING ENFORCEMENT TASK FORCE

Beloit Police Officers will participate in the Rock County Impaired Driving Enforcement Task Force on Saturday, March 17 and Friday, March 23, 2018. During this additional enforcement, the Beloit Police Department will have more officers on patrol to discourage people from driving while impaired. They will have zero tolerance for driving under the influence, open intoxicants, seatbelt violations and improper use of child safety restraints. I-39/90 PROJECT UPDATE

From the Wisconsin Department of Transportation:

"Construction activities are underway in the I-39/90 work zones between Beloit and Madison. Thursday night, crews successfully completed the major traffic switch of all I-39/90 traffic onto the southbound side from Beloit to Janesville. Two lanes remain open in each direction, separated by a median barrier wall. Be alert for crossovers, don't tailgate and drive with caution through this area!

With the recent traffic switch, the County S/Shopiere Road ramp to I-39/90 northbound is CLOSED until early April as crews complete the temporary loop ramp connection to the southbound side. Follow the posted detour route (I-39/90 and I-43 interchange) during the short-term closure. The temporary loop ramp to I-39/90 northbound is anticipated to open in early April."

6. CONSENT AGENDA

All items listed under the Consent Agenda are considered routine and will be enacted by one motion. There will be no separate discussion of these items unless a Council member so requests, in which event the item will be removed from the General Order of Business and considered at this point on the agenda.

- a. Consider approval of the Minutes of the Regular Meeting of March 5, 2018.
- b. Consideration of Resolution 2018-045 awarding Contract C18-26, Branigan Realignment. One competitive bid was received, the low bid being from Rock Road Companies, Inc. This project will realign the frontage road in front of Walmart at the intersection with Branigan and the entrance to Menards. The roads will come together to form a standard intersection rather than the current offset configuration.
- c. Consideration of Resolution 2018-048, awarding Contract C17-02, Milwaukee Road Gateway Corridor Improvements. This project will construct new sidewalks, curb & gutter, a multi-use path and decorative street lighting. In addition, upgrades and repairs will be made to the signals, crosswalks, storm sewers, and landscaping. The existing road surface will be milled and overlayed with new asphalt. The lowest bid was from Rock Road Companies, Inc.
- d. Consideration of Resolution 2018-042 approving Clubhouse Food and Beverage Operating Agreement for Krueger-Haskell Municipal Golf Course.
 Last year's vendor opted out of the prior Operating Agreement. The city located another concessionaire to offer food and beverage service. Hospitality on the Green Inc. will be operational a minimum of 10 hours daily in order to effectively provide food and beverage services to the general public, including golf patrons, Playday Events/Golf Outings and special events as requested. This Operating Agreement will allow the new vendor to operate the food and beverage service at the Krueger Haskell Municipal Golf Course for a minimum of three (3) years, with an option for two (2) one-year extensions.
- e. Consideration of Resolution 2018-063 approving the Location and Design of a Storage Building at the City's Water Pollution Control Facility. Plan Commission recommendation for approval 5-0.
 The \$120,000 cost of the project will be funded by utility operating funds and is included in the approved 2018 Capital Improvements Program.
- f. Consideration of Resolution 2018-064 approving the location and Architectural Design of a Proposed Park Shelter in Eagles Ridge Park located at 3731 Golden Eagle Drive. Plan Commission recommendation for approval 5-0. The Master Plan for Eagles Ridge Park recommends a park/picnic shelter as a high priority public amenity within the park. The cost for this project will be financed through TIF #10 funds.
- g. Consideration of Resolution 2018-066 accepting Attachment Pursuant to Section 66.0307 of Wisconsin Statutes for 2032 E. Ridge Road from the Town of Turtle. Accept and Refer to Plan Commission for review and recommendation. A failing septic system is the impetus for this attachment request, as the applicants must be located in the City in order to connect to the City's sanitary sewer system.

- h. Consider Application for a Conditional Use Permit to allow a New Pavilion and Expanded Outdoor Seating and Activity areas with Alcoholic Beverage Sales & Consumption in a C-3 Community Commercial District, for properties located at 101 & 145 Maple Avenue and 1621 Shore Drive. This item will be referred to Plan Commission for review and recommendation. This is property at The Rock Bar & Grill. This project involves the replacement of the existing outdoor patio adjacent to the restaurant building with new tables, chairs, and features including a fire bowl, Adirondack chairs, and stamped concrete; replacement of the existing pavilion with a new pavilion and storage building to be connected to the restaurant building with a new concrete sidewalk; replacement and improvement of the outdoor volleyball courts.
- i. Consider Application for Zoning Map Amendment to change the Zoning District Classification from C-1, Office District, to R-1A, Single-Family Residential District for a portion of the property located at 1575 Prairie Avenue. This item will be referred to Plan Commission for review and recommendation. Most of this 12.5-acre parcel is already zoned R-1A; however the northwest portion of the parcel, located near Prairie Avenue, is zoned C-1. The applicant intends to eventually subdivide the subject property for future sale.
- j. Consider Application for a Zoning Map Amendment to change the Zoning District Classification from R-1B, Single-Family Residential District, to PLI, Public Lands and Institutions District for property located at 1905 Mound Avenue and 1950 Church Street. This item will be referred to Plan Commission for review and recommendation. The property located at 1905 Mound Avenue is a 3.15-acre parcel which contains a religious institution. The applicant intends to include a day care center within the existing building, in addition to its current religious services. The property located at 1950 Church Street is a 2.24-acre vacant lot which is currently used as green space. The applicant intends to install a community garden on the southeast portion of the 1950 Church Street property; eventually the applicant would like to construct a community center on the 1950 Church Street property.

The list includes 12 applicants taken between February 28 - March 15, 2018. Eleven applicants are recommended for approval; one applicant is recommended for denial on the basis of the background check and the failure to disclose matters on the application.
- b. Consideration of Resolution 2018-052 approving New Class "B" Beer and "Class B" Liquor License for Hospitality on the Green, Inc., d/b/a Putterz Pub, located at 1611 Hackett Street. Alcohol Beverage License Control Committee recommendation for approval 5-0. The City and Hospitality on the Green, Inc. have negotiated an agreement to operate the concessions at the Krueger-Haskell Golf Course Clubhouse. JT Hankins LLC d/b/a The Restaurant at "Muni" has submitted a letter relinquishing its license upon approval of this application by the City Council at its March 19, 2018 meeting.

- a. Consideration of Ordinance No. 3613 to amend certain Sections of the Index of Special Locations, Section 13.02 of the Code of General Ordinances of the City of Beloit, relating to the removal of the No Parking Designations on Sunshine Lane. Traffic Review Committee recommendation for approval 4-0. First Reading. The City is in the process of updating signage in the area around the former McLenegan School location. As part of the update, staff is requesting the removal of certain parking restrictions that were put in place related to the activities of the school in that location. The proposed ordinance removes the No Parking designations along Sunshine Lane as those designations are not needed while the use of the property has changed from a schoolhouse to a church. School speed limit signs and crossing signage related to McLenegan School are also scheduled to be removed since the use is no longer a schoolhouse.
- b. Consideration of Ordinance No. 3614 to amend certain Sections of the Index of Special Locations, Section 13.02 of the Code of General Ordinances of the City of Beloit, relating to the removal of Parking on Third Street near West Grand Avenue. Traffic Review Committee recommendation for approval 4-0. First Reading. The proposed ordinance removes parking along the west side of Third Street, north of West Grand Avenue which will allow for pedestrians and vehicles to see (and be seen) more clearly.

c. Consideration of Ordinance No. 3615 to amend certain Sections of the Index of Special Locations, Section 13.02 of the Code of General Ordinances of the City of Beloit, relating to the Removal of Parking On Bluff Street. Traffic Review Committee recommendation for approval 4-0. First Reading. The City received a request to remove parking along the west side of Bluff Street near the intersection of Highland Avenue. The request was made by a citizen living in the 300 block of Highland Avenue. The proposed ordinance will remove 135 feet of parking along the west side of Bluff Street, north of Highland which will allow pedestrians and vehicles to see (and be seen) more clearly. After the Traffic Review Committee met, the resident at 410 Bluff Street contacted city staff to state her opposition to the proposed removal of the parking.

Beloit Police Officers Participating in Rock County Impaired Driving Enforcement Task Force in March

March 12, 2018 - Officers from the Beloit Police Department will be participating in the Rock County Impaired Driving Enforcement Task Force on Saturday, March 17, and Friday, March 23.

During this additional enforcement, the Beloit Police Department will have more officers on patrol to discourage people from driving while impaired. The Beloit Police Department will have zero tolerance for driving under the influence, open intoxicants, seatbelt violations and improper use of child safety restraints.

"By choosing to get behind the wheel while impaired, drivers are putting the lives of everyone around them at risk," said Sgt. Christian Dalton. "Our goal is to reduce the number of impaired drivers in Beloit and send the message that driving under the influence is never acceptable. We want to see each and every person get home safely each and every day."

Driving under the influence includes the use of alcohol, illegal drugs or prescription medication. The Beloit Police Department suggests all motorists take steps to protect themselves and others:

- Ensure everyone in your vehicle is buckled up every day, every trip. Watch your speed, be patient and alert.
- If you plan to use any alcohol, drugs or prescription medication that will impair your driving, choose a sober designated driver.
- If you're feeling buzzed, you likely are over the 0.08 BAC limit and should not drive. Take public transit, a taxicab, or ask a sober friend to drive you home.
- The Wisconsin DOT offers a free Drive Sober mobile app that includes a blood alcohol estimator, designated driver selector, and find-a-ride feature that uses a smart phone's GPS to locate alternative transportation.
- Some taverns and restaurants have programs to provide patrons with a safe ride home. Visit www.tlw.org/ and click
 on Safe Ride.
- Report impaired drivers to law enforcement by calling 911. Provide as much detail as possible on the driver, vehicle, and location.

The Rock County Impaired Driving Enforcement Task Force includes the Rock County Sheriff's Department and the Janesville, Town of Beloit and City of Beloit police departments. Funding for the special enforcement periods is provided via a grant from the Wisconsin Department of Transportation.

SUBJECT: Cancellation of Landmarks Commission Meeting

Since no applications have been submitted, the regularly scheduled <u>March 20, 2018</u> meeting of the Landmarks Commission has been cancelled. The next Landmarks Commission meeting is scheduled for Tuesday, April 17, 2018.


