## **CURRENT EVENTS AND ACTIVITIES**

#### **CITY MANAGER'S ACTIVITIES**

- Held Leadership Team meeting and one-on-one meetings with direct reports.
- Participated in the press conference regarding the Dolly Parton Imagination Library.
- Attended training on the "Basics of Workers Compensation."
- Met with Councilor Nancy Forbeck.
- Participated in the dedication and ribbon cutting for the Hope Park Playground at 826 Bellevue Place, Council Vice-President Dunkin and Councilor Beth Jacobsen were also in attendance.

#### SHORE DRIVE WATER MAIN PROJECT BEGINS JUNE 4, 2018

Water main replacement and street reconstruction work along Shore Drive begins on June 4th. Shore Drive will be closed to through traffic during the duration of the project, which is expected to be completed by August 31, weather permitting. In addition to updating the existing water main, the project will also include road resurfacing with curbs and terraces, storm sewer placement, and the installation of a detention pond and sod restoration. No detour route will be posted, and no parking will be allowed at U.S. Pride Park during the project. Beloit Transit will temporarily remove the two blue route bus stops on Shore Drive during the project; a temporary stop will be located on Poole Court south of Carpenter Street.

#### **ROAD CONSTRUCTION PROJECT UPDATE - MAY 31, 2018** Milwaukee Road Project Update:

- Travel lanes are limited to one lane for each direction; however, the corridor is open and access to businesses remains throughout the project.
- Work on concrete pavement and joint repairs continues; removals and grading for new sidewalks has begun along with work associated with the signals; and work related to storm pipes and structures is on-going.
- A storm sewer crossing between Branigan and Freeman/Ford is underway and necessitated a detour to the frontage road for eastbound traffic. The closure and detour is expected to last 1-2 days.

Work scheduled for the upcoming week will include:

- Continued storm sewer pipe work
- Continued work related to the sidewalks
- Continued repairs to the concrete pavement •
- Continued work associated with the signals

#### Branigan Road Re-Alignment Update:

The work on the Branigan Road re-alignment project is scheduled to begin June 11, • 2018 and last approximately 30 days. The project will re-align the frontage road between Wal-Mart and Menards. #### "CLICK IT OR TICKET" CAMPAIGN

The City of Beloit Police Department reminds motorists to "Click It or Ticket." The national seat belt campaign will take place now through June 3rd. Participating law enforcement agencies will take a no-excuses approach to seat belt law enforcement. In the City of Beloit, the maximum penalty for a seat belt violation is \$10 for adults and \$98.80 for a child restraint violation. The Wisconsin's state fine for a child restraint violation is \$175.30. Seat belts save lives, please buckle up. <u>Attached</u> is a press release with more information.

- b. Consider applications for late renewal of Alcohol Beverage Licenses for license period July 1, 2018 June 30, 2019. This item will be referred to the Alcohol Beverage License Control Committee for review and recommendation. Following review and recommendation by the ABLCC, this list will return to the Council for approval at the June 18 regular meeting.
- c. Consideration of Resolution 2018-106 approving the renewal of an Annual Mobile Home Park License for the property located at 2601 Colley Road, known as Springbrook Village. Inspections have been made by Code Enforcement, Fire Department and the Health Department.
- d. Consider application for a Conditional Use Permit to allow an outdoor entertainment event with the possession, sale, and consumption of alcoholic beverages in an M-2, General Manufacturing District, for the Ironworks property located at 701 Third Street. Beloit International Film Festival (BIFF) proposed moving their event known as the "Summer Blockbuster" fundraising concert to the eastern end of the Ironworks Spine, which is the private driveway leading from Third Street to the cul-de-sac along the river. The proposed event is scheduled for Saturday, August 11, 2018 and will include a stage featuring several bands, food and beverage vendors, portable toilets and a portable movie screen. The event area will be surrounded by fencing. Due to the proposed activities, there are numerous approvals required including an outdoor vendor's permit, a license to serve alcoholic beverages, and a public entertainment license. This item will be referred to Plan Commission for review and recommendation.

- e. Consider application for a Conditional Use Permit to allow an outdoor seating area (deck) with the possession, sale and consumption of alcoholic beverages in the CDB-1, Central Business District - Core, for the property located at 530 E. Grand Avenue. Donta Evans, DBA Royalty Lounge, has filed an application to allow an outdoor seating area (deck) with the possession, sale, and consumption of alcoholic beverages. This item will be referred to Plan Commission for review and recommendation.
- f. Consider application for a Zoning Map Amendment to change the zoning district classification from R-3, Low-Density Multi-Family Residential to PLI, Public Lands & Institutions, for the property located at 749 Bluff Street and from R-1B, Single-Family Residential to PLI, Public Lands & Institutions, for part of the residential property located at 737 Bluff Street. Our Savior's Lutheran Church has used the residential structure at 737 Bluff Street as a day shelter for homeless individuals. In addition to the residential structure, there is a garage and dumpster pad located on the 737 Bluff Street parcel, which is contiguous to the church's main parking lot. The church intends to sell the residential parcel, but desires to retain use of the detached garage, dumpster area, and vacant land for possible future parking expansion. In order to accomplish these objectives, Planning staff recommended and the applicant commissioned the Plat of Survey. This item will be referred to Plan Commission for review and recommendation.
- g. Consideration of Resolution 2018-018 approving Intergovernmental Mutual Aid Agreement between the City of Beloit (WI) Police Department, the Rock County (WI) Sheriff's Office, the Winnebago County (IL) Sheriff's Department, and the City of South Beloit (IL) Police Department. This is an update to a pre-existing, but outdated mutual aid agreement that provides guidelines and protocols for the Beloit Police Department and adjacent law enforcement agencies in the State of Illinois.

The School District of Beloit commissioned a traffic impact analysis report and supplemental analysis for Phase 1 of the High School Campus Master Plan. Phase 1 of the Plan includes the temporary closure of Fourth Street between Middle Street and North Street. The No Parking and Turn Movement ordinances are related to the temporary closure.
- b. Consideration of Ordinance No. 3620 to amend certain Sections of the Index of Special Locations, Section 13.02 of the Code of General Ordinances of the City of Beloit, relating to the establishment of a loading zone on Public Avenue. Traffic Review recommendation for approval 7-0. First reading. 419 Pleasant Street is being renovated to include a boutique hotel, restaurant, and rooftop patio. Off-street parking for the property is located to the east of the main entrance on the side of the building. The loading zone on Public Avenue will provide a pick-up/drop-off area closer to the main entrance of the facility, while keeping the area free of parked cars. City staff recommended shortening the requested loading zone length from 115' to 105' to provide an additional buffer for vehicles turning right from Pleasant Street onto Public Avenue.

#### 12. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Consideration of Resolution 2018-109 amending the 2018 Capital Improvement Budget for TID 10 to provide funding for a Water Main Extension project in the Gateway Business Park. The City of Beloit Water Utility recommends construction of a water main extension in the Gateway Business Park to eliminate a long dead end main on Colley Road. This project was not included in the original 2018 CIP and requires the CIP to be amended to include this project. Funding is from the TID 10 fund balance.
- B. The City Council will adjourn into Closed session pursuant to section 19.85(1)(e), Wis. Stats. for the purpose of deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session, namely to consider an offer to purchase a strip of vacant land near 3437 Duggan Road. The City Council may reconvene into open session.

#### Beloit Police Department Participating in "Click it or Ticket" Campaign

May 23, 2018 - As the unofficial start of summer, the Memorial Day holiday weekend is a busy time for Americans. Each year, the highways fill with families in vehicles, on their way to start their summer vacations.

To help keep drivers and passengers stay safe, the City of Beloit Police Department is reminding motorists to *Click It or Ticket*. Aimed at enforcing seat belt use to help keep families safe, the national seat belt campaign will take place now through June 3, concurrent with the busy travel season.

"Buckling up is such a simple task that can keep you and your family safe in the car," said Sgt. Matthew Donovan "But it's more than that. Buckling up is the law. Our law enforcement personnel see the consequences of not buckling up. We see the loss of life. Often, it could have been prevented with the simple click of a seat belt. This should be automatic."

"As the Memorial Day weekend approaches and the summer vacation season ramps up, we want to keep our community members safe, and make sure people are doing the one thing that can save them in a crash: buckling up," said Donovan. "If the enforcement crackdown wakes people up to the dangers of unrestrained driving, we'll consider it a success."

According to the National Highway Traffic Safety Administration, nearly half (48%) of the passenger vehicle occupants killed in crashes in 2016 were unrestrained. At night from 6 p.m. to 5:59 a.m., that number soared to 56 percent of those killed. That's why one focus of the *Click It or Ticket* campaign is nighttime enforcement. Participating law enforcement agencies will be taking a no-excuses approach to seat belt law enforcement, writing citations day and night. In City of Beloit the maximum penalty for a seat belt violation is \$10 for adults and \$98.80 for a child restraint violation. The Wisconsin's state fine for a child restraint violation is \$175.30.

"If you know a friend or a family member who does not buckle up when they drive, please ask them to consider changing their habits," said Donovan. "Help us spread this life-saving message before one more friend or family member is killed as a result of this senseless inaction. Seat belts save lives, and everyone—front seat and back, child and adult—needs to remember to buckle up—every trip, every time."

Stir in kitty litter, Oil-Dri, or any highly absorbent material. Fast acting hardeners available at hardware stores (check label for use on stain).

Latex or oil paint recycling - Ace Hardware in Janesville, Beloit. Small fee per gallon. Call ahead. Solid chunks of non-lead, non-metallic paints, varnishes - Remove can lids, place with trash.

- Solvents (acetone, mineral spirits, more)
- All lead paint (banned in 1978)
- All metallic paint
- Liquid oil-based paints, varnishes, lacquers, stains (solvent clean up)
- Photographic chemicals
- Lye
- Pool and spa chemicals
- Wood or paint stripper (methyl chloride, more)
- Wood treatments (penta, creosote, or arsenic)
- Driveway sealers
- Dairy acids
- General farm chemicals

#### PESTICIDE CONTAINERS that are empty or almost empty . . .

- 1. While still wearing protective equipment, pour any excess pesticide into the sprayer.
- 2. Fill pesticide container ¼ full of clean water, replace cap and shake container for 30 seconds. Pour rinse water into sprayer.
- 3. Repeat two additional times, shaking container in different directions.
- 4. Carefully rinse the outside of the container and the cap over the sprayer (or bucket to catch rinse water).
- Dispose of the cap as regular household waste, and dispose of or recycle containers according to local regulations.
- 6. Apply the diluted rinse material according to label directions.

## Buying, Storage, & Safety tips

- Look at less hazardous alternatives.
- **Read labels before buying** for warnings, storage, shelf-life, disposal, safe for septic systems.
- Buy only what will be used up right away.
- Protect your eyes, lungs, and skin.
- **Storage**. Avoid extreme heat, freezing, damp areas that can rust containers; and long-term storage where products can dry out, evaporate, leak, or spill.
- Do not mix chemicals.
- Never pour hazardous chemicals down the drain.
- Large amounts of waste can be a health, fire, or environmental hazard. Recycle or responsibly dispose of wastes as soon as possible.
- Place fragile packages in separate containers and label "Hazardous!" Use clear bags.
