3. SPECIAL ORDERS OF THE DAY/ANNOUNCEMENTS

a. Introducing newly hired and promoted employees

4. PUBLIC HEARINGS

- a. Consideration of Ordinance No. 3624 amending the Zoning District Map to change the Zoning District Classification from R-1A, Single-Family Residential District, to R-1B, Single-Family Residential District, for twenty-six (26) properties on the 2100 and 2200 blocks of Knoll View Drive. Plan Commission recommendation for approval 5-0-1. First reading. Including the applicant, the owners of thirteen of the subject properties have signed a petition supporting the proposed Zoning Map Amendment. The request began when the applicant sought a permit to construct a front deck on his home, only to be informed that the deck was prohibited by the 30-foot front setback. The minimum street side building setback for corner lots will be reduced from 30 feet to 20 feet.
- b. Consideration of Resolution 2018-132 adopting 2019 Community Development Block Grant (CDBG) Local Funding Priorities. CDA recommendation for approval 4-0. Based on information included in the Council meeting packet, staff recommended the CDA approve the following funding priorities for City Council consideration and approval: 1) Public Service Programs which focus on comprehensive case management strategies, with priority given to neighborhood stabilization activities, education in budgeting and life skills, employment training that corresponds with local employment opportunities, and activities which meet one of the NRSA objectives. 2) Code Enforcement. 3) Housing Rehabilitation. 4) Economic Development Activities, with priority given to Technical Job Training.

6. CONSENT AGENDA

All items listed under the Consent Agenda are considered routine and will be enacted by one motion. There will be no separate discussion of these items unless a Council member so request, in which event the item will be removed from the General Order of Business and considered at this point on the agenda.

- a. Consider approval of Minutes of the regular meeting of June 18, 2018.
- b. Consideration of Resolution 2018-129 to accept a donation to the City of Beloit for the Police Explorer Youth Program and the Bicycle Patrol Unit, authorizing the expenditure therefore and amending the 2018 General Operating budget. The Police Department has received several donations from community organizations to assist funding of certain department programs that would otherwise be unattainable with the 2018 current operating budget. The operating budget for Police Services needs to be amended to permit revenue and expenditures of funds for these programs.
- c. Referral to Plan Commission: Consideration of applications for Final Subdivision Plats of Glen Hills Plats No. 6 and 7 in the Town of Beloit. These plats are located beyond the City limits but within the City's Extraterritorial jurisdiction. Both subdivisions will be served by public water (City Water Utility) and sewer (Town Sewer Service Area).
- d. Referral to Plan Commission: Consideration of a request to approve the location and architectural design of a storage building at the Department of Public Works, 2351 Springbrook Court. The proposed building will be constructed adjacent to an existing storage building at the western edge of the facility, and will be used to store solid waste trucks. The site plan and elevations are included in the Council packet. Location and design of all new public buildings must be reviewed by the Plan Commission and City Council in order to comply with state statutes.
- e. Consideration of Resolution 2018-133 awarding Public Works Contract C18-07 for street resurfacing. This project will overlay rough pavements on 39 blocks of city streets. Townhall Road, which is shared ownership with the Town of Turtle, is the additive alternate included in this project. A separate cost sharing agreement between the Town of Turtle

and the City of Beloit has been negotiated. Two bids were received for this project with the low bid coming from Rock Road Companies, Inc.

- f. Consideration of Resolution 2018-134 approving a Townhall Road Resurfacing Cost Sharing Agreement between the Town of Turtle and the City of Beloit. The portion of the reconstruction of Townhall Road that falls within the jurisdiction of the Town of Turtle is approximately 37%. The City shall invoice the Town of Turtle after the completion of the work for its share of the cost. The Town shall pay to City \$15,000 no later than 30 days after receipt of the invoice. The remaining portion of the cost shall be payable to the City no later than January 31, 2019.
- g. Consideration of Resolution 2018-135 approving an amendment to the Class "B" Beer and "Class B" Intoxicating Liquor license for Evans Group LLC, d/b/a Royalty Lounge, Donta Evans, Agent for an outside premises extension, located at 530 E. Grand Ave. Alcohol Beverage License Control Committee recommendation for approval 4-0., contingent on applicant meeting all conditions of the Conditional use Permit. The applicant is seeking to amend their premise description from Main Floor and Bar Area to Main Floor and Bar; and outdoor seating area per Conditional Use Permit (CUP) granted 6-18-2018.
- h. Consideration of Resolution 2018-138 Granting an Extension for the Issuance of a Class "B" Beer and "Class B" Intoxicating Liquor License for Truk'T, LLC, Jeffery Whiteman, Agent. Alcohol Beverage License Control Committee recommendation for approval 4-0. The license was granted at the City Council meeting on January 16, 2018. The license has not been issued due to construction not being complete. Since construction has not been completed, the applicant is seeking a three-month extension in order to complete construction, comply with inspections and open the restaurant.
- i. Consideration of Resolution 2018-136 approving a Memorandum of Understanding between the School District of Beloit and the City of Beloit for the School Resource Officer Program. This is an extension of a pre-existing agreement establishing roles and responsibilities of both parties in maintaining a School Resource Officer (SRO) program.

- a. Consideration of Resolution 2018-131 for approval/denial of 2017-2019 applicants for an Alcohol Beverage Operator's (Bartender's) License for period June 11 - July 10, 2018. The list includes 14 applicants; recommend approval of 13 applicants and denial of one applicant on the basis of the background check of the applicant.
- b. Consideration of Resolution 2018-130 approving a new Class "B" Beer and Reserve "Class B" Intoxicating Liquor License for Velvet Buffalo, LLC, located at 419 Pleasant Street, Jeffery Whiteman, Agent. Alcohol Beverage License Control Committee recommendation for approval 4-0.

Consideration of Ordinance No. 3621 amending the Zoning District Map to change the Zoning District Classification from R-3, Low-Density Multi-Family Residential District, to PLI, Public Lands and Institutions, for property located at 749 Bluff Street and from R-1B, Single-family Residential District, to PLI, Public Lands and Institutions District, for the rear portion of property located at 737 Bluff Street. Plan Commission recommendation for approval 7-0. Second reading.
- b. Consideration of Ordinance No. 3625 to create 18.02(15)(k) of the Code of General Ordinances of the City of Beloit authorizing outdoor vending for Pride Fest sponsored by the Yellow Brick Road Organization, Inc. First reading, suspend rules for second reading.

Rock County Impaired Driving Enforcement Task Force Dates Announced for July, August

July 5, 2018 - Officers from the Beloit Police Department will be participating in the Rock County Impaired Driving Enforcement Task Force on the following weekends in July and August:

- Friday, July 6, and Saturday, July 7
- Friday, July 13, and Saturday, July 14
- Friday, Aug. 3, and Saturday, Aug. 4
- Friday, Aug. 17, and Saturday, Aug. 18

During this additional enforcement, the Beloit Police Department will have more officers on patrol to discourage people from driving while impaired. The Beloit Police Department will have zero tolerance for driving under the influence, open intoxicants, seatbelt violations and improper use of child safety restraints.

"Our goal is send the message that driving under the influence puts the lives and safety of others at risk," said Sgt. Christian Dalton. "We hope this enforcement will help reduce the number of people who choose to drive while impaired."

Driving under the influence includes the use of alcohol, illegal drugs or prescription medication. The Beloit Police Department suggests all motorists take steps to protect themselves and others:

- Ensure everyone in your vehicle is buckled up every day, every trip. Watch your speed, be patient and alert.
- If you plan to use any alcohol, drugs or prescription medication that will impair your driving, choose a sober designated driver.
- If you're feeling buzzed, you likely are over the 0.08 BAC limit and should not drive. Take public transit, a taxicab, or ask a sober friend to drive you home.
- The Wisconsin DOT offers a free <u>Drive Sober mobile app</u> that includes a blood alcohol estimator, designated driver selector, and find-a-ride feature that uses a smart phone's GPS to locate alternative transportation.
- Some taverns and restaurants have programs to provide patrons with a safe ride home. Visit <u>www.tlw.org/</u> and click on Safe Ride.
- Report impaired drivers to law enforcement by calling 911. Provide as much detail as possible on the driver, vehicle, and location.
