### 2018 U.S. KUBB OPEN

Kubb United partnered with the City of Beloit Parks and Recreation and Visit Beloit to present the 2018 U.S. Kubb Open tournament on **Saturday, August 11, 2018** in Riverside Park, 1160 Riverside Drive, Beloit. This will be the first televised Kubb tournament in the United States! Information about the closure of Fourth Street between Middle and North Streets will be provided to parents and guardians next week during registration at Beloit Memorial High School. The information will also be shared via other School District of Beloit communications channels to ensure a successful launch of the initiative this fall.

## ROAD CONSTRUCTION PROJECT UPDATE - August 10, 2018

### Milwaukee Road Project Update:

- Milling and paving operations are ongoing and should be complete by the end of next week.
- Traffic patterns will continue to shift as the operation is rapidly changing during this phase of construction.
- Pavement markings will begin to be painted next week.
- Although traffic lanes are still scheduled to be open and access to businesses will be maintained, there will be a few more closures through intersections while the new asphalt is being laid and allowed to cool. These closures will last a couple of hours per crossing.
- Cranston Road and the outside lanes on Milwaukee Road have been milled and new asphalt pavement has been placed.
- The new bike path has been paved and the south frontage road between Lee Lane and Cranston Road has been resurfaced.
- Work continues on the bio-infiltration area and grading activities continue throughout the project.
- Electrical work is on-going.
- Work scheduled for the upcoming week will include:
  - Complete asphalt paving
  - Begin painting pavement markings
  - Continue grading activities for the bio-retention basin and northern ditch areas
  - Continue electrical work and complete concrete work

Drivers are urged to use caution and have patience while driving through the construction zone. Be prepared to stop for construction vehicles during the paving operations.
