#### SANDBAGS AVAILABLE FOR CITY OF BELOIT RESIDENTS

Governor Walker has declared a State of Emergency for the entire State of Wisconsin due to flooding. The City of Beloit Department of Public Works, 2351 Springbrook Court, has bags and sand available for City of Beloit residents, if needed. We do not pre-fill or deliver bags. The sand and bags are free, bring your own shovel. The Public Works office is open Monday - Friday, 7:00 a.m. - 4:00 p.m. They will give you the bags and direct you to the sand pile.

#### SLOW-NO-WAKE DECLARED ON THE ENTIRE ROCK RIVER IN ROCK COUNTY

The Rock County Sheriff's Office advises that the water level for the Rock River at the Afton gauge was 8.79 feet (on August 30th). County Ordinance requires a slow-no-wake speed restriction be placed on the Rock River between West Beloit-Rock Townline Rd. and the Wisconsin/Illinois state line when water levels exceed 8.5 feet at the Afton gauge.

The slow-no-wake restriction is now in effect on the entire Rock River in Rock County, and it will remain in effect until water levels recede to normal levels per County Ordinance. Lake Koshkonong is exempt from the slow-no-wake restriction. Signs will be placed along the river at public access points.

#### I-39/90 EXPANSION PROJECT UPDATES

Construction work on most major highway projects throughout the state will be suspended during the Labor Day holiday weekend to help travelers reach their destination safely and efficiently. Construction in highway work zones, including most operations related to the I-39/90 Expansion Project, will stop by noon on August 31 and will not resume until 6 a.m. Tuesday, September 4th.

I-39/90 construction activities between Beloit and Janesville:

- Crews will continue installing storm sewer in various location throughout the project.
- Crews will be placing select crushed material from the Beloit SWEF to WIS 11/Avalon Road interchange.
- Boring and Jacking of a 48 inch pipe under the I-39/90 between UP Railroad and Avalon Road will continue.
- Branch Rock River Box Culvert: Crews will start pouring the walls of the box culvert.
- Turtle Creek: Crews will form abutment and possibly pour the abutment this week.
- Townline Road: They will finish pouring the parapet and continue wet cure for the parapet.
- <u>Union Pacific Railroad</u>: Contractor will finish installing steel and preparing for deck pour.
- Nighttime lane closure (8 p.m. to 5 a.m.) on I-39/90 northbound between Shopiere Road and Townline Road, north of Beloit.
- All I-39/90 northbound bridges over the roadways in Janesville are complete, besides some parapet and approach slab work.
- I-39/90 concrete paving to continue WIS 11/Racine Street and US 14 interchange.
- Landscaping crews will work on final restoration along I-39/90 northbound in Janesville.
- The park and ride lot off Midland Court near the WIS 11/Racine Street interchange is open.
- <u>Noise barriers</u>: Drilling and post installation along the new lanes of I-39/90 northbound in Janesville will occur for the next several weeks. Placement on noise barrier panels is ongoing.

#### I-39/90 EXPANSION AND I-43 RECONSTRUCTION

Illinois state line to Hart Road; County X/Hart Road to Freeman Parkway, Beloit (Map <u>attached</u>) Anticipated construction completion: November, 2019

Important: Overnight ramp closures scheduled at the I-39/90 and I-43/WIS 81 interchange in Beloit next week (September 4-7, 2018)

- Nighttime closure of the I-43 southbound ramp to I-39/90 northbound in Beloit
  - 10 p.m. Tuesday (Sept. 4) to 5 a.m. Wednesday (Sept. 5)
  - Alternate routes required
- Nighttime closure of the WIS 81 ramp to I-39/90 northbound in Beloit.
  - 10 p.m. Wednesday (Sept. 5) to 5 a.m. Thursday (Sept. 6)
  - Alternate routes required
- Crossover construction underway on I-43 for future traffic staging.
- Nighttime work involves sawing for crossover construction in I-39/90.
- One lane closed on I-43 northbound and southbound (County X/Hart Road to I-39/90) until mid-September.

#### 4. PUBLIC HEARINGS

- a. Consideration of Ordinance No. 3626 to amend Section 6.4.2 of the Zoning Ordinance, Chapter 19 of the Code of General Ordinances of the City of Beloit pertaining to Outdoor Vending as a temporary use in the PLI Zoning District. This proposed Ordinance stems from a request submitted by the Beloit Historical Society related to a proposed outdoor festival on their campus (zoned PLI) during Heritage Days in September, 2018. Under the proposed Ordinance, the property owner in PLI (that includes institutional lands such as churches, colleges, and quasi-public uses) will need to obtain an outdoor vending license, and the vending may not involve the construction or alteration of a permanent structure. Plan Commission recommendation for approval 6-0 first reading, suspend rules for second reading.
- b. Consideration of Resolution 2018-149 authorizing a Conditional Use Permit to allow a drive-in use in the C-2, Neighborhood Commercial District, for the property located at 2667 Prairie Avenue. If the uses are approved, the City Council is authorized to impose conditions to minimize any potential adverse effects, as long as the conditions are supported by substantial evidence. The Plan Commission report includes an extensive discussion on parking requirements, stacking space requirements, and needed improvements to this commercial property. Plan Commission recommendation for approval 5-1.

The current mixing system is 25 years old, inefficient and expensive to maintain. Installing updated equipment will enhance mixing and allow for future sustainable projects such as community digestion or co-generation of energy. Plan Commission recommendation for approval 6-0.
- c. Referral to Plan Commission: Consider application for a Conditional Use Permit to allow a drive-in use in a C-2, Neighborhood Commercial District, for the property located at 2648 Prairie Avenue. The property includes a commercial building that was previously Fiesta Cancun. The building has a drive-through window and stacking spaces. A drive-through use requires a Conditional Use Permit in the C-2 zoning district. This item will be referred to Plan Commission for review and recommendation.
- d. Consideration of Resolution 2018-156 awarding Public Works Contract C18-17 Gateway Sewer and Water Extensions. This project will extend sanitary sewer and potable water mains from Townhall Road to Hart Road and water main only from Kettle Foods to the Illinois state line. Five bids were received for this project. The low bid comes from Maddrell Excavating, LLC.
- e. Resolution Awarding Public Works Contract C18-31 Digestion Mixing Improvements. This project will provide a new mixing system for anaerobic digesters located at the Water Pollution Control Facility. The current system utilizes 28 year old technology that is requiring increased maintenance activity and is less energy efficient and more labor intensive than current mixing strategies. Two bids were received for this project. The low bid comes from Staab Construction Corporation.

#### Fourth Street Closing Near High School for 2018-19 School Year

**Aug. 16, 2018** - The School District of Beloit and the City of Beloit are partnering together to create a safer environment on the Beloit Memorial High School campus by closing the one block of Fourth Street in front of the school, effective Monday, Aug. 20, 2018.

Fourth Street separates the parking lot from the school building, which has created an unsafe environment for students who are walking across the busy street. Because of these concerns, city and school staff are implementing the street closure as a temporary, one-year trial period. The temporary closure creates an opportunity for city and school district staff to make any necessary changes prior to developing a permanent solution.

The closure will be between Middle and North streets with the intersections remaining open for traffic. As part of this change, there is **no parking allowed on either side of Middle and North streets between Fourth and Sixth streets.** 

The closure will initially begin with barricades until the installation of removable bollards, which are short posts used to divert traffic. First responders will have the ability to lower the bollards on Fourth Street to access the school building.

Drop-off and pickup will be in the parking lot west of the high school and at the loading zone on North Street. At the intersection of Fourth and Middle, northbound traffic on Fourth Street will have a lane to turn left and a lane to turn right. On Middle Street going eastbound, there will be a lane to go straight or to turn right. At the intersection of North Street and Fourth Street, southbound traffic on Fourth Street will turn right onto North Street. Eastbound North Street traffic will be able to turn left onto northbound Fourth Street.

Alternative through routes include Riverside Drive or Sixth Street.

### Interstate construction near Beloit Know Before You Go for 2018-2019

Reconstruction and expansion work is underway on Interstate 39/90 from Hart Road north to the US 14 interchange (Exit 171B) in Janesville. Work on this section of Interstate will continue through spring 2020. This includes current I-39/90 northbound expansion to be completed in fall 2018 and I-39/90 southbound expansion in 2019 to 2020.

Below is the anticipated 2018 and 2019 Phase 1 construction schedule for I-39/90 and I-43 in the Beloit area.

Construction work is scheduled to be completed in 2021. Another flyer will be published prior to Phase 2 construction work continuing in 2020 and 2021.

In fall 2018, crews will construct crossovers on I-39/90 near the Illinois state line, and between Colley Road and Cranston Road. Spot repairs/patching will also take place on the Interstate. In addition, crews will improve the shoulders on I-43, about one mile east of I-39/90, in preparation for future reconstruction staging. Motorists can expect weeknight single lane closures on the Interstates.

Beginning in spring 2019, all I-39/90 traffic will shift to the southbound side between the Illinois state line and Cranston Road, and crews will begin reconstruction and expansion of the northbound lanes of the Interstate. Colley Road will be closed for the duration of the project as crews widen the bridges over the local roadway.

Crews will also begin reconstructing I-43 with traffic being reduced to one lane in each direction and eventually shifted onto the southbound side of I-43. Crews will then reconstruct the lanes on the opposite side, update the interchange ramps at County X/Hart Road, and modify the roundabouts' truck aprons.

In late summer or early fall 2019, all I-39/90 traffic will shift to the new northbound permanent pavement between the Illinois state line and Cranston Road as crews begin to reconstruct and expand the southbound side within these limits.

Interstate 43 traffic will also be shifted to the newly completed I-43 lanes and crews will begin reconstruction of the southbound side.

#### **TRAFFIC IMPACTS FOR 2018 AND 2019**

- I-39/90: Two lanes remain open in each direction during daytime hours and weekends.
- I-43: One lane open each direction during the late 2018 and 2019 construction season.
- Periodic nighttime lane and ramp closures on both Interstates from 8 p.m. to 5 a.m. weeknights.
- Access to the Beloit Rest Area and Wisconsin Welcome Center will remain open except for a two- to three-week closure most likely in fall 2018 (potentially spring 2019) to complete ramp connections to the future northbound lanes.
