COLLEY ROAD UNDER I-39/90 NEAR BELOIT CLOSED UNTIL EARLY DECEMBER, 2018

We have been advised by the Wisconsin Department of Transportation that Colley Road under Interstate 39/90 near Beloit is closed to all traffic until early December. Crews will begin work on the new piers for the I-39/90 bridges over Colley Road in advance of the 2019 construction in this area. These operations and closure are weather dependent and subject to change.

Emergency access will be provided to police, fire and EMS.

Motorists are reminder to be alert for crews and equipment working in this area, and drive with caution through all work zones. FIRE PREVENTION WEEK AND PIZZA HUT FUNDRAISER FOR SURVIVE ALIVE HOUSE

National Fire Prevention week is observed October 7 - 13, 2018. The theme this year is "Look. Listen. Learn. Be aware. Fire can happen anywhere."™ The theme reminds us that fires can (and do) happen anywhere. "Look" for places fire could start. "Listen" for the sound of the smoke alarm. "Learn" two ways out of every room. This is a good time of year to check that

smoke detectors are well placed and functioning properly. The Fire Department recommends changing batteries twice a year and replacing smoke detectors at least every 10 years. Carbon monoxide detectors should be replaced every 5-7 years. (Beep sequences are noted on the back of the carbon monoxide detector.) Look on the back for a manufacturer's date that will help determine the age of the detector.
