### PORTION OF PARK AVENUE TO CLOSE FOR UTILITY WORK

A portion of Park Avenue will close late next week so Fairbanks Morse can upgrade electrical service. The following closures are planned:

Friday, November 2: The outside northbound lane on Park Avenue will be closed between Alice Avenue and Harvey Street during the daylight hours. The inside northbound lane will remain open during this time. The sidewalk on the east side of Park Avenue will be closed as well. The road and the sidewalk will re-open once the work is completed on Friday.

Sunday, November 4: All of Park Avenue will be closed between Alice Avenue and Harvey Street during the daylight. All through vehicles should plan on by passing Park Avenue and travel on Riverside Drive. All local traffic can still travel on Park Avenue but will be detoured east to Wisconsin Avenue in the work area. Traffic signage will be provided to guide drivers through the area. Pedestrians on Park Avenue will need to follow the detour route as well. Park Avenue will be reopened on Sunday after the completion of work.

The project requires a new 80-foot-tall electrical pole to be installed at the railroad tracks near the Fairbanks Morse building. The equipment to deliver, unload, and install the pole is large, and will require space clear of people and cars to operate safely.

#### CITY TO HOLD CURBSIDE YARD WASTE COLLECTION IN NOVEMBER

The City of Beloit's Public Works Department is holding its free fall yard waste collection from November 5 - 15 and November 26 - 29 this year.

If a resident prefers to not place leaves into bags or trash containers for the free collection, the resident can subscribe to the paid leaf vacuuming services. The City will vacuum the leaves on a scheduled basis this fall for a one-time fee of \$100.

- Referral to Plan Commission: Application for a PUD, Planned Unit Development (PUD) Master Land Use Plan on the property located at 2240 Cranston Road. The proposed plan contemplates up to four assisted living buildings totaling 96 units. The proposed buildings are approximately 14,000 square feet each and will include up to 24 units each. The facility will be licensed by the State of Wisconsin as a Community Based Residential Facility.
- c. Referral to Plan Commission: Application for a Zoning Map Amendment to change the zoning district classification from C-2, Neighborhood Commercial District, to PUD, Planned Unit Development, for the property located at 2240 Cranston Road. The PUD District is a special-purpose zoning district that permits greater flexibility in land planning and design standards than conventional zoning districts. This application is being considered in accordance with the Zoning Map Amendment procedures contained in Section 2-300 of the Zoning Ordinance.
- d. Consideration of Resolution 2018-174 approving Emergency Ambulance Service Agreement with the Town of LaPrairie, Wisconsin. The City of Beloit Fire Department has provided ambulance service to the Town of Turtle and parts of the Town of LaPrairie for over 40 years. In order to help cover the costs of the service provided to the Town of Turtle and Town of LaPrairie, they will reimburse the City of Beloit the agreed upon fee stated in the Ambulance Service Contract.
- e. Consideration of Resolution 2018-175 approving Emergency Ambulance Service Agreement with the Town of Turtle, Wisconsin. (See item "d" above.)

The ABLCC reviewed and recommended to deny the application due to concerns regarding the density of alcohol establishments within the

proximity of the applicants property as well as in the City overall.

#### 8. ORDINANCES

- a. Consideration of Ordinance No. 3628 updating the City of Beloit Comprehensive Plan and amending Section 12.015(3) of the Code of General Ordinances. Plan Commission recommendation for approval 6-0. Second reading. On November 6, 2017 the City Council adopted a Resolution establishing a detailed process and Steering Committee to facilitate a 10-year update of the 2008 City of Beloit Comprehensive Plan in accordance with Wisconsin Statutes. The Steering Committee held eleven public meetings and two open houses from November 2017 through August 2018. The Steering Committee has completed their process and recommended a Comprehensive Plan Update consisting of revisions to four chapters. The draft Plan Update is accessible on the City's website in the Document Center under Planning and Building Services: http://gouda.beloitwi.gov/WebLink/0/fol/65975/Row1.aspx
- b. Consideration of Ordinance No. 3631 to amend Section 3.15(3) of Code of General Ordinance of the City of Beloit pertaining to the distribution of room taxes. First reading. The City of Beloit imposes a room tax for accommodations that are available to the public. Such tax is at the rate of 8% of the gross receipts from such retail furnishing of rooms, lodging, or sites. Proceeds from the tax are remitted to the City Treasurer within 30 days of each calendar quarter end. Currently, the proceeds of such tax is apportioned at 15% to the City for general administration expenses and the remaining 85% to the Beloit convention and Visitors Bureau. The City seeks to increase the amount apportioned to the City from 15% to 20% and reduce the amount apportioned to the Beloit Convention and Visitors Bureau from 85% to 80%. Staff projects the impact for 2019 to be a \$35,000 increase in general fund revenues.

The City Council has a history of recognizing distinguished residents who have made extraordinary contributions to the City of Beloit. The honorary designation of naming infrastructure publicly recognizes those exceptional residents.
- b. Consideration of Resolution 2018-182 approving the 2019 Home Investment Partnerships Program (HOME) Budget. CDA recommendation for approval 6-0. The City is a member of the Rock County HOME Consortium. As a result, the City receives an annual allocation of Home Investment Partnership Program (HOME) funds. The CDA recommended approval of the HOME Budget.
- c. Consideration of Resolution 2018-190 approving the 2019 Business Improvement Operating Plan and Budget. In 1987, the Downtown Beloit Association (DBA) was formed. In 1988, the Business Improvement District (BID) was formed along with designating Downtown Beloit as a Main Street Community. The BID assessment rate will remain at \$4.27/\$1000, as it has been since 2018. The BID boundaries will be amended to include the former Angel Museum, St. Paul on the Riverfront, located at 656 Pleasant Street, currently owned by the City of Beloit.
- d. Consideration of Resolution 2018-181 approving the 2019 Community Development Block Grant (CDBG) Annual Action Plan, approving the 2019 CDBG Budget, and appropriating the funds necessary for the operation and administration of the 2019 CDBG program. CDA recommendation for approval 6-0.
- e. Consideration of Resolution 2018-189 approving the Operating Budgets, Appropriating Funds, and Levying Property Taxes necessary for the Operation and Administration of the City of Beloit for the year 2019, including the 2019 Capital Improvement Budget, the Beloit Public Library Budget; and further authorizing the City Clerk-Treasurer to allocate the City Property Tax along with the apportionments certified for other jurisdictions upon the current tax roll of the City. ### City to Hold Curbside Yard Waste Collection in November

**Oct. 24, 2018** - City of Beloit's Public Works Department is holding its free fall yard waste collection from Nov. 5-15 and Nov. 26-29 this year.

The free collection is limited to contained leaves, grass clippings and garden debris. All yard waste must be free of litter and placed in paper yard waste bags, Back to Nature Biodegradable bags or clean trash containers. The containers or bags of yard waste should be placed 3 feet away from residents' trash cans on their regularly scheduled trash collection day.

"Please keep all leaves and grass clippings away from the street to keep them from going into storm drains, which can lead to clogged drains and harmful debris going into our waterways," said Tim Drager, Solid Waste and Safety Supervisor for the Operations Division. "When you are out raking or using a leaf blower, make sure you're directing the leaves away from the street."

If a resident prefers to not place leaves into bags or trash containers for the free collection, the resident can subscribe to the paid leaf vacuuming service. Leaves must be placed so that the back of the pile is no farther than 8 feet away from the street. The city will vacuum the leaves on a scheduled basis several times this fall for a one-time fee of \$100. The vacuum service programs runs Nov. 5-16 and Nov. 26-30 this year. The City of Beloit is not responsible for the timeliness in which leaves fall from the trees or weather-related cancellation of the leaf vacuum program. No refunds will be issued on this program; no spring service will be offered.

The city will also pick up brush and shrubbery during this time period on the regularly scheduled trash day. All brush or shrubbery must be bundled or tied with a \$1.50 sticker attached to it. The bundles should be no larger than 4 feet long and/or 4 inches in diameter. Stickers may be purchased at City of Beloit Treasury Department, City of Beloit Department of Public Works Operations and Parks Facility, Grinnell Hall, Ace Hardware and Walgreens.

If residents are looking for other yard waste disposal options, they can take the yard waste to Complete Compost LLC, 1105 E LT Townline Road, Janesville, WI 53546. Complete Compost is open from 8 a.m. to 5 p.m. Mondays through Saturdays. Fees do apply. Contact Complete Compost at (262) 725-2500 for more information.
